Subj: ACQUISITION MANAGEMENT REVIEW (AMR) OF FACILITIES SUPPORT CONTRACTS, MARINE CORPS BASE, CAMP LEJEUNE, NORTH CAROLINA.


1. Your response to the subject AMR provided by reference (a) has been reviewed and the following comments are provided:

a. Recommendation 86-IB-4 --(quote from reference (a)): --- "Concur: The OIC FSC will seek one time authority to award any facilities support contracts which will exceed the OIC's warrant level. On LANTNAVFACENCOM awarded FS Contracts, all files will be requested to be consolidated and maintained by this office. Additionally, to minimize this situation strongly recommend that current warrant level of 100k be raised to level III for type 6 (Maint. Service) and 15 (Indefinite Quantity) as current OIC FSC has had extensive FSC contract formation and administration experience."

The current warrant level for CDR. T. L. Huguelet, OIC FSC, is Level V, (100k), for type 6 (Maint. Services) and Level V, (100k), for type 15 (Indefinite Quantity). These will be raised to Level IV, (500k). This level is consistent with warrant levels of similar activities and should be adequate.

b. Recommendation 86-IB-5 --(quote from reference (a)): --- "Concur: Action initiated by Attachment C. Two meetings to discuss formation of centralized OIC FSC organization similar to that proposed by AMR have been held with Commanding General, MARCORB Camp Lejeune designated representatives. OIC FSC has been requested to prepare formal proposal for Base review and approval. Initial contact with only tenant command currently involved has been positive. Action continuing, OIC FSC will keep LANTNAVFACENCOM advised of progress. Should MARCORB Camp Lejeune refuse to transfer billets required to direct control of OIC FSC, OIC FSC may have to consider refusing to advertise and award future facilities support contracts. Request LANTNAVFACENCOM advise OIC FSC of what support he may expect should use of this alternative be required."

Your efforts to resolve this fragmented organizational problem are recognized, appreciated and supported. We prefer to not issue an ultimatum as to discontinuing contractual services. Other Marine Corps activities have recognized the need and established the centralized OIC FSC organization. We anticipate that when you demonstrate the benefits of the team approach for contract administration, your activities will recognize that our motives are to ensure that checks and balances are functioning in the contracting process



to remove or minimize the possibilities of waste, fraud or abuse. None of us wish to be a party to any organizational approach to contracting that provides anything but the most favorable environment for ensuring the integrity of the process.

By copy of this letter, the Commanding General, Marine Corps Base and the Commanding Officer, Naval Hospital are requested to continue their support and cooperation to ensure that the FS Contract administration organization, as recommended by the subject AMR, is put in place as soon as possible. This matter is of vital concern to all parties.

3. You are requested to keep this Command informed of the continuing action in your efforts to implement the recommended reorganization of the FSC Office.
