

Subj: HAZARDOUS WASTE MANAGEMENT PROGRAM

Ref: (a) BO 6240.5A

Problem:

Major commands within the Camp Lejeune/Marine Corps Air Station, New River, complex have failed to properly implement the subject program, per the reference. The result is issuance of a Hazardous Waste Compliance Order by the North Carolina Division of Health Services (DHS) on 11 August 1987. Immediate action is required to comply with this Order and to prevent additional enforcement action by DHS.

Background/Discussion:

Commanding Officers at all levels have failed to place proper priority on the subject program. Recognizing this, Marine Corps Base revised the reference with emphasis on internal controls and personnel training. The Battalion Commander is assigned primary responsibility for the day-to-day collection and disposal of hazardous waste. The reference requires the appointment of Hazardous Material Disposal Coordinators (HMDC) at the major command level and Hazardous Material Disposal Officer (HMDO) at the Battalion level. The HMDO is the key to a successful Battalion (equivalent) program. It is critical that HMDOs be provided training, resources and authority required to ensure compliance with the reference and related DHS regulations. Until HMDOs are provided necessary support and direction from their Commanding Officers, the subject program will continue to falter.

Recommended Action:

Commanding Officers should personally monitor their hazardous waste programs until such time as the current noncompliance status with DHS is corrected. The selection of a competent HMDO and providing of adequate authority to the HMDO are actions essential to maintaining continuous compliance with the complex regulations promulgated by the reference. Commanding Officers must place proper importance to the selection and replacement of HMDOs.

Subj: PROTECTION OF HISTORICAL AND ARCHAEOLOGICAL RESOURCES

Ref: (a) MCO 11000.19
(b) Historic Preservation Plan Executive Summary

Problem:

Reference (a) requires Marine Corps Base to implement the National Historic Preservation Act and numerous other Federal directives requiring the identification of properties that are eligible for inclusion in the National Registry of Historic Places. Additionally, regulations governing environmental protection require that all environmental assessments discuss the potential effect of Marine Corps projects on historic and archaeological resources.

Background/Discussion:

In recent years, survey requirements have become increasingly strict demanding the skills of professional archaeologists. The first survey was conducted by archaeologists from UNC-Wilmington in 1978 which involved only surface examination over a portion of the Base. A more intensive survey was conducted through contractual procedures in 1980; under the auspices of the Naval Engineering Command, Norfolk, Virginia. A three volume report of the survey was published by Dr. Thomas Loftfield, UNC-Wilmington, Principal investigator for the contractor in 1981. Efforts were initiated to carry out recommendations for protecting sites listed by the 1981 survey. A draft Historic Preservation Plan was published under Marine Corps contract during April 1987 which lists known site descriptions; National Registry Historic Place recommendations; action required and recommendations for protection.

Recommended Action:

Implement reference (a) by establishing policy, responsibilities, guidance and identify organization and personnel for carrying out the priorities listed in reference (b).

Subj: ENDANGERED SPECIES PROTECTION PROGRAM

Ref: (a) BO 11015.6A
(b) BO 11017.1A
(c) Endangered Species Act of 1973

Problem

Reference (a) sets forth regulations and establishes responsibilities for the conservation of the Endangered Red-Cockaded Woodpecker relative to military training use. Twenty-four violations have been processed and staffed thus far in 1987 in comparison to thirteen which occurred during the entire year of 1986. Vehicle traffic both POV and government owned, on Onslow Beach continues to be a problem relative to sea turtle nesting. Three Loggerhead sea turtle hatchlings and twenty-five eggs with embryos were destroyed recently when a military vehicle traveled across the nest near Onslow Beach North Tower. This is in direct conflict with references (b) and (c).

Background/Discussion:

Weekly inspections of Red-Cockaded Woodpecker habitat in the Combat Town - TLZ Penquin areas, are conducted under the cognizance of the Training Facilities Officer supported by a Natural Resources and Environmental Affairs representative. Random inspections of the remaining woodpecker habitat of the base is conducted by NREAD personnel. When violations occur, they are reported to the Assistant Chief of Staff, Training and Operations. Natural Resources personnel conducted nightly patrols to monitor sea turtle nesting activities during the period June - August, and are presently checking each nest for hatching results to continue through late October. Only 25 nests were laid on Onslow Beach during the 1987 nesting season. An increase in unauthorized vehicle use on the beach could be one of the contributing factors for the nesting decline this season.



Recommended Action:

That Commanders of all the Base/Tenant Commands, conduct a continuous education/information program to ensure that all personnel are aware of the contents of references (a) and (b). That Assistant Chief of Staff, Training and Operations personnel, supported by NREAD personnel, monitor endangered species habitat per references (a) and (b), and implement protection guidelines.
