



MUTUAL FIRE FIGHTING ASSISTANCE AGREEMENT

This Agreement, made and entered into this 25th day of November, 1952, by and between the North Carolina Department of Natural and Economic Resources (State Forest Service) hereinafter referred to as the State Forest Service, and the Commanding General, Marine Corps Base, Camp Lejeune, North Carolina, hereinafter referred to as the Commanding General.

WITNESSETH :

WHEREAS, each of the parties hereto maintains equipment and personnel for the suppression of fires within its own jurisdiction and areas, and

WHEREAS, the parties hereto desire to augment the fire protection available in their various establishment, districts, agencies and municipalities in the event of large fires or conflagrations, and

WHEREAS, the lands or districts of the parties hereto are adjacent or contiguous so that mutual assistance in a fire emergency is deemed feasible, and

WHEREAS, it is the policy of the U. S. Marine Corps and of the municipalities or other districts and of their governing bodies to conclude such agreements wherever practicable, and

WHEREAS, it is mutually deemed sound, desirable, practicable, and beneficial for the parties to this Agreement to render assistance to one another in accordance with these terms;

THEREFORE BE IT AGREED THAT:

1. Upon request of the designated official of the State Forest Service, the Commanding General will furnish such fire fighting service, to the extent deemed available at the time of the fire, for the purpose of assisting the State Forest Service in combating fires occurring within the latter's fire protection district.

a. The following officials of State Forest Service are hereby designated to request fire fighting assistance from the Commanding General:

State Forest Director
Onslow County Forest Ranger.

b. Requests for assistance will be made to the Camp Lejeune Fire Dispatcher (phone: 451-3004 or 451-5856).

2. Upon request of the Commanding General or his designated representative, the State Forest Service will furnish such fire fighting service, to the extent they deem available at the time of the fire, for the purpose of assisting the Camp Lejeune Fire Department in combating fires occurring on the Marine Corps Base.

a. The following officials are designated representatives of the Commanding General to request fire fighting assistance from the State Forest Service:

Chief of Staff, Marine Corps Base
Fire Chief, Marine Corps Base
Staff Duty Officer, Marine Corps Base.

b. Requests for assistance will be made to the Onslow County Forest Ranger (phone: 324-3431).

3. Upon arrival at the scene of the fire, assisting personnel and equipment shall report to the technical head of the Fire Department of the requesting party who shall assume full charge of the operations, but if he specifically requests a senior officer of a fire department furnishing assistance to assume command, he shall not, by relinquishing command, be relieved of his responsibility for the operation; provided that the



apparatus, personnel and equipment of the agency rendering assistance shall be under the immediate responsibility of the senior officer of the fire department rendering assistance.


4. The rendering of assistance under the terms of the Agreement shall not be mandatory, but the party receiving the request for assistance should immediately inform the requesting service if, for any reason, assistance cannot be rendered.
5. Services rendered under the terms of this Agreement shall be rendered without reimbursement of either party therefor.
6. Each party to this Agreement hereby expressly waives all claims against the other party or parties for compensation for any loss, damage, personal injury, or death occurring in consequence of the performance of this Agreement.
7. The Chief Fire Officer and personnel of the fire department of both parties to this Agreement are invited and encouraged, on a reciprocal basis, to frequently visit each other's activities for guided familiarization tours consistent with local security requirements and, as feasible, to jointly conduct pre-fire planning inspections and drills.
8. The technical heads of the fire departments of the parties to this Agreement are authorized and directed to meet and draft any detailed plans and procedures of operation necessary to effectively implement this Agreement. Such plans and procedures of operations shall become effective upon ratification by the signatory parties.
9. The terms of this Agreement will abrogate all previous agreements between the parties hereto with respect to the subject matter contained herein and will remain in effect until such time as either of the parties shall notify, in writing, the other party of an intention to rescind the agreement.



3. This memo is to make you aware of the violations on the use of forestry owned equipment. The violations of reference (a) can be avoided.





1. Reference (a) states, as shown in enclosure (1), that equipment purchased by Forestry (H2) funds are not available for joint use from the activities engineering equipment table. Presently this equipment is assigned to the Base Maintenance Division. Reference (a) states, as shown by enclosure (2), that the equipment should be assigned to the activities Natural Resources and Environmental Affairs Division. Enclosure (2) also states that the activity commander shall establish procedures which will ensure that equipment procured with forestry (H2) funds will be used exclusively to support the activities forest management operation.

2. On 27 August, the forestry hauling unit, truck and trailer, were observed being used to train student drivers. This is clearly a violation of reference (a).

3. This memo is to make you aware of the restrictions placed on the use of forestry owned equipment so that additional violations of reference (a) can be avoided.



1. REFERENCE (a) STATES THAT EQUIPMENT PURCHASED BY FORESTRY (H2) FUNDS ARE NOT AVAILABLE FOR JOINT USE FROM THE ACTIVITIES ENGINEERING EQUIPMENT TABLE. PRESENTLY THIS EQUIPMENT IS ASSIGNED TO THE BASE MAINTENANCE DIVISION.

REFERENCE (a) STATES, AS SHOWN BY ENCLOSURE (2), THAT THE EQUIPMENT SHOULD BE ASSIGNED TO THE ACTIVITIES NATURAL RESOURCES ENVIRONMENTAL AFFAIRS OFFICE. ENCLOSURE (2) ALSO STATES THAT THE ACTIVITY COMMANDER SHALL ESTABLISH PROCEDURES WHICH WILL ENSURE THAT EQUIPMENT PROCURED WITH FORESTRY (H2) FUNDS WILL BE USED EXCLUSIVELY TO SUPPORT THE ACTIVITIES FOREST MANAGEMENT OPERATION.

2. ON 27 AUGUST, THE FORESTRY HAULING UNIT, TRUCK AND TRAILER, WERE OBSERVED BEING USED TO TRAIN STUDENT DRIVERS. THIS IS CLEARLY A VIOLATION OF REFERENCE (a).

3. THIS MEMO IS TO MAKE YOU AWARE OF THE RESTRICTIONS PLACED ON THE USE OF FORESTRY OWNED EQUIPMENT SO THAT ADDITIONAL VIOLATIONS OF REFERENCE (a) CAN BE AVOIDED.

f. Equipment Procurement. Procedures for the procurement of equipment are contained in MCO 4200.9. However, ~~equipment needed solely to support the production of timber products, and not available for joint use from the activity's engineering equipment table, may be eligible for financing from timber sale proceeds as stipulated in the NavCompt Manual, paragraph 075150.~~ Information concerning the purchase of natural resource support equipment is contained in section 6 of this chapter.

2301. HUNTING, FISHING, AND TRAPPING

1. Commanders of Marine Corps activities having executed a Fish and Wildlife Cooperative Agreement and received CMC (Code LFF) approval of a Long-Range Multiple-Use Natural Resources Management Plan addressing the management and harvest of game species are authorized to permit hunting, fishing, and/or trapping as legitimate recreational activities.

2. Activity commanders permitting hunting, fishing, and trapping shall issue regulations for the harvest of fish and wildlife and develop procedures for enforcing all applicable laws and regulations. Where feasible and practical, activity game enforcement operations shall be assigned to the staff of the natural resources and environmental affairs office. Enforcement shall be performed in accordance with the provisions of paragraph 2104, preceding.

2302. GROUNDS MAINTENANCE. Implementation of the Natural Resources Management Program requires effective grounds maintenance planning and programing. Activity commanders are responsible for ensuring the application of sound grounds maintenance techniques, procedures, and methods in accordance with MCO P11000.7. The activity shall prepare a Grounds Maintenance Plan to adhere to recommendations contained in the Natural Resources Management Plan, and shall maintain sufficient records to permit evaluation of program accomplishments. Suitable maps, delineating various grounds maintenance operations and the associated area, shall be maintained and updated annually. Operations, such as moving, fertilizing, liming, edging, seeding, and landscaping, shall be shown.

2602. ADMINISTRATION

1. ~~The following requirements apply to all equipment (administrative-use vehicles, engineer equipment, etc.) acquired under the provisions discussed in paragraph 2601, preceding.~~ The reporting requirements of the current editions of MCO 4440.27 and MCO 11260.3 are not applicable to these items of equipment, except as provided for herein.
2. Registration numbers assigned by Headquarters Marine Corps shall be affixed in accordance with MCO 11240.46 (vehicles) or MCO 11260.3 (equipment) prior to assignment to the using office. The six-digit number shall be followed by the letter "F" to distinguish the items as natural resources equipment under the administrative control of the CMC (Code LFF).
3. ~~The equipment shall be assigned to the activity's natural resources and environmental affairs office. The activity commander shall establish procedures which will ensure that equipment procured with forestry funds is used exclusively to support the activity's forest management operations.~~
4. The following information shall be provided to the CMC (Code LFF) upon assignment of the equipment:
 - a. Commercial name/nomenclature.
 - b. Model number.
 - c. Serial number.
 - d. Manufacturer and date of manufacture.
 - e. Copy of the contract or interdepartmental procurement request.
 - f. Acquisition cost and fund source (forestry or wildlife conservation).
 - g. Date of assignment and using office (including the building number).
5. The managing office shall maintain an equipment utilization record of each item of equipment, indicating the date and accumulated miles or hours of operation.
6. The using office shall establish procedures for issuing and maintaining the Vehicle and Equipment Operational Record (form NAVMC 10627).

1. Introduction. This letter reports the results of the audit of revenues and expenses related to forestry management at Marine Corps Base (MCB), Camp Lejeune, North Carolina. The Naval Audit Service Southeast Region completed the subject audit in accordance with reference (a). A closing conference was held with the Assistant Chief of Staff Facilities, your designated representative, on 29 September 1986. Since the audit did not disclose deficiencies, no response is required.

2. Background. The Forestry Branch of the Natural Resources and Environmental Affairs Division has a forest resource base of 66,000 forested acres, of which 58,000 acres are considered to be commercial forestland. Forestry management operations are supported on a reimbursable basis from proceeds generated by timber sales. Contract administration services for timber sales contracts are provided by the Resident Officer-in-Charge of Construction, MCB, while contract performance inspections are provided by forestry personnel. Revenues from timber sales for fiscal year (FY) 1986 were estimated to be \$419,000. As of 30 June 1986, \$414,385 had been collected from 13 contracts. The revenues collected were used to reimburse Operation and Maintenance, Marine Corps appropriation, subfunctional code H-2, (forest products) for those expenses directly incurred in the production and sale of forest products. Funds budgeted for forest products may not be exceeded or used for any purpose other than the forestry management program. Costs incurred for management, civilian personnel services, equipment, and minor construction are costs related to such forestry management operations as: timber sales, timber stand improvement; reforestation; forest protection; and forest access road maintenance. These functions are performed by 11 civilian personnel. FY 1986 Operating Fund Authorization Budget (Subfunctional Category Code H-2) was \$400,000. Administrative and Operational Support for expenses incurred by the Forestry Branch was accomplished by the Base Maintenance Department and Logistics Department of MCB. As of 30 June 1986, \$272,992 had been obligated.

3. Objectives, Scope, and Methodology

a. Audit objectives were to review forestry management at MCB to:

(1) determine if sufficient internal controls were in place to ensure that revenues and expenses were correctly charged to the forestry program;

c. We reviewed instructions and operating procedures applicable to forestry management at MCB. We validated the accuracy of 100 percent of FY 1986 revenue collections, as of 30 June 1986. Further, using judgmental sampling methods, we selected various expense transactions for review. These included: forestry, civilian personnel salary costs; vehicle maintenance/repair costs; and petroleum, oil, and lubrication costs incurred, for the same period. The audit was performed in accordance with generally accepted government auditing standards.


4. Summary of Audit Results. We reviewed internal controls in place with regard to revenues collected and expenses incurred by the Forestry Branch. Internal controls in place were adequate to prevent or detect material errors and irregularities in the operations. Also, the Forestry Branch was in substantial compliance with applicable procedures and regulations for those transactions tested. Revenues were correctly recorded and expenses applied were proper and in accordance with prescribed regulations. Nothing came to our attention during the course of the audit that caused us to believe that there was not compliance with any regulation applicable to those transactions not tested.

1. The use of aerial recon for monitoring damages to pine timber by the southern pine beetle has been scheduled as necessary for approximately ten years. Initially military aircraft was used for this purpose and was contingent upon aircraft availability. Commercial aircraft has been contracted for the past six years. The enclosure lists the contractual requirements for conducting these recon flights.

2. Air space for conducting these flights will be requested by Base Forestry and scheduled in accordance with availability. Some minor adjustments in flight lines can be made to avoid overflight of impact areas, etc. It is estimated that 5-10 of these flights will be necessary this fiscal year and your cooperation in making air space available is appreciated.

defense.


2. All confidential sources are required to provide information

CONTRACTUAL REQUIREMENTS AND STANDARDS FOR PERFORMANCE OF SOUTHERN
PINE BEETLE RECON

1. Supply pilot and overwing aircraft capable of carrying two observers.
2. Aircraft must be equipped with radio equipment capable of communicating on 325.0 UHF or 38.6 FM with the Base Range Control (Blackburn), Camp Lejeune, North Carolina.
3. Pilot will be provided with a base special map with east-west transect lines drawn at one mile intervals covering the entire base from the intersection of Highway 17 and NC 24 East to Risely Pier.
4. Transect lines will be flown at 1000 feet traveling approximately 90 miles per hour.
5. Pilot must follow east-west transect lines with no more than 1/2 mile drift from the designated line of travel in any one transect.
6. Upon completion of the first transect flying due east across the base, pilot will turn 180 and follow the second transect due west across the base. Similarly, upon completion of the second transect, pilot will turn 180 and follow the 3rd transect due east. This technique will continue until all transects have been completed.
7. Observers accompanying the pilot may make minor adjustments in the areas to be covered, to accommodate planned military training or accomplish desired recon goals.
8. Flights will generally last approximately two hours.
9. Flights will be scheduled by Base Forestry personnel contingent upon planned military training at least one week in advance.
10. Flight confirmation will be made at 8:00 a.m. on the morning of the scheduled flight, weather permitting.
11. A maximum of 20 hours per year will be authorized for flights; however, depending on military training and southern pine beetle occurrence, actual flight time may be somewhat less.

1. As discussed during reference (a), I have reviewed the tree damage reported by the CG, MCB. As there is no trenching work along Sneads Ferry Road, I assume the CG was referring to the damaged trees caused by utility excavation along Main Service Road in the vicinity of Sneads Ferry Road.
2. As you can see by enclosure (1), para 5.2.2., the contract covers this damage. The contractor has previously been verbally reminded of this contract requirement. However, to ensure the contractor is aware I requested issuance of enclosure (2).
3. I have discussed the damage with Julian Wooten and he will assist us as necessary to ensure proper restoration/repair is undertaken and if required, amount of applicable restitution.
4. I feel I should note that the excavation area between Main Service Road and the tree line is severely limited. Some damage must be expected. However, this fact does not in any way relieve the contractor of his contractual obligation.



- 4.2.1 Sediment: Soil that has been eroded and transported by running water.
- 4.2.2 Garbage: Waste foodstuffs.
- 4.2.3 Human excrement: Solid or liquid wastes produced by the human body.

5. PROTECTION OF NATURAL RESOURCES:

5.1 General: It is intended that the natural resources within the project boundaries and outside the limits of permanent work performed under this contract be preserved in their existing condition or be restored to an equivalent or improved condition upon completion of the work. The Contractor shall confine his construction activities to areas defined by the work schedule, plans, and specifications.

5.2 Land Resources: The Contractor shall not remove, cut, deface, injure, or destroy trees or shrubs without written permission from the Contracting Officer. No ropes, cables, or guys shall be fastened to or attached to any existing nearby trees for anchorages unless specifically authorized. Where such special emergency use is permitted, the Contractor shall be responsible for repairing or replacing any damage resulting from such use.

5.2.1 Protection Plan: Where trees may possibly be defaced, bruised, injured or otherwise damaged by the Contractor's activity, equipment, or by his dumping, or other operations, the Contractor shall submit a plan for protecting such trees. Monuments, markers and works of art shall be protected before beginning operations.

~~5.2.2 Repair or Restoration: Any trees or other landscape features scarred or damaged by the Contractor's equipment or operations shall be repaired and/or restored to their original condition at the Contractor's expense. The Contracting Officer shall approve the repair and/or restoration planned prior to its initiation.~~

5.2.3 Temporary Construction: The Contractor shall obliterate all signs of temporary construction facilities such as work areas, structures, stockpiles of excess or waste materials, or any other vestiges of construction as directed by the Contracting Officer.


5.3 Water Resources: It shall be the responsibility of the Contractor to investigate and comply with all applicable Federal, State, and Local regulations concerning the discharge (directly or indirectly) of pollutants to the underground and natural waters. All work under this contract shall be performed in such a manner that any adverse environmental impacts are reduced to a level that is acceptable to the Contracting Officer.

5.4 Oily Substances: At all times, special measures shall be taken to prevent oily or other hazardous substances from entering the ground, drainage areas, or local bodies of water in such quantities as to affect normal use, aesthetics or produce a measurable ecological impact on the area.
