

1. References (a) through (c) establish the requirement for Marine Corps Base to establish a hazardous materials and waste storehouse by 19 February 1981. This is a new mission. The Defense Property Disposal Office will ultimately operate the hazardous waste facility and has requested that a warehouse also be provided.

2. Please prepare a supplemental minor construction project for submission. The cover letter will be prepared by the Facilities Office.

3. Enclosure (1), prepared by Base Maintenance/Environmental Affairs, is a preliminary design for the conversion of hazardous and flammables storehouse TP-451 to a hazardous materials and waste storehouse. Additionally, a design sketch and an engineer cost estimate (materials only) will be required for the erection of a 40 x 80 Butler Building. This building will be provided from one of three buildings currently scheduled for demolition at Camp Geiger (TC-861, TC-862 & TC-863). Alterations to building TC-451 and the building selected for salvage and movement will be accomplished by a troop training project.

4. It is requested that the project package be completed by 20 January 1981. Points of contact for design and environmental information are Mr. R. Dillon and Mr. D. Sharpe, at Base Maintenance. Point of contact at the Facilities office is Major J. A. Marapoti.
