




Subj: Car Wash Facility





Subj: Special Services Building Projects

Ref: (a) Our conversation of 22 Jan 82

1. In accordance with reference (a) this letter is submitted for your consideration.


2. Special Services has three major projects planned with hopes of completion before I depart in late August of 1982. Each is for the benefit of our marines and will enhance significantly the MWR program.

3. In order that completion can be effected, Special Services will have to depend on Marine Corps Base Camp Lejeune for some help. The projects and assistance required are listed below:

a. Car Wash. A car wash is to be constructed, funded fully with NAFI dollars, in the rear of our Auto Hobby Shop lot. Near the site is a new oil/water separator system installed for Detachment "A" (old tenants). It is requested that we be allowed to tap on to the incoming water (2" line required) and electrical (three phase/440 volt) lines and also run the drain into that system. We will require Base's assistance for both approval and accomplishment of the work. We will of course, reimburse them. The maintenance of the facility will be handled by Special Services.


b. Racquetball Court Roof. We plan to cover the racquetball courts, building 207. When work is complete, we will need Base to run single phase/220 volt electrical service to the building from a power pole with transformers no more than 100' away. We will reimburse them for the work. We will also assume maintenance responsibility for the entire building.

c. Bath House. A bath house is badly needed and scheduled for construction at the Marina. After built, we will require base to hook up the sewage line to the sewage pumping station (within 90') beside the Marina, Building 2800. We will also need a 2" water line and a single phase/220 volt electrical line run 100' underground to the site from Building 2800. We will again reimburse them for the work and assume maintenance responsibility for the building.



In order to proceed with these projects as expeditiously as possible, it is requested that a representative of Marine Corps Base meet with us at the earliest possible date so that conflicts can be resolved and progress continued.


1. Reference (a) emphasized the Commandant's concern and his desire to provide MWR facilities designed to provide alternate recreational outlets for Marines aboard Federal property. In this context we have three projects that have for one reason or another been stymied for as long as three years.

- (a) A roof, lighting and ventilation for building AS-207, a racquetball court
- (b) A Car Wash facility
- (c) A Marina Bathhouse

2. Item (a), the racquetball court roof has failed 3 times to receive a Headquarters validation sufficiently high enough to be accomplished as a minor construction (R-2) project. Item (c) has also befallen the same problem. In both cases Headquarters representatives have indicated that the projects should be accomplished through use of WAF funds.

3. In keeping with the guidance of reference (a), we have decided to proceed with the three projects utilizing local WAF funds. Your assistance is requested in order to expedite the accomplishment of these projects. Specifically, assistance from the Base Maintenance forces in the form of technical assistance (i. e., inspection service during construction) and utilities connections required to make the facilities operational (all work to be on a reimbursable basis).

4. Liaison with Base Maintenance has been ongoing for some time regarding these projects as noted by references (b), (c) and (d). An on-going concern of responsible persons from Base Maintenance and the Assistant Chief of Staff, Facilities has been that work accomplished from any source be of such quality that it meets professional standards of workmanship, conforms to building codes and does not leave the Government in a position whereby dollars would be spent to correct inferior or inadequate construction. We share exactly the same concern and in this regard solicit and welcome routine overview inspection and advise during all phases of construction by the inspection branch of Base Maintenance.



5. Specifically, in addition to the assistance described above, the following service by Maintenance forces is required. Again, all work will be reimbursed from NAF sources under the control of the Commanding Officer, MCAS(H), New River.

(a) Roofing Project-

1. Provide 220 volt electrical service. There are transformers mounted on a pole approximately 100 feet away.

(b) Car Wash Facility

1. Provide ^{220V} ~~440V, 3-phase~~ electrical service.
2. Provide (or authorize) a 2" water connection.
3. Provide (or authorize) connection to a recently constructed oil/water separator system located at the site.

(c) Marina Bathhouse

1. Provide water (2" water line).
2. Underground electrical service (220V). It is proposed to bring it from building AS-2800.
3. Provide connection to central sewage system.

6. In order to proceed with these projects as expeditiously as possible, it is requested that a representative of Marine Corps Base meet with us at the earliest possible date so that conflicts can be resolved and progress continued.
