I'm not all here this morning. The plant account book had listed 1500 and 438 as having dry cleaning operations. I had listed these as drop-off / pick-up points because I could not find anyone who could verify what operations they were used for. Fred verified 1500, 438 is still not-verified. I will call a few additional people to pursue.

I spoke with the lady who managed the dry cleaners from 1988-1998, to her knowledge there were no dry cleaning activities at any other Buildings than Building 25. She told me that the man who had managed prior to her was now dead.
