This letter is in response to your letters of August 25, 2001 and September 13, 2001 to the Commanding General, and your August 28, 2001 and September 24, 2001 letters to the Director, Environmental Management Division.

In your letters of August 25 and September 13, you requested a copy of the "limited information" which was referenced in Colonel Karle's letter dated August 6, 2001.

*Response: The 'limited information' consists of TTHM Surveillance Report Forms provided by the US Army Environmental Hygiene Agency. Enclosure 1 pertains.*

In the same letter you posed a question, "If MCB's 'limited information' cites the sample dates and the fact that they were in fact submitted for TTHMs to some NC certified laboratory for analysis, has this laboratory been identified and questioned if the testing laboratory made any effort to determine the nature of the unidentified halogenated or chlorinated hydrocarbons?"

*Response: Based on documents in our possession and all currently available information, it is not known whether the US Army Environmental Hygiene Agency made any effort to determine the specific identity of the unidentified halogenated or chlorinated compounds.*

In your August 28, 2001 letter you request that EMD attempt to locate documents cited in a March 1, 2001 LANTDIV letter. The documents requested include:
