As a Federal Magistrate Judge in the United States District Court for the District of Colorado, Magistrate Crews has proven he has the intellect, time management skills, and judicial temperament necessary to be an effective judge. He deftly handles a full docket and is well respected by his colleagues and the parties that appear before him. When parties consent under 28 U.S.C. § 636(c), he presides over full trials as he would as an Article III judge, which demonstrates his ability to "hit the ground running" and make an immediate impact. Those who encounter Magistrate Crews, ranging from a judicial officer of Colorado's highest court to a juror in a week-long trial he presided over, rave about his incredible work ethic, judicial temperament, and impeccable character.
