
We are a diverse nation. Our citizens possess a colorful array of different political opinions, have varying religious beliefs, hail from a combination of racial and ethnic backgrounds, national origins, family histories, sexual orientations, and have unique outlooks on all manners of issues and topics. He is also an experienced litigator, having spent the last fourteen years defending governmental and commercial entities in federal and state courts when multi-million-dollar lawsuits were brought against them.
