I am a civil litigator, with trial and appellate experience in both state and federal court. About half of my litigation experience has been as an Assistant United States Attorney (AUSA) for the United States Attorney's Office for the Southern District of Indiana (USAO), Civil Division, and the other half has been at law firms in Indianapolis, Indiana. At present, my practice focuses on helping clients respond to government enforcement actions related to the False Claims Act, professional licensing, and Drug Enforcement Administration (DEA) regulations. I maintain an active civil litigation case load representing plaintiffs and defendants in matters involving Title IX, First Amendment, and general business litigation disputes.

In September 2013, after graduating law school and serving as a legal research assistant for Professor Alfred C. Aman, I served for two years as a law clerk for the Honorable Chief Justice Loretta H. Rush of the Indiana Supreme Court. As a clerk, I drafted majority opinions, dissents, oral argument memoranda, reviewed and advised on transfer petitions, original action petitions, and certified questions.

I advised Chief Justice Rush in deciding civil, criminal, constitutional and attorney discipline cases. I also assisted Chief Justice Rush in various other administrative and professional duties, including speech writing.

In September 2015, I returned to Faegre Baker Daniels LLP (now Faegre Drinker Biddle & Reath LLP), having worked there as a Summer Associate in 2012. For the next three and a half years, I worked as a business litigation associate for a large, full-service law firm in their Indianapolis office. I worked on a variety of business litigation matters, including dispositive motions drafting, attorney-client privilege and work product disputes, e-Discovery, document review, witness preparation, trial preparation, settlement negotiations, contract review, and pre-litigation investigations. I represented all kinds of clients – including individuals, corporations, non-profits, municipal entities, utilities, and medical providers – in state and federal court, and in one case before the Indiana Board of Pharmacy. My substantive focus was antitrust, False Claims Act, trade secrets, and commercial disputes. I also supported the firm's antitrust team by researching and drafting compliance memoranda on cutting-edge antitrust compliance issues.

In February 2019, I accepted an offer to become an AUSA at the United States Attorney's Office for the Southern District of Indiana in the Civil Division. I served as the USAO's Civil Health Care Fraud Coordinator and Civil Opioid Coordinator, and litigated civil cases on behalf of the United States as government defense counsel. As the Civil Health Care Fraud Coordinator and Civil Opioid Coordinator, I coordinated the investigation and litigation of virtually every federal health care fraud and Controlled Substances Act enforcement matter that had the possibility of civil enforcement. My enforcement efforts contributed to approximately \$350 million in civil monetary damages and penalties recovered by the federal government. As government defense counsel, I defended federal agencies and their employees from tort claims filed under the Federal Tort Claims Act, including personal injury claims arising from motor vehicle accidents involving federal vehicles, slip-and-falls on federal property, medical malpractice claims against physicians employed by the Department of Veterans Affairs, and constitutional torts filed against the Federal Bureau of Prisons and federal law enforcement officers. As an AUSA, I tried three cases, taking the direct examination of fifteen trial witnesses and cross-examining six trial witnesses. I also took approximately twenty-nine depositions and defended approximately fourteen. I also participated in approximately sixteen settlement conferences with the Southern District of Indiana magistrate judges.

In July 2024, I accepted an offer to join Kroger Gardis & Regas, LLP, where I presently work as Counsel. My practice is three-fold. First, I am associate counsel in several matters on behalf of current and former women collegiate athletes challenging athletic eligibility policies that allow trans-identifying men to participate in collegiate athletics. Across my entire career, approximately 75% of my practice has been in trial-court or appellate litigation, and the other 25% has been pre-litigation government investigations or compliance counseling. I have also participated in Indiana administrative proceedings before the ultimate agency authority in contested hearings.

During my clerkship, I was in the Indiana Supreme Court multiple times per month observing dozens of oral arguments. While an Associate at Faegre Baker Daniels, LLP, most of my litigation practice involved brief writing, fact investigation, legal research, and e-discovery management. At the United States Attorney's Office, about two-thirds of my practice was in federal trial or appellate court. I appeared frequently in the District Court for the Southern District of Indiana, including initial pre-trial and status conferences, applications for administrative inspection warrants, contested evidentiary hearings, discovery dispute conferences, mediations, pre-trial conferences, bench trials, and a jury trial. I also filed many briefs in support of pre-trial and dispositive motions. As Counsel at Kroger Gardis & Regas, LLP, most of my practice involves litigation in federal and state court, appearing at initial pre-trial and status conferences, contested evidentiary hearings, contested hearings on motions for injunctive relief, discovery

1. *United States ex rel Fischer v. Community Health Network, Inc.*, 1:14-cv-01215-RLY-MKK (S.D. Ind.) (J. Richard Young; M.J. Doris Pryor; M.J. M. Kendra Klump) (Representation: 2019–2024)

I represented the United States in a False Claims Act case against Community Health Network, Inc. The United States alleged that Community Health Network knowingly submitted claims to Medicare for designated health services that were referred in violation of the Stark Law (i.e., the anti-self-referral law). The United States alleged that Community Health Network violated the Stark Law by paying dozens of physicians compensation that exceeded fair market value and bonuses that took into account the value and volume of referrals. The case started before I joined the United States Attorney's Office as a qui tam action filed by the former Chief Financial Officer of Community Health Network. After I was assigned to the matter, the United States intervened in the case and aggressively litigated it. *See, e.g., United States v. Cmty. Health Network, Inc.*, No. 1:14-cv-01215-RLY-DLP, 2021 WL 12222172, at *1 (S.D. Ind. Oct. 20, 2021) (denying motion to dismiss United States' complaint in intervention); *United States v. Cmty. I coordinated the investigation and litigation of virtually every federal health care and drug enforcement matter that had the possibility of civil enforcement. These matters involved alleged Medicare, Medicaid, and TRICARE fraud committed by health care providers – from individual practitioners to regional health networks to life sciences companies. These matters also involved Controlled Substances Act violations committed by DEA registrants – from individual practitioners to retail and long-term care pharmacies. I worked closely with the USAO criminal division, working in parallel on health care matters or enforcing civil remedies in matters declined by the criminal division. This required monitoring and reviewing the work of special agents, investigators, auditors, and paralegals while collaborating with counsel from other USAOs, Trial Attorney's from the Department of Justice, federal agencies, and the Indiana Attorney General's Office. In 2015 and 2016, I represented an inmate incarcerated in the Wisconsin Department of Corrections in a Seventh Circuit appeal and Petition

for Certiorari before the United States Supreme Court (*Werner v. Wall, et al.*, No. 14-1746, ECF No. 59 (Jan. 21, 2016) (7th Cir.); *Werner v. Wall, et al.*, No. 16-898).

While an Associate at Faegre Baker Daniels, LLP, I worked with the managing partner to assist two individuals seek status under the Deferred Action for Childhood Arrivals (DACA) executive order.

In law school, I participated in the IU Maurer Inmate Legal Assistance Program (ILAP). As a participant in the program, I did legal research for and drafted letters advising inmates on a variety of legal issues.

I have also assisted non-profit organizations both in a legal representative capacity, in my capacity as a member of the board of directors, and as a volunteer. For example, in a representative capacity, I assisted the Second Reformed Presbyterian Church in obtaining a zoning variance from the Indianapolis Metropolitan Board of Zoning Appeals to install a new sign that encroached on the public right of way. Later, in a board management capacity, I assisted the Second Reformed Presbyterian Church and the Indianapolis Jewish Community Center with bylaws revisions and with navigating complex financial matters. I have also volunteered at my church, serving in Sunday school, musical, property management, and financial management capacities.

On June 13, 2025, I interviewed with Senator Banks and his staff. On July 29, 2025, I interviewed with attorneys from the White House Counsel's Office at the Eisenhower Building in Washington, D.C. On August 20, 2025, I was contacted by staff from the office of Senator Young to interview with Senator Young. On August 25, 2025, I interviewed with Senator Young and his staff. On October 24, 2025, I was informed of my potential nomination. Since then, I have been in regular contact with the White House Counsel's Office and Office of Legal Policy at the Department of Justice in preparation for a potential nomination. On November 12, 2025, the President called to tell me I would be nominated.

To my knowledge, Indiana does not have a selection commission.
