Town of Altoona Annexation:

The small town of Altoona, Alabama is one of my longstanding clients. The town became very concerned that a small rural elementary school just outside of their municipal limits was without adequate protection and well beyond the geographic scope of the county Sheriff's Department if there were an emergency. I researched Alabama law and discovered a means by which the town could annex the school with contiguous property agreements creating a form of island annexation by agreement.

All neighboring landowners agreed to the plan and the town then authorized me to draft the necessary filings and deed modifications. The long time Judge of Probate said that he had never had any annexation come through his office that was so meticulously planned and amicable. As a result of the work done the Town of Altoona adopted the school via annexation and placed a full-time School Resource Officer there as a protective measure for the students and faculty.

Revision of Alabama's Foreign Adoption Laws:

One of my clients adopted their daughter (Karina) from Ukraine. After two years they came to me and asked if I would conduct the "re-adoption" required under Alabama law. It turned out that Alabama was one of the few states that required any foreign adoption to be redone in state courts.

I first handled the adoption successfully. But as a State Senator I was not satisfied. I personally researched and drafted original legislation to abolish the archaic re-adoption process and to streamline the ability of families to adopt children from foreign countries. I then sponsored the legislation and while working the bill on the Senate floor I amended it to be named "Karina's Law." The family then came to Montgomery and were present for the bill signing with the Governor. I have had a number of people over the years since that time inform me that their adoption process was so much easier and less expensive as a result of Karina's Law.

Establishment of State Senate Impeachment Procedures:

In 2016 Alabama Governor Robert Bentley was facing impeachment for indiscretions that occurred during his time in office. I researched the issue and informed the Senate Pro Tem that Alabama had never conducted a formal impeachment and that there were no rules or procedures for doing so.

I was then tasked with forming a bipartisan commission to review other states, research existing law, and to form the manner and means by which a Senate Impeachment Trial would be conducted. After weeks of study and cooperative planning I drafted the report of findings and recommendations for the Senate. This included rules of procedure, rules of evidence, timing, presiding authority, and means of casting votes.

The full report was unanimously adopted by the Senate and is now a matter of permanent record in the event of a future need for such actions. I have provided a copy of this report as one of my writing samples.
