Knights of Columbus is a fraternal organization whose membership is limited to men who are practicing Catholics in good standing with the Church, and so, it does limit membership based on sex and religion.

To the best of my knowledge, none of the other organizations listed above currently discriminates or formerly discriminated on the basis of race, sex, religion or national origin, either through formal membership requirements or the practical implementation of membership policies.

1. *Adkins v. City of Middletown*, 2025-Ohio-317, 263 N.E.3d 429 (Ohio Ct. App.).

Adkins was involuntarily terminated as Middletown's city manager. Adkins, a 56-year-old white male, sued the city for age, sex, and race discrimination. The trial court granted Middletown's motion for summary judgment, dismissing all of Adkins' claims. Adkins appealed. The court of appeals' majority opinion, which I authored, upheld the trial court's summary judgment decision. However, the court of appeals rejected the higher standard for "reverse discrimination" claims imposed on members of racial majorities, finding that this standard was not supported by the Ohio discrimination statute's text and should not have been applied by the trial court. A few months later, the United States Supreme Court applied similar analysis to reach the same result, rejecting the Sixth Circuit's higher standard under Title VII. The court of appeals was the first and only Ohio court of appeals to reject the Sixth Circuit's non-text-based standard. Adkins did not appeal our court's decision.

2. *State v. Froman*, 2022-Ohio-2726 (Ohio Ct. App.). Copy supplied.

Froman killed his former girlfriend's son in Kentucky. He then abducted his former girlfriend, drove to Ohio, and killed her. The Warren County Court of Common Pleas convicted Froman of aggravated murder of the former girlfriend and sentenced Froman to death. The Ohio Supreme Court affirmed the conviction and death sentence. Froman later filed a petition for postconviction relief, arguing 47 grounds for relief. The state moved to dismiss the petition and the trial court granted the motion to dismiss. Froman appealed, raising nine assignments of error. The court of appeals' majority opinion, which I authored, upheld the trial court's decision to dismiss Froman's petition for postconviction relief. Among other findings, the court of appeals held: (1) that American Bar Association Guidelines regarding professional norms in death penalty cases are not law, (2) that the death penalty is constitutional, (3) that pretrial publicity about the former girlfriend's murder did not require a change of venue, (4) that Froman's counsel was not ineffective for failing to request a jury instruction on testosterone use, and (5) that Ohio's postconviction relief system is not unconstitutional.

3. *Marinakakis v. Marinakis*, 2025-Ohio-2555, 271 N.E.3d 884 (Ohio Ct. App.).

This case involved a probate dispute over whether a deceased man's extensive assets should be inherited by his siblings or his children. The children were born after the deceased man drafted his will, and thus the children were "pretermitted children" under R.C. 2107.34(A). The case turned on language in a statute that originally entered Ohio law in the 1830s, but which had never been interpreted by the Twelfth District Court of Appeals and was seldom interpreted by other courts. The trial court granted summary judgment in favor of the children. The siblings

appealed, and the children cross-appealed. The court of appeals' majority opinion, which I authored, interpreted the relevant statutory language in a significantly different manner than the probate court had interpreted that language. The court of appeals also found that the trial court should not have granted summary judgment because genuine issues of material fact still existed. The court of appeals reversed the probate court's decision.

In an earlier lawsuit, ClarkDietrich Building Systems LLC brought a defamation claim against the Certified Steel Stud Association, Inc., a trade association. The defamation claim was based on the association's statements about ClarkDietrich's products in the association's trade publication. During trial, ClarkDietrich offered to settle the case by voluntarily dismissing its defamation claim in exchange for no money. The board of directors of the trade association rejected the no-cost settlement offer. A jury then found for ClarkDietrich, resulting in a \$40 million judgment against the trade association. The trial court then appointed a receiver to bring claims, on behalf of the Certified Steel Stud Association, against individual members of the trade association's board of directors for breach of fiduciary duty and declaratory judgment, based on the directors' rejection of the no-cost settlement offer. The trial court granted summary judgment to the directors and dismissed the receiver's claims, based on its interpretation of Delaware's business judgment rule. The court of appeals' majority opinion, which I authored, applied Delaware law in finding that the directors' decision to reject the no-cost settlement offer was subject to review under Delaware's business judgment rule. Based on the nature of a trade association, language in the association's bylaws, evidence establishing a rational basis for the directors' decision to reject the no-cost settlement offer, and other factors, the court of appeals affirmed the trial court's summary judgment decision.

5. *Preterm-Cleveland v. Yost*, 2023-Ohio-4570 (Ohio). Copy supplied.

*Preterm-Cleveland*, an abortion provider, challenged Ohio's Heartbeat Bill in the Hamilton County Court of Common Pleas. That court, finding that the law violated a federal constitutional right to abortion, issued a statewide preliminary injunction enjoining the law. The state appealed, and the First District Court of Appeals affirmed. The state then appealed to the Supreme Court of Ohio. Chief Justice Sharon Kennedy appointed me as a visiting justice in the place of Justice Joseph Deters, who recused. I participated in oral arguments. The only issues before the court were procedural: whether the state may immediately appeal orders preliminarily enjoining state laws and whether the plaintiffs had standing. Before the Ohio Supreme Court could issue a decision, Ohio voters approved an amendment to the state constitution that provided for "a right to make and carry out one's own reproductive decision," including but not limited to abortion. Ohio Const. art. I, § 22. *Preterm-Cleveland* argued the case should be returned to the trial court, and the state argued the Ohio Supreme Court should decide the procedural issues. Five justices voted to *sua sponte* dismiss due to a change in the law. Justice Brunner dissented and would have dismissed the appeal as having been improvidently accepted. I dissented on different grounds, because I would have proceeded with addressing the propositions of law previously accepted for review. I concluded that jurisdiction is determined at the time a case is filed, and thus the important procedural questions before the court regarding the appealability of a single-county judge's statewide injunction preliminarily enjoining state law and standing should be decided.

6. *Dudley v. Siler Excavation Servs., LLC*, 2023-Ohio-666, 210 N.E.3d 580 (Ohio Ct. App.).

The plaintiff was a human resources manager who opposed her employer's decision to require an

employee who tested positive for COVID to return to work in less than 10 days. The employer terminated her. The plaintiff brought a claim for wrongful termination in violation of public policy. The trial court granted the employer's motion to dismiss. In a majority opinion authored by Judge Robin Piper, the court of appeals affirmed, finding the plaintiff failed to articulate a clear public policy to support her claim. I authored a concurring opinion in which I further explained, on separation of powers grounds, that the "Responsible Restart" guidance issued by the Ohio Department of Health was not law and thus could not form the basis for a public policy claim.

7. *State v. Fuell*, 2021-Ohio-1627, 172 N.E.3d 1065 (Ohio Ct. App.).

The appellant, while 17 years old, shot and killed the victim during a home invasion. He was charged with murder, aggravated robbery, and aggravated burglary. A juvenile court conducted a mandatory bindover hearing and then transferred the appellant to adult trial court. After the appellant was convicted of murder, the trial court sentenced him to fifteen years to life in prison, which was required by statute. He appealed, arguing that (1) the bindover hearing violated his confrontation clause rights, (2) the bindover hearing should have been governed by the Ohio Rules of Evidence, and (3) the trial court committed plain error in not considering the appellant's youth when sentencing him. In an opinion that I authored, the court of appeals held that (1) federal and state confrontation rights do not apply at a juvenile bindover hearing; (2) the Rules of Evidence do not apply at juvenile bindover hearings; and (3) the failure to consider the appellant's youth was not plain error.

A juvenile court granted permanent custody of S.B., a minor child, to a county children services agency. The parents appealed, arguing the juvenile court's decision was not supported by sufficient evidence and was against the manifest weight of the evidence. In an opinion that I authored, the court of appeals affirmed the juvenile court's permanent custody decision. Among other facts supporting the award of permanent custody to the agency, S.B. experienced homelessness, exposure to domestic violence, educational neglect, neglect of health conditions, and more while in the mother's care. S.B. experienced severe anxiety when required to interact with the mother. The court of appeals also noted that the father had very little contact with S.B. and did not attempt to assist her when she was homeless. However, the court of appeals also noted that "[t]here is no requirement in Ohio law that parents must unquestioningly accept and support their minor children's claims of transsexual identity or preferred pronouns." Likewise, the court of appeals noted that "[p]arents are free to assist and guide their children in the development of their religious faith." Finally, the court of appeals noted that the court would use S.B.'s biological pronouns.

9. *Ehlers v. Thomas*, 2024-Ohio-2531, 247 N.E.3d 586 (Ohio Ct. App.).

The petitioner, a deputy coroner, sought a civil stalking protection order after the respondent sent numerous confrontational email messages to her about a death that the respondent believed was part of a coverup. The trial court granted the protection order. In addition to barring the respondent from contacting the petitioner, the court's order barred the respondent from making any social media posts that mentioned the petitioner and prohibited the respondent from possessing firearms. In an opinion authored by Judge Robert A. Hendrickson, the court of appeals struck down the trial court's speech and firearms restrictions as overbroad and not permitted by the First and Second Amendments. Further, in the case of the firearm restriction, the restriction was improperly imposed when there was no evidence the respondent used or threatened to use a firearm. The other restrictions in the protection order remained in place.

The Hamilton County Clerk of Courts eliminated online access to court records in residential eviction cases that were older than three years. The Hamilton County municipal court judges ordered the Clerk to restore online access and threatened to hold the Clerk in contempt. In response, the Clerk sought a writ of prohibition in the First District Court of Appeals against the municipal court judges. The municipal court judges sought a writ of mandamus requiring the Clerk to restore online access. Chief Justice Sharon Kennedy appointed three judges of the Twelfth District Court of Appeals, including me, to sit on the First District Court of Appeals by designation because the First District judges recused. In an opinion authored by Judge Robin Piper, the court of appeals concluded that the Clerk was not entitled to a writ of prohibition because the judges had the authority to hold the Clerk in contempt and because the Clerk had an adequate remedy at law. The court also granted the judges' petition for writ of mandamus.

A judge may recuse later in the appellate process if a reason for recusal becomes apparent.

During my entire law practice, I have focused primarily on employment law. While at Taft Stettinius & Hollister LLP, I occasionally performed some work related to other practice areas. At Jackson Lewis P.C., I focused entirely on employment law.

I devoted approximately 85% or more of my time to representing employers in employment litigation. I handled cases involving claims brought under the Fair Labor Standards Act, Title VII of the Civil Rights Act of 1964, the Age Discrimination in Employment Act, the Family and Medical Leave Act, the Americans with Disabilities Act, and other federal statutes, as well as claims brought under state employment law statutes and state common law claims such as non-competition/restrictive covenant cases, promissory estoppel, and negligent hiring and supervision. In the last few years of my practice, I devoted a greater portion of my practice to representing employers in wage and hour collective action and class action disputes.

I represented clients primarily in the United States District Courts for the Southern District of Ohio, the Western District of Kentucky, and the Eastern District of Kentucky, and in the state courts of Ohio and Kentucky.

I also represented clients in agency proceedings with the Equal Employment

My client, Fifth Third Bank, terminated the employment of three plaintiffs. The plaintiffs brought claims for sex and age discrimination under Kentucky state law in Campbell County Circuit Court. Fifth Third filed a motion to dismiss, or, in the alternative, for summary judgment, arguing that the claims should be dismissed because the plaintiffs had signed lawful contractual limitation of actions provisions and their claims were untimely filed. After full briefing and a hearing at which oral argument was presented, Judge Julie Reinhardt Ward of the Campbell County Circuit Court granted the motion and dismissed the plaintiffs' claims. Plaintiffs McLaughlin and Raniero then filed similar sex and age discrimination claims under Title VII in

the U.S. District Court for the Eastern District of Kentucky. The parties engaged in discovery, after which Fifth Third filed a motion for summary judgment, this time addressing the merits of the plaintiffs' claims, rather than timeliness. United States District Judge Karen K. Caldwell granted Fifth Third's motion for summary judgment and dismissed the case on June 7, 2018. The plaintiffs appealed to the United States Court of Appeals for the Sixth Circuit. The Sixth Circuit affirmed the district court's summary judgment decision on May 24, 2019. The Sixth Circuit panel that heard and decided the appeal included United States Circuit Judges Danny J. Boggs, Alice M. Batchelder, and Jane Branstetter Stranch. 2. *Bey v. WalkerHealthcareIT, LLC*, No. 2:16-cv-01167 (S.D. Ohio).

The plaintiff brought putative class and collective action claims of unpaid overtime under the FLSA and Ohio state law. The potential class included at least 500 individuals. The plaintiff alleged that she was not paid time and a half for overtime hours worked, and that our client, Encore Health Resources, LLC, was liable, along with the other defendants who were not represented by our firm. Our client filed a motion to dismiss, arguing that the complaint failed to allege that our client was either an employer or joint employer under the FLSA or state law. United States District Judge George C. Smith permitted the plaintiff to file an amended complaint, and the plaintiff did so. Our client filed a new motion to dismiss, which was denied. Other plaintiffs came forward in other states, and similar cases were filed in California (the *Pierce* case) and Texas (the *Andrus* case). We initially represented Encore in the *Pierce* case but had to withdraw after a conflict arose between Encore's previous owner (our first client) and Encore's new owner. While I worked at Taft Stettinius & Hollister LLP, I represented a handful of individuals in employment law matters on a pro bono basis through the Volunteer Lawyers Project. I no longer have records regarding these matters, but I know I represented a young man who was not paid wages by his employer. I filed a wage and hour lawsuit on his behalf, but it was eventually dismissed when the plaintiff left the country and was unavailable to pursue the matter.

My next law firm, Jackson Lewis P.C., did not permit attorneys to represent employees. Therefore, my pro bono work at Jackson Lewis instead focused on finding ways to provide

employment law advice to charitable/non-profit organizations. I advised several non-profits on specific situations involving employment law concerns and updated employment policies and/or employee handbooks for such organizations. These organizations included a national leadership organization for girls, a national organization that engages in breast cancer advocacy and education, a church, and an organization that engages in public advocacy for people with a particular form of cancer. I also gave presentations on employment law compliance to non-profit charitable organizations through the Pro Bono Partnership of Ohio.

On average I performed around 30 hours of pro bono legal work per year while I was a practicing attorney.

Currently, as a judge, I cannot engage in pro bono legal services. So, I have found other ways to make a positive impact on the legal system and the administration of justice. I frequently volunteer for speaking engagements and public ceremonies. I also arranged for our court to travel to off-site locations so that schoolchildren may attend oral arguments and question-and-answer sessions with the judges and discussions about the role of state courts in our constitutional system. I regularly speak to students at my children's school about the legal profession and the role of the courts, and make myself similarly available to other school or student groups when invited.

I learned of Judge Michael Watson's decision to take senior status in October 2025. I promptly informed Senators Moreno and Husted of my intention to seek their recommendation for the President's nomination to fill the vacancy. The United States Senators from Ohio do not utilize a selection commission for judicial vacancies. Instead, each Senator's office informed me of their respective application processes. I submitted the requested applications to both senators. I interviewed with Senator Moreno's staff on November 24, 2025, and with Senator Husted's staff on January 7, 2026. I interviewed with Senator Moreno and his staff on January 26, 2026, and with Senator Husted and his staff on February 13, 2026. On April 21, 2026, I interviewed with attorneys from the White House Counsel's Office in Washington, D.C. Since then, I have remained in contact with attorneys from the White House Counsel's Office and officials from the Office of Legal Policy at the Department of Justice. On May 27, 2026, President Trump called me to inform me that he had selected me to be nominated for a position on the United States District Court for the Southern District of Ohio.
