In the past, the Boy Scouts of America (now renamed “Scouts BSA”) limited troop and pack membership to males, although segments of the program, such as Venturing and Exploring, were open to both males and females. The Scouts BSA limitation has since been removed, and all segments of the program are open to both males and females.

A Century of Jewish Life in Dixie: The Birmingham Experience maintains that Pine Tree Golf & Country Club was a club formed by the merger of two country clubs that limited membership to Jews. This membership policy changed in 1991, long before my membership, and I was unaware of the former policy until researching it for this questionnaire. To the best of my knowledge, none of the other organizations listed above currently discriminates or formerly discriminated on the basis of race, sex, religion or national origin, either through formal membership requirements or the practical implementation of membership policies.

My records show that in August 2008, I wrote an article with R. Bruce Barze, Jr. and Marcus R. Chatterton entitled "Production of Information Contained in Litigation Reserves" for an ABA newsletter, "Business Litigation Committee Newsletter." I have been unable to locate a copy of this article.

I served on the Grievance Committee of the Birmingham Bar Association for one term (three years). In that role, we would investigate bar complaints against lawyers and recommend findings and punishments to the State Bar. I do not have these materials and do not recall specific lawyers. Further, these recommendations are confidential under Alabama law and procedure.

In addition, I served on the Standing Committee on Rules of Civil Procedure for the Alabama Supreme Court for six years (I was not the chair). In that role, our Committee made several recommendations to the Supreme Court to revise certain Rules of Civil Procedure. The Committee Comments for each such rule reflect the report which our Committee provided to the Court. These comments are attached to the individual rules and are dated. Among the rules which I recall the Committee revising (and in which I had a role) were rules 23, 26, 37, 43, 59.1.

As noted above, as a member of the Alabama Supreme Court I have not “presided” over cases. Consistent, however, with the practice of past nominees who have served on courts of appeal, I have provided 10 cases for which I wrote the majority opinion

delivering the judgment of the court.

1. *Ex parte Ala.-West Fla. Conference of United Methodist Church, Inc.*, 401 So. 3d 1123 (Ala. 2024).

A local congregation, Harvest Church-Dothan, sued regional and national United Methodist entities seeking a declaration that they had no ownership interest in the church's property. The denominational bodies argued that the case should be dismissed because resolving the dispute would require courts to decide ecclesiastical matters, which are generally beyond the jurisdiction of civil courts.

The Alabama Supreme Court rejected that argument at this stage of the litigation. It held that the dispute appeared to concern property ownership and control—issues that civil courts may resolve using “neutral principles of law” without deciding questions of church doctrine or governance. Accordingly, the court denied the petition for a writ of mandamus and allowed the lawsuit to proceed in the trial court.

2. *Sawyer v. Cooper Tire & Rubber Co.*, 412 So.3d 603 (Ala. 2024).

The personal representative of a Florida decedent’s estate sued Cooper Tire in Alabama after a fatal crash in Mobile County allegedly resulted from a defective tire that experienced tread separation. Cooper Tire argued that Alabama courts lacked specific personal jurisdiction because neither the plaintiff nor the decedent was an Alabama resident and because the tire at issue was not shown to have been sold or distributed by Cooper Tire in Alabama during the years immediately preceding the accident.

The Alabama Supreme Court, relying heavily on the U.S. Supreme Court’s decision in *Ford Motor Co. v. Montana*, held that Cooper Tire’s extensive activities in Alabama—including selling, distributing, and marketing the same tire model involved in the case—were sufficiently related to the plaintiff’s claims to support specific personal jurisdiction. The court concluded that the lawsuit “related to” Cooper Tire’s Alabama contacts even if the precise tire could not be traced to a recent Alabama sale by the company. Accordingly, the court reversed the trial court’s dismissal and remanded the case for further proceedings on the merits.

3. *Ex parte Hous. Auth. of City of Talladega*, 413 So.3d 14 (Ala. 2024).

A public-housing tenant sued his landlord after he fell on apartment stairs that lacked handrails, alleging negligence and wantonness. The trial court granted summary judgment to the Housing Authority, reasoning that the missing handrails were an “open and obvious” danger the tenant knew about.

The Alabama Supreme Court held that the lower courts had applied the “open and obvious” doctrine too broadly in the landlord-tenant context. The court explained that a landlord may still owe duties regarding dangerous conditions in areas under the landlord’s control, even when the danger is obvious, consistent with long-standing landlord-liability principles reflected in the Restatement of Torts.

Accordingly, the court affirmed the Court of Civil Appeals’ decision reversing summary judgment for the Housing Authority and allowed the tenant’s claims to proceed. The decision clarified that Alabama’s earlier opinion in *Daniels v. Wiley* did not eliminate these traditional exceptions to the open-and-obvious rule in landlord-tenant cases.

4. *Ex parte Scarborough*, 428 So. 3d 1146 (Ala. 2025).

The administrator of an inmate's estate brought a wrongful-death and medical-malpractice action against healthcare providers who treated the inmate at Limestone Correctional Facility before his suicide. Although the defendants believed venue was proper only in Limestone County under the Alabama Medical Liability Act (AMLA), they litigated the case in Montgomery County for several years before moving to transfer it.

The Alabama Supreme Court held that the defendants had waived any objection to venue by failing to raise it in a timely manner as required by Alabama Rule of Civil Procedure 12(h)(1). The court rejected the argument that the AMLA's venue statute allowed a late venue challenge notwithstanding the ordinary waiver rules, relying on its prior interpretation of that statute.

Accordingly, the court granted Scarborough's petition for a writ of mandamus and directed the trial court to vacate its order transferring the case to Limestone County.

5. *Nissan North America, Inc. v. Henderson-Brundidge*, 2025 WL 3039769 (Ala. Oct. 31, 2025).

A woman who was permanently blinded in one eye sued Nissan under the Alabama Extended Manufacturer's Liability Doctrine (AEMLD), alleging that the passenger-side airbag in a 1998 Infiniti QX4 was defectively designed and that safer alternative designs were available. A Mobile County jury returned an \$8.5 million verdict in her favor, after which Nissan sought judgment as a matter of law, a new trial, or a remittitur.

The Alabama Supreme Court held that the plaintiff had presented substantial evidence supporting her defective-design claim, including evidence of a safer, practical alternative design, and therefore affirmed the trial court's denial of Nissan's motion for judgment as a matter of law. However, the Court concluded that the trial court had mistakenly believed prior Alabama precedent deprived it of discretion to grant a new trial based on jurors' failure to disclose prior lawsuits during voir dire.

Accordingly, the Court affirmed the denial of Nissan's request for judgment as a matter of law but reversed the denial of its motion for a new trial and remanded the case. The result was not an outright new trial; instead, the trial court was directed to exercise its discretion and determine whether the jurors' nondisclosures caused probable prejudice warranting a new trial.

6. *Laborde v. Citizens Bank, N.A.*, 2025 WL 3684583 (Ala. Dec. 29, 2025).

A veteran and his spouse sued their mortgage lender after the bank foreclosed on their home, alleging that they had attempted to reinstate the loan and avoid foreclosure following financial hardship. They asserted claims for breach of contract, wrongful foreclosure, unjust enrichment, and breach of the duty of good faith and fair dealing, contending that the bank failed to comply with requirements governing their VA-guaranteed mortgage.

The Alabama Supreme Court held that Alabama law does not recognize an independent cause of action for breach of the duty of good faith and fair dealing and therefore affirmed dismissal of that claim. However, the Court concluded that the homeowners had sufficiently alleged facts supporting their claims for breach of contract, wrongful foreclosure, and unjust enrichment, including allegations that the bank improperly refused to permit reinstatement of the loan before the foreclosure sale.

Accordingly, the Court affirmed the dismissal of the good-faith claim but reversed the dismissal of the other three claims and remanded the case for further proceedings. The result was that the homeowners were permitted to continue litigating their contract, wrongful foreclosure, and unjust-enrichment claims against the bank.

7. *Alabama Plating Tech., LLC v. Georgia Plating Tech., LLC*, 411 So. 3d 335 (Ala. 2024).

In this case, the buyer of a brake-plating plant sued the sellers after discovering environmental violations, unpaid accounts payable, and allegedly inoperable equipment following the asset purchase. The buyer claimed that these problems were retained liabilities or breaches of warranties under the asset-purchase agreement and therefore justified setting off its losses against installment payments owed to the sellers. The sellers, in turn, sued the buyer for breach of contract and sought acceleration of the remaining payments.

The Alabama Supreme Court largely sided with the buyer. It held that the buyer was entitled to indemnification for environmental-remediation costs and unpaid accounts payable, and it further concluded that the trial court had erred in denying relief on the buyer's claim relating to inoperable assets. The Court also determined that the buyer was entitled to pursue recovery of attorneys' fees and litigation expenses under the agreement's indemnification provisions.

Accordingly, the Court reversed the portions of the judgment denying relief on the inoperable-assets claim and denying attorneys' fees, affirmed the rulings in the buyer's favor on the environmental and accounts-payable claims, and upheld the denial of the sellers' request to accelerate the remaining installment payments. The case was remanded for further proceedings consistent with those holdings.

8. *CBS Holdings, LLC v. Hexagon US Fed., Inc.*, 2025 WL 1910167 (Ala. July 11, 2025).

In this case, the dispute arose from an alleged breach of a commercial lease after CBS Holdings purchased property that Hexagon US Federal (HexFed) continued to occupy. After HexFed prevailed in litigation over lease renewal and related breach-of-contract issues, the trial court also awarded HexFed attorney's fees and costs, later setting the amount at about \$174,000 based largely on redacted billing records. CBS Holdings appealed, arguing the fee award was inadequately supported and insufficiently explained for appellate review.

The Alabama Supreme Court agreed in part with CBS Holdings. It held that while HexFed was entitled to attorneys' fees under the lease, the trial court's order did not provide enough detail or analysis under the required *Peebles* factors to allow meaningful appellate review, especially given the heavily redacted invoices. The Court concluded that the fee award lacked adequate explanation of how the court evaluated reasonableness and billing entries.

Accordingly, the Court vacated the attorney-fee award and remanded for the trial court to reconsider the request using appropriate evidentiary support and to enter a more detailed order explaining its reasoning. The underlying judgment in favor of HexFed on the merits of the lease dispute was not disturbed.

9. *Brickhouse Cap., LLC v. Coastal Cryo AL, LLC*, 393 So. 3d 467 (Ala. 2023).

In this case, a business owner (Santa) sued a financing company after entering into a transaction to acquire and finance a cryotherapy device, ultimately signing multiple electronically delivered documents labeled as lease-related agreements. When Santa later defaulted on payments under the final lease agreement, the lessor sued for breach of contract, and Santa and his company brought a third-party claim against Brickhouse Capital, the financier, alleging fraudulent inducement, arguing they were misled about the nature and terms of the financing arrangement.

The Alabama Supreme Court held that the fraud claim failed as a matter of law because Santa's reliance on any alleged misrepresentations was unreasonable. The Court emphasized Alabama's duty-to-read doctrine, explaining that a party who signs clear contractual documents—especially multiple documents repeatedly identifying the transaction as a lease—cannot avoid the consequences of those terms simply by claiming they did not read them. It also rejected the argument that the use of an electronic signing platform like DocuSign altered the analysis or created any special duty on the part of the other contracting party.

Accordingly, the Court reversed the jury verdict in favor of Santa and Coastal Cryo and rendered judgment in favor of Brickhouse Capital, eliminating the fraudulent-inducement award entirely.

10. *Dalton Drug Co., Inc. v. OptumRx, Inc.*, 424 So. 3d 1254 (Ala. 2025).

OptumRx, a pharmacy benefit manager (PBM), sued independent pharmacies seeking a declaratory judgment to clarify (1) its rights and obligations under an arbitration provision in the parties' contracts and (2) that that provision was binding and enforceable, requiring the parties to arbitrate any future disputes between them.

Eventually, OptumRx moved for a summary judgment in its favor arguing that, if the trial court did not enforce the arbitration provision in the parties' contracts, future litigation between it and the pharmacies would be inevitable because the pharmacies had expressed an intent not to arbitrate the disputes between them. The trial court entered a summary judgment in favor of OptumRx and declared that the parties must arbitrate any future disputes between them pursuant to their contracts. The pharmacies appealed.

The Alabama Supreme Court focused on whether a ripe, justiciable controversy existed between OptumRx and the pharmacies at the time OptumRx filed its declaratory-judgment actions and, thus, whether the trial court's summary judgment in OptumRx's favor was proper. The Court concluded that no ripe, justiciable controversy existed between the parties at the time the declaratory judgment actions were filed. Accordingly, the Court reversed the trial court's judgment and remanded the actions to the trial court with instructions for that court to vacate its judgment and dismiss the actions, without prejudice.

In deciding whether to recuse myself from a case, I apply the standards for disqualification set forth in Canon 3.C of the Alabama Canons of Judicial Ethics and related Alabama Judicial Inquiry Commission Advisory Opinions. That canon provides that “[a] judge should disqualify himself in a proceeding in which his disqualification is required by law or his impartiality might reasonably be questioned, including but not limited to instances” described in the remainder of the canon. The Supreme Court of Alabama utilizes an automatic recusal system. In addition, whenever a case is assigned to my chambers, my senior staff attorney conducts a recusal check to make sure that there is no reason for me to recuse. Per our Court’s policy, a Justice may recuse later in the appellate process if a reason for recusal becomes apparent.

When I left Balch & Bingham for the Alabama Supreme Court, my practice focused almost solely upon commercial litigation with a focus on complex litigation. This included handling over 60 class actions (including MDLs) such as financial services and energy-related actions. I estimate I participated in 1000 matters in multiple state and federal courts (including 15 different states). I have tried jury trials, bench trials and arbitrations.

During the early years of my practice (especially before I became a partner in 1998), I was a general litigator doing matters as assigned. For instance, I handled

most of the workers compensation litigation for our firm for several years. In Alabama, such actions are tried as bench trials in circuit court. Because these cases are statutorily limited in their damages, this provided a low-risk opportunity for a young lawyer to learn with minimal supervision. I had the opportunity to negotiate, settle and try these cases—often by myself. These workers’ compensation cases also led to some involvement in the firm’s employment practice, including some workers’ compensation retaliatory discharge litigation. I also handled insurance disputes both for and against insurance carriers and defended an insurance broker. Some of these early cases involved construction disputes, which I tried by jury in both state and federal court.

In the late 1990s, my practice grew more focused on complex, commercial litigation. I assisted in defending several state court class actions. I became my law firm’s expert in class action rules and strategies. As the litigation climate in Alabama changed, I took these skills and relationships and began litigating in federal courts across the country. A significant portion of this time was spent in connection with class actions.

I also spent considerable time during this period representing banks and financial institutions. Some of this time was dealing with everyday routine advice (for instance, disputes over account ownership and written demands over fraudulent wire transfers). Other matters dealt with mortgage and real property disputes, noncompetition or theft of confidential information. As an example, I filed a series of cases for a banking client related to fraud with their credit card processing business line. I helped the bank recover the losses and to work closely with the assigned Assistant United States Attorney, leading to several convictions.

As noted above, my early years were spent as a general litigator handling a wide variety of matters for the firm. Typical clients included employers, insurance carriers, insurance brokers, and businesses. Areas of practice included workers’ compensation litigation, insurance disputes, and state court class actions.

Over time, I developed an increasing focus on complex commercial litigation, particularly class actions. Typical clients included banks, financial institutions, and other commercial entities facing fraud, consumer, and business-related claims. Although I represented the defendant in many of these cases, I sometimes represented plaintiffs, especially in commercial matters, as reflected in my significant matter list below.

I estimate that 95% of my practice focused on litigation. I engaged in extensive motion practice and discovery issues. I estimate that I appeared in person before a court or by phone once every few weeks. Over time I delegated routine court appearances to younger lawyers.

Generally speaking, my service involved advising disadvantaged clients at the clinic, located in the Jefferson County Courthouse. Examples of matters I handled for clients included: 1) defending a tax redemption lawsuit (won on motion practice and eventually settled for a conveyance of the property); 2) assisting a tenant who claimed that their apartment was infested with lice and that the landlord was responsible (convinced the landlord to pay for the problem); 3) assisting a tenant in an eviction dispute (they brought the problem to the clinic too late and I was unable to set aside the default judgment; however, I was able to obtain several additional months of occupancy before they were required to leave).

I also volunteered with the Alabama Bar Volunteer Lawyers Program, and worked on "Wills for Heroes," using a software package to advise first responders in drafting wills, living wills and powers of attorney.
