Senator Dick Durbin Ranking Member, Senate Judiciary Committee Written Questions for Sara Bailey Nominee to be Director of National Drug Control Policy September 24, 2025

- 1. Past Directors of ONDCP have had backgrounds in public health, medicine, and law enforcement.
 - a. Are you a medical professional?

ANSWER: No.

- b. Have you ever served as a prosecutor or law-enforcement official? **ANSWER:** No.
- c. Have you ever worked for a federal or state government public health agency? **ANSWER:** No.
- 2. At your hearing, you said that shutting down the border has stopped weapons from being trafficked south across the border during the Trump Administration. What evidence do you have to back up this statement?

ANSWER: In calendar year 2024 under the Biden Administration, CBP seized 811 weapons at the southwest board being transported from the United States to Mexico. Contrast that with since February 2025, CBP has seized 298 weapons being transported from the United States to Mexico.

- 3. Your website, SaraACarter.com, is no longer accessible to the public. Online records appear to show that sometime between June 21 and July 19 of this year, the site stopped allowing viewers to see articles you authored.
 - a. Did you or your staff take your website offline or limit viewing to the public? If so, why?

ANSWER: Given the nomination, I had to divest from my company DarkWire, Inc, doing business as SAC, which included SaraACarter.com.

b. Will you commit to making the website public so that members of this Committee can ensure a full and comprehensive review of your record and verify whether any disclosures were omitted?

ANSWER: The website is still accessible but no longer active given that I had to divest from my company to comply with the ethical requirements of the nomination.

4. Gab is social media platform which *The New York Times* described as a "a haven for white nationalists, neo-Nazis and other extremists." Gab's verified X account has stated that it aims to eliminate our current "Judeo-Bolshevik" society. Gab's CEO, Andrew

Torba, is an outspoken antisemite who has argued that "Zionists" are responsible for the "subversion of American Christianity."

Your podcast, "Dark Wars: The Border," has a Gab page with 32 posts.



- a. Does the Gab account depicted in the above photo belong to you?

 ANSWER: I was unaware that a Gab account had been created to promote my podcast prior to now. In trying to respond to this question I learned that the Gab account was created by a former associate who was responsible for marketing.
- b. Has this account been run by you or any of your current or former associates or business partners?

ANSWER: Please see my response to question 4a.

- c. Did you personally create this account or instruct anyone to create it? **ANSWER:** Please see my response to question 4a.
- d. Have you ever posted on this account? **ANSWER:** Please see my response to question 4a.
- e. Do you have a personal Gab account? **ANSWER:** No.

A 2018 article in *The Wall Street Journal* labels the social media website Gab "a home to anti-Semitic and other extremist speech." The Anti-Defamation League called Gab a

"haven for hate and disinformation." Gab CEO Andrew Torba said in 2022, "The Jews in positions of power do not care that you have the freedom of speech in this country, they care that people like [Kan]Ye have the freedom to reach a lot of people and criticize their power and oversized influence in our culture, government, and society."

f. Do you dispute that Gab serves as a haven for white nationalists and antisemites? If so, why?

ANSWER: I do not have any information on Gab other than what you provided here. Therefore, I cannot confirm or dispute that Gab serves as a haven for white nationalist or anti-Semites.

g. Do you condemn Andrew Torba's comments that are quoted above? Are these comments antisemitic?

ANSWER: I condemn all forms of anti-Semitism.

h. Do you currently follow any Gab accounts that have promoted Holocaust denialism?

ANSWER: No.

i. Why would you or your current or former associates choose to publicize your podcast on a platform that serves as a "haven" for white nationalists and neo-Nazis?

ANSWER: Please see my response to question 4a.

- 5. Since taking office, President Trump has undertaken massive funding and personnel cuts to public health agencies, hurting Americans dealing with drugs, addiction, and mental health issues.
 - a. If confirmed, do you plan to continue ONDCP's partnership with the Substance Abuse and Mental Health Administration (SAMHSA)? Please explain the importance of that partnership in combatting drug abuse.

ANSWER: ONDCP maintains strong partnership with SAMHSA and other HHS and federal agencies. The funding cuts have not affected this partnership.

b. Please explain the importance of providing mental health resources to those struggling with addiction.

ANSWER: According to the most recent National Survey of Drug Use and Health, last year, 20.4 million adults in the United States had both some form of mental illness and a substance use disorder, with the highest percentage being young adults aged 18-25. Moreover, it is estimated that approximately 50% of people with a substance use disorder have a co-occurring mental health disorder. Addressing this overlap requires caring for the entire person, and not just treating an individual disease.

c. The Trump Administration has fired thousands of staffers from the Department of Health and Human Services, including many from SAMHSA. Do you believe

reducing the staffing at SAMHSA has helped the U.S. fight the substance abuse crisis?

ANSWER: President Trump is focused on making the government more efficient and reducing waste, fraud, abuse and excess bear acracy. I believe a more efficient government will help the U.S. fight substance abuse.

- d. The Trump Administration's terminations have also targeted suicide and mental health crisis hotlines. Will you fight to restore full funding and staffing to these critical programs?
 - **ANSWER:** I support the President's budgetary decisions while recognizing the importance of suicide prevention and mental health resources.
- e. Please describe the importance of strong data collection efforts to fully understanding the scope and severity of the country's drug abuse problems.

 ANSWER: Data is critical to directing smart and effective drug policies and ensuring resources are applied to where they will do the most good. Innovating in data and research is a key part of the President's drug control policy priorities.
- f. Do you support the Trump Administration's firing of every single staffer responsible for organizing the National Survey on Drug Use and Health?

 ANSWER: I am not aware of the circumstances surrounding the specific personnel decision mentioned in the question and defer to the Department of Health and Human Services.
- 6. On an episode of your podcast, "The Sara Carter Show," you stated that you supported the legalization of medical marijuana. Specifically, you said, "cannabis for medicinal purposes and medical reasons is a fantastic way" of managing cancer, other illnesses, and related side effects.
 - a. If confirmed as ONDCP Director, will you work to legalize medical marijuana on the federal level?
 - **ANSWER:** If confirmed as Director, I will comply with all federal laws and fulfil all statutory responsibilities of the ONDCP. I will also work with the interagency to ensure an examination of all facts and evidence as part of any scheduling or policy actions.
 - b. You previously highlighted a quote by then-Rep. Matt Gaetz that "we have seen a generation, particularly of Black and Brown youth, locked up for offenses that should've not resulted in any incarceration whatsoever." Do you agree that people of color have been disproportionately harmed by drug prosecutions?

 ANSWER: I believe that all communities have suffered as a result of illicit narcotics with data showing that certain drugs are more prevalent in some communities.
 - c. What actions do you believe our government should take to address the past wrongs Rep. Gaetz highlighted?

ANSWER: If confirmed, I will commit to ensuring effective, timely, evidence-based treatment is available to all Americans. At the same time, through collaboration with the Department of Justice, I will support U.S. Attorneys to hold all drug traffickers accountable.

- 7. On numerous occasions, you have praised the self-described dictator of El Salvador, Nayib Bukele. President Bukele runs CECOT, a maximum-security prison in El Salvador notorious for human rights abuses.
 - a. You previously stated that Senator Tim Kaine and then-Senator Ben Cardin "can only dream of having the same type of popular support President Bukele has among his people." Do you stand by this statement?

 ANSWER: I believe polling data shows that President Bukele is more popular among his people than some U.S. politicians.

Prisoners sent from the United States to CECOT in El Salvador were found to have little to no meaningful contact with legal counsel or family members. According to human rights groups, prisoners at CECOT suffered "systematic physical beatings, torture, intentional denial of access to food, water, clothing, health care," and more injustices.

- b. Do you support prisoners having access to legal counsel? **ANSWER:** I support the Constitution of the United States and the rights afforded by it to its citizens which include the right to legal counsel.
- c. Do you support congressional oversight of prisoners in federal custody? **ANSWER:** I support the Constitution of the United State and the U.S. Congress' oversight role.

You previously tweeted that "El Salvador under @NayibBukele is a reflection of what can be for all of us if we fight against corruption and evil." In 2022, President Bukele declared a state of emergency that suspended freedom of assembly, the right to privacy in one's communications, and the right for individuals to be told they are being arrested.

- d. Do you regret your support for a leader who has routinely violated the civil rights and liberties of his own people? ANSWER: My tweet was referring to the fight against corruption, gangs, and drug cartels. Several years ago, El Salvador was listed as one of the most dangerous and corrupt countries in the world. This was directly impacting America as many of El Salvador's gang and drug problems were spilling over to the U.S. My focus is on the safety and well being of America.
- e. President Bukele has also reportedly jailed thousands of innocent people. Is this an approach to fighting "corruption and evil" that you endorse?

ANSWER: I have never expressed support for jailing innocent people.

- 8. In February of 2025, you posted a picture with Hungarian Prime Minister Viktor Orban, praising him for "keep[ing] the EU in check" and stating that there is a "bright future ahead" for him.
 - a. What did you mean when praised Prime Minister Orban for keeping the European Union in check?

ANSWER: I was referencing PM Orban's commitment to put his country ahead of the EU's interest.

b. Prime Minister Orban has referred to the country under his leadership as an "illiberal democracy" with weaker checks and balances and has targeted the free press and weakened the independence of the judiciary. Do you support these actions?

ANSWER: I believe in the free press and support the Constitution of the United States.

9. Have you ever promoted claims questioning how Joe Biden won the 2020 election and implying that he engaged in fraud to do so?

ANSWER: Like many Americans, I had concerns about certain irregularities with the 2020 election.

10. Have you ever suggested that Democrats "need [censorship] to even have a chance" to win in the 2022 election?

ANSWER: I have no recollection of the statement, but like most Americans, I was generally concerned with the amount of censorship that conservatives were experiencing during that time period.

11. You reposted Trump advisor Stephen Miller's claims that, "The Democrat Party at every level — judges, politicians, academics, nonprofits — is organized around the defense and protection of the criminal, the monstrous and the depraved. The more vile the threat, the more vociferously the Democrat Party works to protect and enable it." You claimed these were "facts."

Do you stand by this assessment?

ANSWER: Mr. Miller's tweet was in reference to the murder of a young Ukrainian refugee on a train in North Carolina at the hands of a violent repeat offender with over 14 prior arrests. The shocking video of this violent attack was widely distributed and Americans rightly questioned why this violent offender was released.

12. Do you support the rescheduling of marijuana?

ANSWER: If confirmed as Director, I will comply with all federal laws and fulfil all statutory responsibilities of the ONDCP. I will also work with the interagency to ensure an examination of all facts and evidence as part of any scheduling or policy actions.

13. Please see below for a post from your "Dark Wars" podcast's account.



- a. Do you run this account, and are you the author of the tweet in question?

 ANSWER: This account is run by my prior business. I have access to it but I am not the only person with access. I do not recall if I authored this tweet.
- b. If not you, who authored this tweet?

 ANSWER: Please see my response to question 13a.
- c. Do you stand behind the message of this tweet?

 ANSWER: Regardless of authorship, I view this tweet as an attempt to highlight how inappropriate it was for Members of Congress to be holding up paddles during the President's address.
- 14. In a conversation hosted by the Federalist Society, you called for the Republican members of the House Judiciary Committee to impeach "radical leftist judges."
 - a. Can a judge be impeached simply for ruling against the president?
 ANSWER: I am not an attorney, however, it is my understanding that judges can be impeached for high crimes and misdemeanors.
 - b. According to a study by Stanford University Professor Adam Bonica, President Trump has lost in 72 percent of cases before Republican-appointed judges. Should these judges be impeached?

ANSWER: Please see my response to question 14a.

- 15. During his 2025 State of the Union address, President Trump claimed that his administration had canceled funding for research to make mice transgender. You tweeted your confusion and outrage about that funding, posting "\$8 million for making mice transgender? WTF." Reporting has now confirmed that the funding in question served to evaluate the impacts of hormones on breast cancer risks, asthma, and vaccines.
 - a. If confirmed as Director of National Drug Control Policy, your office's decision making would benefit from scientific studies. How will you ensure that you base your decisions on facts and data, rather than sensationalist headlines?
 ANSWER: If confirmed, I plan to consult with a wide array of experts in the field and review all applicable data to ensure that my decisions and recommendations are supported by facts.
 - b. Do you regret spreading misinformation and mischaracterizing serious public health research?
 ANSWER: I reject the premise of your question. President Trump has put a state of the premise of your question.

ANSWER: I reject the premise of your question. President Trump has put a stop to wasteful spending and ended funding for studies that had little to no scientific value. He has saved the American taxpayer billions of dollars.

- 16. You expressed outrage following President Biden's grant of clemency to a drug trafficker who later ended up reoffending and going back to jail.
 - a. Do you denounce all pardons of individuals who re-offend?
 ANSWER: I was denouncing the pardon of a repeat offender whose prior criminal history and the type of crime committed showed a high likelihood of reoffending.
 - b. Several individuals pardoned by President Trump have committed serious crimes after their pardons. Do you denounce President Trump's pardon of Jonathan Braun, who was pardoned for drug trafficking but now faces another five years in prison because he violated the terms of his release?
 ANSWER: The Constitution vests the pardon authority solely on the President of the United States. As a current government employee, it would be inappropriate for me to comment on the President's pardon decisions.
 - c. President Trump pardoned Ross Ulbricht, founder of the anonymous online drug marketplace Silk Road. Ross, who was convicted of distributing narcotics and related money laundering, ran a website that helped facilitate hundreds of millions of dollars of illicit drug transactions. Did this pardon make the country safer?

 ANSWER: Please see my response to question 16b.
 - d. The Trump Justice Department has argued that a pardon of a January 6 defendant extends to evidence of his drug trafficking. Do you agree with this argument?

 ANSWER: Please see my response to question 16b.

17. You previously attacked then-Senate Leader McConnell, arguing that "Mitch McConnell and the gang are just going to sit back and do mothering as our nation faces one of the most significant crisis [sic] in modern Political history...It's shameful our leadership is out to lunch. Or maybe their inaction is exposing exactly how they feel about President Trump."

Do you stand by your criticism of Senator McConnell?

ANSWER: I do not recall when this statement was made or the context behind it. Like most Americans I sometimes express frustration with the pace of Congress.

18. In 2023, you claimed that "Republican lawmakers appear to care more about themselves and fighting over power than the American people."

Do you stand by this statement?

ANSWER: Please see my response to question 17.

19. Have you ever attacked Republican members of Congress as "sell-outs" who deserve a primary challenge?

ANSWER: Please see my response to question 17.

- 20. According to a bipartisan report from the House Ethics Committee, there was "substantial evidence" that former Rep. Matt Gatez had broken both internal rules and laws along with "other standards of conduct prohibiting prostitution, statutory rape, illicit drug use, acceptance of impermissible gifts, the provision of special favors and privileges, and obstruction of Congress." In 2020, you hosted him on an episode of "The Sara Carter Show."
 - a. Why did you claim that the investigations of former Rep. Matt Gaetz were politically motivated, and that people were going after him because he was "over the target"?

ANSWER: Like many Americans, I was concerned with the weaponization of law enforcement agencies during the Biden Administration. The House Ethics Committee report you reference was released earlier this year while the podcast in question took place in 2020.

- b. Do you accept the findings of the House Ethics Committee report? **ANSWER**: I have not read the Committee's report.
- 21. According to reports, you were generally prohibited from appearing on news shows on *Fox News* and instead were limited to the entertainment and opinion side of the network.
 - a. Did anyone at *Fox News* ever communicate this to you directly? If so, what did they say?

ANSWER: This is false as evidenced by my continued contract renewals.

b. Please estimate what percentage of your appearances on *Fox News* were on news shows, rather than opinion or entertainment shows.

ANSWER: The majority of my time on Fox News was spent reporting news.

Sean Hannity was reportedly told not to refer to you as an "investigative journalist" because your reporting was not vetted or verified to be meet the network's editorial standards.

c. Was this communicated to you by Mr. Hannity or anyone else at *Fox News*? **ANSWER:** This is false and Sean Hannity was never told to do that - this false story came out when I was aggressively covering the Russia hoax as an attempt to discredit my investigations. As we have seen, my reporting on the Russia hoax was proven correct.

A *Fox News* staffer stated that, "on the news side, we don't take really anything Carter 'reports' seriously."

d. Were you aware of the concerns that some at *Fox News* held over the reliability and independence of your reporting?

ANSWER: No.

22. Have you ever published someone else's reporting or writing without attribution on your website?

ANSWER: Not to my knowledge and I have never been sued for plagiarism.

- 23. Have you ever published someone else's reporting or writing without attribution on the websites of any of your employers, including *Fox News* and *The Washington Examiner*? **ANSWER:** Please see my response to question 22.
- 24. Have you ever been asked to give a public or private apology for errors in your reporting? **ANSWER:** No.
- 25. Please describe the role that cryptocurrency plays in allowing drug traffickers and cartels to sell their illicit narcotics and launder the proceeds and provide your thoughts on how to crack down on this practice.

ANSWER: Cryptocurrency is being used by TCOs to move money quickly and secretly, especially on the DarkWeb which deals primarily in cryptocurrency. Cartels use cryptocurrency to hide the money's trail and avoid traditional banking. If confirmed, I will work with the interagency to target and dismantle the financial networks that support drug traffickers. Our strategy will recognize that every drug interdiction has a corresponding financial transaction and require that seizures be exploited to generate financial intelligence. We will also continue to levy and enforce sanctions against these criminal networks – up and down the drug supply chain.

- 26. You previously stated that the "FBI's surveillance tool [was] misused on Jan. 6 suspects."
 - a. What did you mean by this? ANSWER: Like many Americans, I was concerned that the FBI and Justice Department's resources were being diverted to arrest non-violent individuals who were then being excessively charged and sentenced to long prison sentences for non-violent crimes.

- b. Do you stand by your previous calls to "defund the bureau"? **ANSWER:** No, under Director Patel and Attorney General Bondi's leadership the FBI is returning to its core mission of going after criminals.
- 27. On January 5, 2021, you stated that "the pressure is now on @VP Mike Pence."
 - a. What did you mean by this?

 ANSWER: Like many Americans, I had concerns about certain irregularities with the 2020 election.
- 28. You tweeted after the 2020 election: "Trump's attorneys battle for 'legitimate votes' as concern mounts over Dominion Voting Systems & Smartmatic...Based on the affidavits given to [Trump election lawyer Sidney] Powell and concern over the election system's integrity there needs [sic] to be investigations."
 - a. Your former employer *Fox News* was sued by Dominion Voting Systems and paid a \$787 million settlement over defamation regarding their election machines. Do you still have concerns about Dominion and Smartmatic's voting machines?

 ANSWER: Like many Americans, I had concerns about certain irregularities with the 2020 election.
 - b. Do you still believe that the election was not decided by legitimate votes? **ANSWER:** Please see my response to question 28a.
- 29. You are a featured curator for the Madison Media Fund, a financial supporter and promoter of "freedom focused filmmakers." Films supported by the fund include *The Eastman Dilemma: Lawfare of Justice* (which premiered on January 6, 2025, at Mara-Lago), and fellow curators include Candace Owens, Tucker Carlson, and *In Defense of Internment* author Michelle Malkin.
 - a. Please describe how you were selected as a curator and your responsibilities in the role.
 - **ANSWER:** I was unaware that I had been selected as a curator. According to their own website, they state, "We included Sara Carter as a Madison Media Fund curator because of her established presence..." I was not involved or aware of that decision and I had no role or responsibilities with this organization.
 - b. Do you currently receive or have you in the past received any compensation from the Fund?

ANSWER: No.

- 30. In 2024, you sat on the board of directors of Border911, an anti-immigration nonprofit. The founder of the group is Tom Homan, who now serves as President Trump's "border czar."
 - a. Describe your role and responsibilities during your time with Border911.

ANSWER: I was not on the board of director I was a speaker for Border911

b. Were you involved in the group's fundraiser at Mar-a-Lago, which featured Donald Trump?

ANSWER: Yes.

c. Legal experts argued that the organization was breaking the law by explicitly supporting a political figure, Donald Trump, despite nonprofits being prohibited from doing so. Were you aware that the organization may have been violating federal law?

ANSWER: No federal laws were violated.

- a. What did you understand it to mean that your article "got Q'd"? **ANSWER:** I do not know what it means to be "Q'd".
- b. Why did you retweet this post?

 ANSWER: I retweeted a reply to my tweet because it said "great job".

The slogan WWG1WGA, which stands for "where we go one, we go all" is used by the QAnon conspiracy theory community. This community believes that the government is controlled by a cabal of Jewish, Satan-worshipping pedophiles and cannibals who are working to undermine President Trump.

- c. Have you ever considered yourself to be a part of the QAnon community? **ANSWER:** No.
- d. Do you denounce the QAnon conspiracy theory?
 - i. If yes, then why did you retweet a QAnon hashtag?

ANSWER: Please see my response to question 31b.

ii. If not, why not?

ANSWER: Please see my response to question 31b.

32. Is there currently a presidentially appointed Deputy Director for the Office of National Drug Control Policy?

ANSWER: No.

a. If not: Given your lack of law enforcement, public health, or medical experience, will you commit, if confirmed, to ensuring the appointment of someone with experience in those fields?

ANSWER: It would be inappropriate for me to comment on specific hiring decisions. However, I am committed to hiring the qualified individuals.

- 33. On an episode of your podcast featuring Rudy Giuliani, you stated that you were in Washington, D.C. on January 6, 2021.
 - a. Did you attend President Trump's speech on the Ellipse? **ANSWER:** No.
 - b. Were you on Capitol grounds that day? **ANSWER:** No.
 - c. Were you the Capitol or any buildings in the Capitol complex that day? **ANSWER:** No.

QUESTIONS FROM SENATOR BLACKBURN

- 1. ONDCP is responsible for anti-doping efforts in sport and has specific jurisdiction over the payment of United States dues to the World Anti-Doping Agency (WADA). Over a year ago, WADA betrayed its mission by allowing twenty-three Chinese swimmers to unfairly beat American swimmers event though it knew that they were doping. When the United States opened an investigation into this incident, WADA did not cooperate. Instead, it stonewalled and attempted to intimidate and strongarm the United States. The United States rightfully withheld its 2024 dues to WADA because WADA failed to protect American athletes and have never implemented meaningful governance reforms.
 - a. As ONDCP Director, will you take a strong stance against WADA and any other organization that attempts to intimidate the United States and fail to protect Americans?
 - **ANSWER:** Yes, if confirmed, I will be a strong advocate for fair competition and clean sports on behalf of American athletes, especially against the failed practices of WADA.
 - b. Will you commit to withholding U.S. dues to WADA if they continue to cover up credible doping allegations and fail to implement meaningful governance reforms?
 - **ANSWER:** Yes, if confirmed, I commit to leveraging any tools available to hold WADA accountable to our athletes.

 - a. If confirmed, will you work with us to quickly reauthorize ONDCP?

ANSWER:. I will always work with Congress on initiatives to improve the health and lives of the American public.

b. Do you support keeping HIDTA within ONDCP?

ANSWER: As I stated at my hearing, I support the President's budget and I am dedicated to ensuring the success of HIDTA regardless of where the program ultimately ends up.

c. If you are confirmed, will ONDCP continue to prioritize expanding access to and use of medication-assisted treatment?

ANSWER: Yes.

- 2. Certified Community Behavioral Health Clinics (CCBHCs) are a federal model for offering comprehensive and accessible substance use disorder and mental health services, including outpatient treatment, crisis care, and peer support.
 - a. If confirmed, how will you work with CCBHCs in states like Rhode Island to improve recovery outcomes and reduce the rate of overdoses for youths and adults?

ANSWER: CCBHCs have served over 2 million people and have resulted in decreases in emergency department visits and hospitalizations. As Director, I would welcome the opportunity to work with CCBHCs in Rhode Island, and elsewhere around the country, to ensure they have the resources they need to better serve the needs of their communities.

Senate Judiciary Committee Nomination Hearing September 17, 2025 Questions for the Record Senator Amy Klobuchar

For Sara Carter, to be Director of the Office of National Drug Control Policy

1. One of my top priorities is ONDCP's High Intensity Drug Trafficking (HIDTA) Program. The resources and support that HIDTA provides its partners in law enforcement have proven invaluable. For example, the North Central HIDTA program—which includes Minnesota and Wisconsin—was responsible for seizing over 2.2 million fentanyl pills; 1,700 kilograms of meth; nearly 475 kilograms of cocaine; and more than 1,500 crime guns.

That's why I am concerned when the Administration proposed cutting \$102 million — or more than one-third of the HIDTA budget. The bills that have been reported out of the Appropriations Committee did not adopt the administration's request to slash HIDTA funding.

- If confirmed as ONDCP Director, do we have your commitment that ONDCP will utilize all of the funds Congress appropriates to support law enforcement?

 ANSWER: Yes.
- 2. I have heard from numerous law enforcement officials, both in Minnesota and nationally, who are concerned about reports that the Administration is considering moving HIDTA out of ONDCP and into the Justice Department.
 - Congress specifically placed HIDTA within ONDCP by statute. Do you agree that absent direct authorization from Congress, it cannot be moved to the Justice Department?

 ANSWER: That is my understanding, however, I am not an attorney and cannot give a definitive legal answer.
- 3. I am very concerned about the prevalence of illegal drugs in our communities—especially when it comes to fentanyl, which is having particularly deadly consequences. The latest data from the Minnesota Department of Health indicates that synthetic opioids like fentanyl were involved in 70 percent of all overdose deaths in my state.
 - What do you see as the ONDCP's role in addressing the opioid epidemic, particularly as it relates to synthetic opioids?
 - **ANSWER:** If confirmed as Director, I will use ONDCP's statutory authorities to develop policies and budgetary guidance and coordinate across Federal and state government to take the decisive action needed to stop the flow of dangerous drugs into our communities and reducing drug use in the country.

Offering treatment and opportunities for change is a worthwhile investment for people who break the law because of their addiction.

- 11. The Department of Justice FY 2026 budget request also contains a 34 percent budget cut to the HIDTA program. I am concerned, as are many law enforcement agencies and associations, that this cut would make it harder for law enforcement to fight drug activity and ensure public safety—including in places like New Castle County in Delaware, which is part of the Philadelphia/Camden HIDTA.
 - a. Do you support this cut?

ANSWER: As mentioned during my hearing, I support the President's budget. The HIDTA Program is critical to drug enforcement efforts nationwide, and I applaud the Liberty Mid-Atlantic HIDTA for its successes in disrupting and dismantling drug trafficking organizations throughout the region. I recognize that federal funding is imperative to programs such as HIDTA and I am a strong advocate for law enforcement.

b. At your Senate Judiciary Committee hearing, you told Ranking Member Durbin that the *One Big Beautiful Bill Act* supplements this funding. What code provision in the *One Big Beautiful Act* were you referencing in your response to Ranking Member Durbin?

ANSWER: SEC. 100051 (7) Appropriation for the Department of Homeland Security, which provides funding to support state and local participation in homeland security efforts.

- 12. On August 27, 2024, you wrote a post on X about interviewing a prisoner at CECOT, the maximum-security prison in El Salvador. You wrote that "El Salvador under [President Nayib Bukele] is a reflection of what can be for all of us if we fight against corruption and evil. [The prisoner] was once a child with hopes and dreams he was recruited into MS13 at the age of 15 he will now spend the rest of his life in prison under terrorism laws implemented by Bukele. Those laws have put thousands in prison but more importantly those laws are saving future generations."
 - a. Do you support opening a prison like CECOT in the United States?
 ANSWER: I support the President's mission to make America safe again and would consult with DHS and DOJ with respect to safe and effective prison systems.

- b. In April, the Trump administration cut \$88 million in DOJ grants focused on addressing substance use and mental health disorders. - 7. In your confirmation hearing, Ranking Member Durbin asked you about firearms from the United States being used by the Mexican cartels. Under oath and in response to his question, you stated that "we have significantly reduced the flow [of firearms] going

south as well as coming north." You also promised Ranking Member Durbin that you would produce evidence of this in writing.

- a. In the data you used to answer that question, what was the number of weapons being transported from the United States to Mexico in the last reporting period fully covering the Biden administration's time in office?
 ANSWER: In calendar year 2024, CBP seized 811 weapons at the southwest board being transported from the United States to Mexico.
- b. In the data you used to answer that question, what was the number of weapons being transported from Mexico to the United States in the last reporting period fully covering the Biden administration's time in office?
 ANSWER: In calendar year 2024, CBP seized 200 weapons at the southwest board being transported from Mexico to the United States.
- c. In the data you used to answer that question, what are the number of weapons being transported from the United States to Mexico in all of the reporting periods covering the Trump administration's time in office?
 ANSWER: Since February 2025, CBP has seized 298 weapons being transported from the United States to Mexico.
- d. In the data you used to answer that question, what are the number of weapons being transported from Mexico to the United States in all of the reporting periods covering the Trump administration's time in office?
 ANSWER: Since February 2025, CBP has seized 56 weapons being transported from Mexico to the United States. In the same time period, ATF had possession of 2 additional weapons intended for transportation from Mexico to the United States.

Nomination of Sara Carter be Director of the Office of National Drug Control Policy (ONDCP) Questions for the Record Submitted September 24, 2025

QUESTIONS FROM SENATOR CORY A. BOOKER

- 1. During the hearing on your nomination to be Director of the Office of National Drug Control Policy (ONDCP), we discussed the pending cannabis rescheduling process. As you are aware, under the Controlled Substances Act (CSA), the rescheduling process begins when the Department of Health and Human Services (HHS) conducts a scientific evaluation and makes a recommendation to the Drug Enforcement Administration (DEA). Throughout the existence of the CSA's rescheduling process, DEA has never rejected a recommendation by HHS to reschedule a substance.
 - a. Who do you believe is better suited to conduct the scientific and medical evaluations of drugs: prosecutors or scientists and doctors?

ANSWER: As stated at the hearing, if confirmed I will work with all relevant interagency stakeholders to ensure an examination of all facts and evidence. Under the CSA, scientists and doctors use a comprehensive approach in balancing potential risks and benefits of any substance, and the HHS Secretary provides a recommendation to the Attorney General.

b. If you are confirmed, would you assign more weight to a scheduling recommendation from HHS based on its scientific and medical evaluation of a drug rather than DEA's opinion?

ANSWER: As stated at the hearing, I support the process under the CSA, and if confirmed I will work with all relevant interagency stakeholders to ensure an examination of all facts and evidence.

- 2. Provide yes or no responses to following questions:
 - a. If you are confirmed, will you support additional federal funding for overdose prevention centers?

ANSWER: No, I support preventing overdoses and all harms caused by drugs. Each overdose save is an opportunity to connect a person to treatment and give them hope. I also fully support the President's executive orders.

- Should fentanyl test strips be legal and federally funded nationwide?
 ANSWER: Fentanyl test strips are one tool in overall overdose prevention efforts, and they should be considered legal and not drug paraphernalia.
- c. Should every emergency room in America be required to have naloxone and offer medication-assisted treatment?

ANSWER: Yes, every emergency department in the United States has access to naloxone and MAT.

d. Should extreme sentences for low-level fentanyl possession or distribution be eligible for clemency?

ANSWER: The Constitution vests the pardon authority solely on the President of the United States. As a current government employee, it would be inappropriate for me to comment on the President's pardon decisions.

- e. Do you believe the "War on Drugs" approach has failed to reduce overdose deaths? **ANSWER:** Our approach will be balanced: preventing the production of illicit drugs overseas and their movement across our borders and into our communities; holding accountable those who traffic in illicit drugs and their raw materials, as well as those who facilitate the illicit drug trade; preventing drug use before it starts; saving the lives of those who overdose; and providing access to evidence-based treatment leading to long-term recovery for everyone who needs it.
- f. If you are confirmed, do you commit to treating the fentanyl overdose crisis primarily as a public health crisis and not only a criminal justice issue?
 ANSWER: If confirmed, I will work to advance as the full range of actions to reduce the demand for these drugs in America, and work equally hard to support the law enforcement community in countering transnational criminal organizations and stopping the flow of dangerous drugs into our country and our communities.
- g. If you are confirmed, will your leadership include treating fentanyl policies as justification for harsher domestic immigration enforcement?

 ANSWER: No.
- h. Do you believe increased criminal penalties adequately deter people struggling with addiction from using drugs?
 ANSWER: No. Deterrence and incentives are both important motivators in changing the behavior of drug use.
- 3. If you are confirmed, how do you plan to shift federal drug policy from a punitive law-enforcement model to a public health-centered model in order to address fentanyl overdoses?
 - **ANSWER:** People with a substance use disorder warrant compassionate care. Those who have been convicted of harming others, and profiting from those with substance use disorder must face the appropriate consequences. Offering treatment and opportunities for change is a worthwhile investment for people who break the law because of their addiction.
- 4. Given the failures of past "War on Drugs" crackdowns, if you are confirmed, how will your approach explicitly avoid repeating policies that increased incarceration without reducing overdose deaths?
 - **ANSWER:** If confirmed, I commit to saving lives and protecting America in every way possible as the Director of National Drug Control Policy. I will support the President's drug policy priorities, and take the decisive actions needed to stop the flow of dangerous drugs into our communities. That involves countering the foreign terrorist organizations

who traffic in illicit drugs, disrupting the global illicit supply chain, and holding accountable the countries that are sources of precursor chemicals and finished drugs that enter into the United States. At the same time, I will work to build a drug free America as the social norm and increase the availability of treatment that leads to long-term recovery at all parts of the continuum of the disease.

5. In April 2025, ONDCP released the Trump Administration's Drug Policy Priorities, "a comprehensive and coordinated blueprint to reduce the devastating impact of illicit drugs on American society." The Statement of Drug Policy Priorities identifies a number of priorities that guide the Trump Administration's development of drug control strategy.²

Policy Priority 1 is to "Reduce the Number of Overdose Fatalities, with a Focus on Fentanyl" and includes encouraging "state and local efforts facilitating law-enforcement-assisted diversion to connect people who use drugs with supportive services that divert them from incarceration and reduce recidivism" as well as "encourage[ing] state and local jurisdictions to increase the availability of drug test strips and naloxone to mitigate the impact of deadly drugs on communities across the country."

a. What is ONDCP's role in supporting diversion of people who use drugs away from incarceration?

ANSWER: ONDCP supports a compassionate and balanced approach for people facing incarceration because of drugs. This cohort population is best suited to connection with evidence-based treatment and motivation to change while facing accountability for their actions.

- b. What is ONDCP's role in increasing the availability of drug test strips and naloxone? **ANSWER:** ONDCP supports policies for naloxone availability and distribution. Fentanyl test strips are one tool that should be legally available to test for fentanyl adulterated into other drugs.
- c. If you are confirmed, will ONDCP support legislation that expands federal funding to states and tribes to purchase drug checking strips?
 ANSWER: ONDCP supports community drug checking that connects people with treatment opportunities and provides near real time public data.
- d. Now more than ever, it is critical to ensure that those working directly with people who use drugs or are in recovery have access to naloxone. If you are confirmed, what would be your role in guiding the Trump Administration's strategy to ensure naloxone is directed to trusted community and health organizations working with those at highest risk?

ANSWER: If confirmed, I will work on policies that ensure the access of naloxone.

Policy Priority 5 is to "Provide Treatment That Leads to Long-Term Recovery" and includes "expanding access to medications for opioid use disorder (MOUD) and improving integration of mental health treatment with clinical and recovery support services."

- e. What is ONDCP's role in expanding access to medications for opioid use disorder? **ANSWER:** ONDCP will work to expand access to all the FDA-approved MOUD, and encourage their use not only in opioid treatment programs, but in primary care settings.
- f. If you are confirmed, how will ONDCP work with other federal agencies, such as the Food and Drug Administration and the Substance Abuse and Mental Health Services Administration to expand access to medications for opioid use disorder?
 ANSWER: If I am confirmed, ONDCP will work with HHS, FDA, SAMHSA and all federal partners to expand treatment of addiction throughout all stages of the disease and by using all available tools, including MOUD.
- g. If you are confirmed, what efforts will ONDCP undertake to expand access to medications for opioid use disorder?
 ANSWER: If I am confirmed, ONDCP will work on policy to expand access to all the FDA-approved MOUD, and encourages their use not only in opioid treatment programs, but in the primary care settings.
 Policy Priority 6 is to "Innovate in Research and Data to Support Drug Control Strategies" and includes prioritizing "the continuous collection and analysis of

accurate, timely, and relevant data to inform policy."

ANSWER: ONDCP's Office of Public Health is supported by a Chief Medical Officer board certified in emergency medicine and addiction medicine as well as a team of policy, public health, and pharmacy expertise. The public health office, as all our offices, work collaboratively with all ONDCP components and the interagency.

i. If you are confirmed, how will you improve the capacity of ONDCP's Office of Translational Research?

ANSWER: ONDCP's Office of Translational Research is supported with a strong staff with research, data, epidemiology and statistics expertise. The Translational Research office works collaboratively with ONDCP components and the interagency to continue improving the data and research infrastructures needed to inform drug control policy.

Senator Peter Welch Senate Judiciary Committee Written Questions for Sara Carter Bailey Hearing on "Nominations" Wednesday, September 17, 2025

1. If you are confirmed, you would supervise the High Intensity Drug Trafficking Area — also called HIDTA — programs that are overseen by the Office of National Drug Control Policy and have been utilized throughout the country, since their creation in 1988.

The New England HIDTA program has done great work in my state of Vermont since it was designated in 1999. I have serious concerns about the Trump Administration's proposal to move HIDTA from your office to the Department of Justice.

- a. Will you commit to ensuring that HIDTA is able to continue its work within the Office of National Drug Control Policy?
 ANSWER: As I stated at my hearing, I support the President's budget and I am dedicated to ensuring the success of HIDTA regardless of where the program ultimately ends up.
- 2. Four days after we met to discuss your nomination prior to your confirmation hearing, on September 7, you reposted a tweet by Stephen Miller. In it, he said "The Democratic Party at every level—judges, politicians, academics, nonprofits—is organized around the defense and protection of the criminal, the monstrous, and the depraved. The more vile the threat, the more vociferously the Democrat Party works to protect and enable it."

You added your own statement to Mr. Miller, writing "Facts" with an emoji pointing a finger at the text of the tweet.

- a. For the record, can you clarify whether you agree with Stephen Miller's tweet? **ANSWER:** Mr. Miller's tweet was in reference to the murder of a young Ukrainian refugee on a train in North Carolina at the hands of a violent repeat offender with over 14 prior arrests. The shocking video of this violent attack was widely distributed and Americans rightly questioned why this violent offender was released.
- 3. On your podcast *The Sara Carter Show*, you said on September 30, 2024, that Democratic Party is "an extreme radical party that is literally trying to rob our nation of its freedom, rob you of its freedom, rob our nation of its constitution." You added that Democrats are "monsters, swamp creatures, liars, charlatans."

- a. For the record, do you believe Democrats are "monsters?"

 ANSWER: Those statements were made in the lead up to what I consider was one of the most consequential Presidential elections of my lifetime Those statements were directed at the national ticket of the Democratic party at the time and does not reflect how I feel about all Democrats.
- b. Do you believe Democrats are "swamp creatures?" **ANSWER:** Please see answer to question 3a.
- c. Do you believe Democrats are all "liars?" **ANSWER:** Please see answer to question 3a.
- d. Do you believe Democrats are "charlatans?" **ANSWER:** Please see answer to question 3a.
- e. Do you believe it was ever appropriate to make these comments or share them with your followers? Please explain.

ANSWER: Please see answer to question 3a.

4. If confirmed as Director of the ONDCP, how would you balance the need for patient access to treatment via telehealth while also leveraging existing infrastructure and technology to help ensure that controlled substances prescribed via telehealth are not misused or diverted, for instance, through the use of interstate prescription drug monitoring queries?

ANSWER: Telehealth brings several important benefits to patients, providers, and the health system overall. If confirmed as Director, I will work to minimize drug diversion and misuse by the continued use of Prescription Drug Monitoring (PDMP) systems, interstate queries on prescription histories, and safe prescribing and dispensing practices.
