Whether hearing big controversies or small cases, she brings the same strong work ethic, attention to detail, and well-reasoned decisiveness. She is efficient, productive, and collaborates exceptionally well with staff, court stakeholders, and the public. Combined with her steady judicial temperament, Judge Wise has been the obvious choice for some of the most challenging responsibilities on our court. She has been selected to serve as a supervising judge, to lead our appellate division, and to lead our complex civil law departments.
