Tyrone Jackson was convicted of possessing more than five grams of crack cocaine after a prior felony drug conviction. He was subject to a mandatory minimum sentence of five years. But since he cooperated, the United States filed a motion under 18 U.S.C. § 3553(e) and U.S.S.G. § 5K1.1 to permit relief from the mandatory minimum. The court reduced the defendant's sentence from 120 months to 90 months. Subsequently, the Sentencing Commission reduced the base offense level for crack in Amendment 706 and made the amendment retroactive. Pursuant to the amendment, the defendant moved to reduce his sentence, but the motion was denied. He appealed the order. An appellate panel denied his appeal. The defendant then filed a petition for panel rehearing and for rehearing *en banc*, and the Federal Defenders of San Diego filed an amicus brief in support of his petition. The panel denied the petition for rehearing and no judge requested a vote on *en banc* rehearing. I opposed the request for rehearing and rehearing *en banc* as sole counsel on behalf of the United States.

Thomas James O'Neill was indicted in 2004 on ten counts of wire fraud and ten

counts of securities fraud related to unauthorized and unsuitable trades in multiple clients' accounts resulting in losses of over \$300,000. The defendant pleaded guilty on the eve of trial to one count of wire fraud and one count of securities fraud. After a lengthy sentencing hearing to determine whether to apply sentencing guideline enhancements for: loss; violation of a prior, specific administrative order, injunction, decree or process; vulnerable victim; and abuse of a position of trust; the defendant was sentenced to 24 months. On appeal, the court of appeals affirmed the sentence. In 2009, the defendant filed a motion under 28 U.S.C. § 1331 contending for the first time that he could not be required to pay restitution to his employer, Piper Jaffray and Company. The district court denied the motion. The defendant appealed and the court of appeals affirmed. From 1992 to 1994, as a law clerk for the Honorable Charles C. Lovell, U.S. District Court for the District of Montana, I conducted legal research and helped the judge prepare his opinion and order in *Printz, Sheriff/Coroner, Ravalli County, Montana v. United States*, 854 F. Supp. 1503 (D. Mont. 1994), *rev'd*, 66 F.3d 1025 (9<sup>th</sup> Cir. 1995); *rev'd*, 521 U.S. 898, 907 (1997), in which the judge enjoined a portion of the Brady Law requiring state and local law enforcement, without federal funding, to carry out background checks on prospective gun buyers on Tenth Amendment grounds. His ruling was ultimately affirmed by the Supreme Court.

From 1994 to 2000, I was an associate and then partner with the law firm of Crowley, Haughey, Hanson, Toole & Dietrich, PLLP. I successfully tried a felony custodial interference case for the Yellowstone County Attorney's Office in state district court. In addition, I represented the Yellowstone County Guardianship Council in a state district court proceeding to finally remove life support from an unconscious, elderly woman, for whom the Council had become guardian. As a senior associate, for two years I supervised the summer associate program for the firm.

From 2001 to 2003, I was the Director of the Montana Department of Revenue. This was the period of time immediately following the deregulation of electric and natural gas utilities in Montana. Utility and energy companies were restructuring and/or reducing their statewide geographical presence causing significant legal issues regarding whether companies' property was locally or centrally assessed for property tax purposes. The possibility of moving from central to local assessment caused significant funding concerns for local governments. I helped develop and ultimately approved the major policy and litigation positions for the Department related to property taxation of centrally assessed property. In addition, I led the state delegation which renegotiated the state's tax revenue sharing agreement with the Blackfeet Nation. I appeared before the Montana legislature on behalf of the Department and the Administration.

From 2003 to 2010, I served as an Assistant U.S. Attorney. In addition to my case work, I started and led the first Suspicious Activity Report review team for the district and represented the office at Yellowstone Bank Security Officer meetings. As First Assistant, I helped oversee criminal prosecutions, civil litigation and oversaw appeals. I wrote 23 appeal briefs, a petition for rehearing en banc and a response to a petition for rehearing and rehearing en banc, and I argued ten cases on appeal. I participated in a death penalty review of a capital case. I also oversaw anti-terrorism activities including the district's Anti-Terrorism Advisory Council, and the office's participation in the Joint Terrorism Task Force and the Montana All Threat Intelligence Center. I created the district's first Executive Committee of the Law Enforcement Coordinating Committee composed of federal, state, local and tribal law enforcement leaders from across the state. The Committee identified key law enforcement priorities, shared information and strategies to address them, and provided for training on those priorities and strategies.

In 2012 and 2013, I was one of four section leaders of the Montana Bar committee reviewing, revising and testifying for the Uniform Trust Code before the Montana legislature, which was adopted. In 2013, I was a leader of a group of attorneys and Montana charities successfully recommending amendments to the Montana Endowment Tax Credit and advocating for its renewal before the Montana legislature. I also coordinated a charitable response to a state district court ruling which had ordered the liquidation and distribution of a charitable endowment to another charity. The response included the Montana Attorney General and the Montana Nonprofit Association filing briefs successfully arguing for reversal of the district court.

From 2017 to 2020, I served as U.S Attorney. During my tenure, I focused on reducing meth-related violent crime, opioid overdose deaths, and crime on our Native American Reservations. I led the launch of Project Safe Neighborhoods in partnership with federal, state and local law enforcement agencies to combat increasing meth-related violent crime, by prioritizing federal prosecutions of meth traffickers, armed robbers and violent felons with firearms. To address both meth-related violent crime and opioid overdoses, together with the Montana Attorney General and the Montana County Attorney's Association, I led the start of the Montana Prosecuting Attorney's Drug Enforcement Coordinating Committee to coordinate drug enforcement activities by all law enforcement in Montana, and share information on drug trends and training. To reduce

opioid overdoses from pill diversion by health care workers, pharmacies and others with access to opioids, I led the start of a statewide healthcare fraud task force. I also served as Vice-Chair of the Native American Issues Subcommittee of the Attorney General's Advisory Committee where I prioritized communication and public safety issues with Montana's tribal governments. I organized more than 20 meetings in Indian country with tribal leaders to address public safety, drug trafficking and abuse, missing and murdered indigenous persons, and victim services. A dedicated Assistant U.S. Attorney met monthly with multidisciplinary teams on the reservations to ensure child abuse, rape and domestic violence cases were prosecuted and victims received help.

My seven years with the Yellowstone Boys and Girls Ranch Foundation were devoted to helping mentally ill, abused and neglected, addicted and poor children. In these roles and since, I have also given many presentations on issues of public interest.

The Yellowstone County Guardianship Council was created under the Mental Health Association to serve as guardian of indigent, incapacitated people in Yellowstone County who have no one else to fulfill that role. From 1997 to 2000, I represented the Council in state district court proceedings to establish guardianships and to take certain actions related to the wards. For this service, I was recognized as the 2000 Mental Health Association Honoree for Outstanding Service in Field of Mental Health.

I have served on several State Bar of Montana sections on which I performed uncompensated tasks such as reviewing proposed legislation, revising committee governance documents, presenting continuing legal education courses, and participating in committee business meetings. In 2012 and 2013, I donated many hours as one of four section leaders of the Bar committee reviewing, revising and testifying for the Uniform Trust Code before the Montana legislature. In 1997 and 1998, I also donated many hours working with members of the Governor's Task Force on Endowed Philanthropy, other attorneys and a charity to propose substantial comments to the Montana Department of Revenue's proposed rules implementing the Montana endowment tax credit. I also assisted with subsequent rulemaking, and statutory reauthorizations and amendments related to that law.

Finally, I have donated many hours of time as a board member and direct service volunteer to numerous community and state-wide charitable and public service organizations. Legal and law enforcement organizations for which I have volunteered include, the Montana Attorney General's Intelligence Advisory Board, the University of Montana Law School – Tax Institute Advisory Board, and the Montana State University Billings – Law and Justice Advisory Committee. I have also graded bar exams, helped judge the moot court team at the University of Montana Law School, and guest lectured on federal criminal law at Montana State University Billings. In addition, I have also donated many hours presenting to charitable organizations and directly assisting them with their legal and tax issues.
