Most of my career has been in public service. My start in government began while I was in law school, when I interned in the Office of the Judge Advocate General at Scott Air Force Base. There I had the opportunity to work with Air Force officers and enlisted personnel in a variety of capacities, from providing basic legal advice to Air Force personnel, to handling legal matters affecting Scott AFB, to seeing the legal and policy work that Air Force Officers handled at Air Mobility Command and U.S. Transportation Command. Those experiences helped guide me toward my legal career path in public service.

In 2004, when I first came to Washington, I began as a legal intern at the U.S. Department of Commerce, in the Commerce Secretary's policy and strategic planning office. In the spring of 2005, I joined the Administration of President George W. Bush as a schedule C appointee at the U.S. Patent and Trademark Office (USPTO). There I worked on both international and domestic intellectual property matters, including trade issues and learning about the overall operations of the USPTO. Later that year, I was asked to return to the Commerce Secretary's office to handle intellectual property and trade issues, and help setup the Administration's Intellectual Property Coordination efforts. There I helped develop U.S. trade enforcement strategies with emerging markets to promote increased market access for U.S. industry, led inter-agency initiatives, outreach with the private sector and participated in bilateral and multilateral negotiations with our international trading partners.

In late 2006, I joined the White House, where I served in a variety of roles in the Office of Presidential Speechwriting, Office of Public Liaison, and the Domestic Policy Council (DPC). At the White House, I continued working on economic and trade issues, including intellectual property law & policy.

Following my time in the Bush Administration, I worked at the Republican National Committee, and then the U.S. House of Representatives, Committee on the Judiciary. On House Judiciary, I continue to serve as a Senior Counsel to the Chairman and the Committee, handling a range of legislative and oversight issues dealing with intellectual property, international trade, technology, cybersecurity, and competition.

During my tenure on the House Judiciary committee, I have worked on a number of initiatives, including organizing trade enforcement oversight hearings, focused on intellectual property enforcement, trade secret theft, digital trade, non-tariff trade barriers and market access for American manufacturers and innovators. Throughout most of my tenure on House Judiciary, the work has been on a bicameral and bipartisan basis to advance policy in both the domestic and international arena, to promote American innovation and economic growth.
