On August 31, 2011, I was appointed by then-Governor Rick Scott to the position of Circuit Court Judge. On May 2, 2014, I was retained through the elections process, unopposed, to a six-year term ending January 3, 2021.

My court handles felony-level criminal cases, civil lawsuits with amounts in controversy over \$15,000, and certain appeals from the County Court. It also has jurisdiction over dependency, family, juvenile, and probate cases. My division assignments have dictated the kinds of cases that I have handled. Thus far, I have been assigned to the Criminal and Civil divisions, and I have also presided over the felony mental health division. In 2013, I presided over the Broward County Grand Jury for the Spring term. In October 2018, I was assigned to handle all Broward County Risk Protection Order (RPO) matters.

In addition to my trial court duties, I was assigned to the initial Criminal Appellate Division in 2015 and the Civil Appellate Division in 2017 and 2019. These divisions hear all direct appeals from the County Court, all administrative appeals, and extraordinary writs with original jurisdiction in the Circuit Court. The appellate panels consist of three circuit judges who, in addition to their trial division work, hear appeals on a six-month rotation.

In 2013, 2014, 2017, and 2019, I served by invitation as an Associate Judge on the Florida Fourth District Court of Appeal. This court consists of twelve appointed judges who hear appeals from the Circuit Court in three-judge panels. On occasion, trial judges are invited to sit and fill in for appellate judges upon approval by the Chief Justice of the Florida Supreme Court.

Stickney v. State, 263 So. 3d 67 (Fla. 4th DCA 2019). This case was remanded for imposition of written orders indicating why probation was violated.

Howard v. Gualt, 259 So. 3d 119 (Fla. 4th DCA 2018). Default judgment set aside because service by publication under the facts in this case was insufficient to properly notice defendant.

Branch-McKenzie v. Broward Cty. Sch. Bd., 254 So. 3d 1007 (Fla. 4th DCA 2018). Evidence was sufficient to establish a genuine issue of material fact as to one of five counts dismissed at summary judgment. The matter was reversed to proceed on the one count.

Scotsman v. State, 238 So. 3d 300 (Fla. 4th DCA 2018). Defendant confessed to several counts of armed robbery after initially invoking *Miranda*. Appellate court found that despite defendant's later decision to talk to law enforcement, defendant's actions were inconsistent with voluntariness.

Williams v. State, 229 So. 3d 848 (Fla. 4th DCA 2017). Reversed because plea colloquy reflected side bar but no actual acknowledgement by defendant that he understood there were no guarantees his prison sentence would be served in state rather than federal prison.

State v. Telucien, 225 So. 3d 385 (Fla. 4th DCA 2017). I dismissed this case for a violation of the speedy trial rule. The appellate court affirmed my decision in March 2017. In May 2017, the court ruled differently on another case. In August, the court granted the State's motion for reconsideration and reversed. The issue was whether felony charges could lawfully be filed outside the speedy trial time period where the defendant had been granted a timely continuance on the original misdemeanor charge.

Davis v. State, 198 So. 3d 995 (Fla. 4th DCA 2016). Occasionally inmates will abuse process by filing successive, frivolous pleadings once their direct appeals have been exhausted. In certain situations, a sanction is to require that future pleadings be signed by a licensed Florida Bar member. This case was reversed to allow this defendant to file further pleadings.

Atwell v. State, 197 So. 3d 1040 (Fla. 2016). In August 1990, sixteen-year-old Angelo Atwell committed an Armed Robbery and First Degree Murder. Atwell was convicted of the charges and sentenced, in accordance with the then-existing statute to life in prison *with* the possibility of parole after twenty-five years. In 2012, the United States Supreme Court decided *Miller v. Alabama* and held that juvenile offenders could not be sentenced to life *without* parole, unless there was a meaningful future review of their sentence. Accordingly, based upon the plain meaning of the sentencing statute and my conclusion that *Miller* did not apply, I denied Atwell relief. The Fourth District Court of Appeal affirmed my decision. The Florida Supreme Court, in a 5-2 opinion, then reversed the Fourth District Court of Appeal's decision and found that, due to the Florida Parole Commission's procedures, "with parole" was analogous to "without parole," and *Miller* applied. Later, finding its decision unworkable and contrary to newer decisions from the United States Supreme Court, this decision was essentially abrogated in *Michel v. State*. See *Franklin v. State*, 258 So. 3d 1239, 1241 (Fla. 2018) (recognizing abrogation).

Walker v. State, 180 So. 3d 1154 (Fla. 4th DCA 2015). Defendant was stopped by the police, and he asked the officer why he was being detained. The officer told him they needed to discuss an armed robbery. Although no question had been asked, the defendant stated, "I've snatched chains before but I don't own a gun." The police officer had not yet told the defendant that the case involved a gun and a snatched chain. I allowed the statement into evidence. The appellate court reversed, finding the statement more prejudicial than probative.

O'Connor v. State, 133 So. 3d 1065 (Fla. 4th DCA 2014). Remanded for disposition to reflect whether defendant was sentenced as a youthful offender.

Robinson v. State, 117 So. 3d 843 (Fla. 4th DCA 2013). This case bears my name as judge because of a scrivener's error, but it was not my case. For double jeopardy reasons, the misdemeanor conviction and sentence were reversed while the felony conviction and sentence were affirmed.

Many cases are resolved through motion practice, resulting in unpublished orders. In cases in which a motion for summary judgment is heard, for example, I write an opinion setting forth my analysis and reasoning. Those opinions are

electronically stored in the court file of each particular case. In criminal court, motions to suppress evidence are handled in the same manner. Such substantive evidentiary motions are normal in approximately fifty percent of all cases.

Although recusal motions have become much more common in modern state court practice, I have rarely been asked to recuse myself. I have offered to recuse myself on any cases, as they come before me, where I had represented a criminal defendant as a lawyer. This has happened approximately ten times. Upon disclosing the issue to counsel, on the record, the litigants discussed the issue and I was always asked to stay on the case.

In civil court, I have been asked to recuse myself on four occasions:

(1) *Brizuela v. Zuni Transp.*, Circuit Civil case number CACE16-016292.

I granted the plaintiff's request because the defense lawyer had handled personal issues for me, specifically, drafting my will and handling a closing.

(2) *Jallali v. Gaisi*, Circuit Civil case number CACE16-009358.

Here, the plaintiff's counsel moved to disqualify me after an adverse ruling. Before I could rule on the Motion, the Chief Judge for the Seventeenth Judicial Circuit took this case as this plaintiff had previously successfully recused Circuit Judges Stone, Gates, and Levenson.

(3) *Canova v. Snipes*, Circuit Civil case number CACE17-010904.

Following an adverse ruling, defendant filed a legally insufficient recusal motion. In civil cases, unlike criminal, opposing counsel files a response to the motion. I denied the motion. This case was appealed and the appeal was later dismissed.

(4) *Republican Party of Florida v. Snipes*, Circuit Civil case number CACE17-001159.

Following an adverse ruling in the *Canova* case, defendant filed a legally insufficient recusal motion. In civil cases, unlike criminal, opposing counsel files a response to the motion. I denied the motion. This case, like the *Canova* case, was appealed and the appeal was later dismissed.

In civil court, I have entered *sua sponte* orders of recusal in two cases. In each case, the level of professionalism and civility displayed by a lawyer was so low, that I believed any adverse decisions I made could be perceived as biased since I was reporting these lawyers to the Seventeenth Judicial Circuit Professionalism Panel. These cases are as follows:

(1) *Romanow v. Maestres*, Circuit Civil case number CACE16-020968.

Following denial of a defense motion, plaintiff's counsel made a remark to defense counsel. Defense counsel then began to take his jacket off and said he "was ready to throw down" and challenged opposing counsel to a fight in the courtroom. I admonished the lawyers on their lack of civility.

(2) *Desilus v. Kelgard*, Circuit Civil case number CACE15-019582.

I was already the second judge on this case. Plaintiff's counsel had missed the first hearing before me and appeared late for the second hearing. At that time, ninety-three pre-qualified jurors were lined up to enter court for selection in a different case. Counsel's behavior in making argument was remarkably disrespectful, and more importantly, repeatedly cited the law incorrectly. Counsel

refused to listen to court personnel. After several minutes of counsel's behavior, I admonished counsel and entered an order of recusal.

In a legally sufficient Motion to Disqualify, in the State courts of Florida, the judge must accept the allegations as true and, without comment, grant the motion if the litigant reasonably has a fear of bias. In that regard, I have been asked to recuse myself on the following five criminal cases. These cases are as follows:

(1) *State v. Ramirez*, Circuit Criminal case number 12-009673CF10A.

Granted. Having sentenced this defendant to twenty-five years in Florida State Prison on his violation of probation (04-006065CF10A), the defendant began litigating his substantive case. Two years later, at a hearing he moved to disqualify me because I had made a finding regarding his previous case that he was not credible. While I believed his allegation was baseless, taking it as true as required, I granted his Motion.

(2) *State v. Barnes*, Circuit Criminal case number 15-010380CF10A.

Denied as legally insufficient and the subsequent writ was dismissed. Defendant alleged I was unfair despite sworn record testimony where he said I was fair.

(3) *State v. Irons*, Circuit Criminal case number 15-013567CF10A.

Denied as legally insufficient; no appeal was taken. Defendant generally alleged I was unfair.

(4) *State v. Beram*, Circuit Criminal case number 13-002628CF10A.

Granted. Taking defendant's legally sufficient Motion as true, I was compelled to grant the motion, without comment, even though the allegations were false.

(5) *State v. Miller*, Circuit Criminal case number 13-000751CF10A.

Following an open plea where defendant received a bottom of the guidelines prison sentence, his lawyer stated that he had promised his client probation. I allowed the defendant to withdraw his plea with the understanding that he would go to a different judge because I did not want to have a potential argument for vindictive sentencing if I gave him a worse sentence later.

(6) *State v. Resiles*, Circuit Criminal case number 14-012657CF10A.

This defendant was accused of First Degree Murder and, on July 15, 2016, executed an escape from a crowded courtroom. Eight others were eventually charged as co-defendants to the escape. One of the lawyers for a co-defendant moved to recuse me arguing I was a witness to the escape and therefore could not

sit on the cases. I denied the motion as legally insufficient. The denial was not appealed.

In October 2010 and August 2016, I applied for a seat on the Fourth District Court of Appeal. In February 2011, I applied for the position of Regional Counsel with the Fourth District Office of Criminal Conflict and Civil Regional Counsel through the Supreme Court Judicial Nominating Commission. I applied, on October 12, 2017, for a position as United States District Judge for the Southern District of Florida. On October 8, 2018, I applied for one of three seats on the Florida Supreme Court. Currently, I serve as a judge on the Circuit Court in and for the Seventeenth Judicial Circuit of Florida, where I have presided over criminal and civil cases. For the eighteen years prior to my 2011 appointment to the Circuit Court, my law practice was devoted to criminal trial and appellate work in both State and Federal courts. Because I handled traffic fatality cases, I also consulted with insurance defense firms in their preparation for wrongful death defense trials. Many of my serious criminal defense clients were indigent, including those in thirty-three murder trials.

In the final few years of my criminal defense practice (2008 – 2011), my caseload evolved to consist of more non-violent money crimes, complex economic fraud litigation, and appellate work. I was always involved in daily courtroom activity, and over the course of my career I was often called upon to handle particularly troublesome cases. For example, judges routinely requested that I be appointed to cases that other lawyers would

not take, or cases in which the clients could not get along with a series of other lawyers.

Prior to my criminal defense work, I spent three years as an Assistant State Attorney in Broward County, Florida and handled cases ranging from misdemeanors to felony habitual offender prosecutions. I started my legal career as an associate at Fleming, O'Bryan & Fleming where I handled general insurance defense matters and appellate work.

Before I became a judge, I handled predominantly state court complex criminal cases at the trial and appellate level. The Florida Supreme Court requires lawyers who handle capital cases to be "death qualified," and from 1996 through 2007, as a death qualified lawyer, I handled an average of three death penalty cases per year. Nearly all of these clients were indigent, and many previously had been represented by counsel who withdrew.

Concurrent with my death-penalty work, I handled private criminal cases for clients from all walks of life. Early in my career I was retained on an average of twenty-five driving under the influence cases per year. By the time I left my practice, it was rare for me to handle a DUI, unless it involved serious bodily injury or death. Toward the end of my practice, I handled many drug related crimes, particularly drug trafficking. I also represented clients involved in a high profile prostitution related case, although my clients there became witnesses rather than defendants.

In federal court, the most significant case I handled concerned the investigation into and prosecution of Broward Sheriff Ken Jenne. The other federal matters I handled were relatively routine.

My civil work at Fleming, O'Bryan and Fleming, to begin my career as a lawyer, involved insurance defense and appellate cases. I clerked for this firm as a 2L and began my legal career there upon graduation.

This appeal affected approximately fifty cases in which a County Court judge back-dated driver's license suspensions on DUI cases in an effort to make plea offers appear more palatable. The County Court judge was ultimately removed from office for utilizing this method, as it involved fraudulent alteration of court documents. The judge's actions in the three cases on appeal were neither requested nor encouraged by the defense, but the issue on appeal was whether the defendants had received an illegal sentence. The appellate court viewed the suspensions as collateral consequences and therefore not correctable based upon the plain meaning of Florida Rule of Criminal Procedure 3.800.

(8) *State v. Weaver*, Broward Circuit Court, The Honorable Mark A. Speiser, Circuit Criminal case 96-01644CF10A (Trial: April 14 through May 26, 1999). Conviction affirmed and sentence reduced to life in *Weaver v. State*, 894 So. 2d 178 (Fla. 2004).

I was court appointed two months before trial to represent Jeffrey Lee Weaver on only the penalty phase portion of his trial for First Degree Murder of a Law Enforcement Officer. One week before trial, the client's guilt-phase counsel was discharged, leaving the client to represent himself. Following his conviction as charged, I presented mitigation witnesses and convinced the jury to recommend a life sentence. Judge Speiser entered an override of the jury recommendation and sentenced the client to death, but that decision was unanimously reversed by the Florida Supreme Court. This case is significant for several reasons. First, it is the last judicial override in Florida. Second, it represents the current state of the law for waiver-of-counsel issues known as *Faretta* hearings. Third, it was the only death-penalty case argued by Mr. Satz, until that time, that ended with a life-sentence recommendation.

(1) *State v. Clinton Seymore*

I was the court appointed criminal defense attorney in this significant case requiring expert testimony about police procedure in photographic lineup identifications. Two eyewitnesses identified the defendant using the same photograph six pack. One witness interpreted for the other. The taint caused by this joint identification resulted in suppression of evidence. This case was one of the reasons Broward County began the practice of using double blind sequential photo identifications.

(2) Reasonable doubt instruction

In 1999, there was a call to rewrite the state court reasonable doubt jury instruction. In essence, the proposed change would have replaced the “abiding conviction of guilt” language with the “firmly convinced” standard. At the time, I was President of the Broward Association of Criminal Defense Lawyers (BACDL), and I handled our organization’s efforts to oppose amendment to the jury instruction.

(3) Videotaped interrogations

With attorney Steven J. Hammer, and in my role as President of BACDL, we had extensive meetings with the Broward County Sheriff to advocate for the use of videotaped interrogations. With regard to Motions for Disqualification or cases in which there might be a question as to impartiality or its appearance, I would refer to and follow the requirements of 28 U.S.C. §455. I would also be guided by the Code of Conduct for United States Judges, particularly canons two and three, and all other practices and procedures applicable to such situations.

As a lawyer, the most significant pro bono case I handled was a civil matter in 2002 relating to then-prison inmate Aileen Wuornos. I was appointed by the Circuit Court to handle Ms. Wuornos' complaints against the prison system during her incarceration on death row. I spent approximately 150 hours handling her case without compensation. Ultimately, she was transferred from Broward Women's Prison to Union Correctional Institution, where she was appointed different counsel and executed.

In 2001, while President of the Broward Association of Criminal Defense Lawyers (BACDL), I was in charge of implementing a program started by attorney Jeffrey Harris to raise money for Legal Aid. The program involved criminal lawyers completing an appointed case on a voluntary basis and billing the case in favor of Legal Aid. Each case resulted in Legal Aid receiving \$350. More than \$10,000 was raised through this program.

I submitted an application to the Florida Federal Judicial Nominating Commission on October 12, 2017. On October 27, 2017, I received an email from the Commission Chair advising that I was one of 24 applicants selected for an interview at the Miami federal courthouse on November 28, 2017.

On the night of November 29, 2017, I received an email including my name among the ten that were certified to the Florida Senators for the position of United States District judge. Next, on December 1, 2017, I received an email from Senator Rubio's office setting a meeting with the Senator for December 7, 2017. Thereafter, on December 6, 2017, I received an email from Senator Nelson's office indicating that it would be in touch at a later date. On December 15, 2017, Senator Nelson's office emailed to set up an interview for December 21, 2017.

On February 2, 2018, I received a phone call and follow-up email from the Office of White House Counsel confirming an interview for February 8, 2018. Following that interview, while I spoke with numerous colleagues about the process, I did not have any formal contact with anyone related to this process until I received an email on April 15, 2019 from Senator Rubio's office setting up a phone call for the following day with the General Counsels of both Florida Senators. On April 17, 2019, I received a phone call setting up an interview with the Office of White House Counsel for April 23, 2019.

On the evening of May 1, 2019, I received a phone call from the White House Counsel's Office informing me the President intended to nominate me pending background. The next day, I received emails from the White House and the Department of Justice's Office of Legal Policy informing me of paperwork needed and deadlines for various forms regarding background and vetting. Since that time, I have been in touch with attorneys and staff at the Office of Legal Policy regarding the vetting process and completion of this Questionnaire.
