#### Question 12(d):

On October 12, 2018 and November 9, 2018, I was the presiding judicial officer at naturalization ceremonies in the U.S. District Court for the District of Arizona. These ceremonies are not recorded or transcribed, but I have previously supplied a copy of a generic script that I use at each ceremony and modify based on the remarks of the new citizens.

## Question 13(b):

As of January 24, 2019, the court's case management electronic case filing program (CM/ECF) reports that I have entered 5,157 orders in civil cases, 241 reports and recommendations in civil cases, 7,708 orders in criminal cases, and 2,695 reports and recommendations and findings and recommendations in criminal cases. The report indicates a total of 15,801 orders, reports and recommendations, and findings and recommendations from June 18, 2012 to January 24, 2019. The total number of orders, reports and recommendations, and findings and recommendations, includes all orders, except text entry only orders (orders entered on the docket as a text entry without a written order). As of January 24, 2019, a Westlaw search identifies 299 orders that I have filed, and a Lexis search identifies 383 orders that I have filed. The citation for my order granting the defendants' motion for judgment on the pleadings on plaintiffs' remaining federal due process claim is *Platt v. Moore*, 2018 WL 3744875 (D. Ariz. Aug. 6, 2018). Also, the plaintiffs' motion for remand is now fully briefed.

# Question 13(g):

Unless sealed, all orders and reports and recommendations that I have filed are available through PACER and the court's CM/ECF system, and as selected by Westlaw and Lexis on their databases. I have not issued unpublished orders or indicated that orders are "not for publication." According to a report run through CM/ECF on January 24, 2019, I have written approximately 15,801 orders, reports and recommendations, and findings and recommendations since June 2012. From those orders and opinions, 299 are available on Westlaw and 383 are available on Lexis.
