Dear Chairman Durbin and Ranking Member Graham:

We wholeheartedly support the nomination of Hon. Cristal Brisco to the United States District Court for the Northern District of Indiana. We have each known Cristal for more than 16 years, starting when she joined us as a colleague in the South Bend, Indiana office of Barnes & Thornburg LLP. We have also had the opportunity to work with her as a client and appear before her as a judge. Judge Brisco's range of legal experience, intelligence, temperament and commitment to service are characteristics that make her qualified to serve as a United States District Court Judge.

We worked directly with Cristal for six years when she was an attorney in the litigation and labor and employment departments in our South Bend office. As an attorney, Cristal had strong litigation skills. Her legal research and analyses were thorough, and her writing was concise and persuasive. We relied on her and trusted her judgment. Our experience with Cristal as a lawyer showed us that she has the intelligence, legal skills, and broad experience that a judge presiding over a docket that includes civil litigation needs.

As long as we have known Judge Brisco, it has been clear that she is guided by a purpose to use her talents to serve her different communities. She has been involved with her alma maters, the University of Notre Dame and Valparaiso University, including their student organizations. She has worked with the CLEO Program for law students in Indiana. She served as a merit selection committee member for the Northern District of Indiana, and many other committees and task forces, including those related to improving the judiciary system.

The Hon. Cristal Brisco has the experience, qualification, and character to be an excellent United States District Court judge. She will serve the citizens of the Northern District of Indiana and the legal profession well.
