The State of Missouri charged the defendant with one count of rape in the second degree. The defendant was accused of raping a 20-year-old woman while she was passed out. I presided over pre-trial hearings from 2023 through 2025. After a hearing, I denied the defendant's request to modify bond to allow community supervision, which would have released the defendant from custody. I ruled on numerous pre-trial motions, including motions in limine and a motion to endorse additional witnesses. Before trial began, the defendant waived his right to sentencing by a jury. I presided over the jury trial in May 2025. The jury found the defendant guilty of rape in the second degree. After a lengthy hearing on August 8, 2025, I sentenced the defendant to seven years in prison, the statutory maximum.

From 2023 through 2025, I held numerous pre-trial hearings. I presided over the defendant's change of plea to guilty on April 10, 2025. Defendant deferred sentencing. After an evidentiary hearing on July 11, 2025, I sentenced the defendant to 20 years in prison.

Voters approved a tax for youth mental health services. The Commission, relying on a statute, refused to levy the tax. Based on the statute, I upheld the Commission's decision not to levy the tax. I issued a preliminary order of mandamus on February 24, 2025. I held an evidentiary hearing on relators' petition for writ of mandamus and respondent's motion to dismiss on March 31, 2025. Plaintiff sued BNSF Railway Company, his employer, under the Federal Employer's Liability Act (FELA). While working near the railroad tracks, plaintiff was hit by a BNSF train. He alleged that, due to BNSF's negligence, he sustained a back injury. I presided over all pre-trial matters in this case from 2023 through 2024. I ruled on multiple pre-trial motions, including a motion to exclude demonstrative exhibits and motions to exclude witness testimony. I entered a pre-trial order in this case and held a final pre-trial conference in September 2024. I presided over the jury trial in October 2024. The jury awarded \$3,000,000 to plaintiff and found plaintiff contributorily negligent under FELA, assessing 70 percent of the fault to plaintiff and 30 percent of the fault to BNSF. After a hearing on the parties' post-trial motions, I entered final judgment in the case in February of 2025 and reduced plaintiff's damages to \$900,000.

As a judge, I cannot provide pro bono legal advice. However, I encourage pro bono work in my legal community by appointing attorneys in appropriate cases.

Previously, while in private practice from 2012 – 2014, I volunteered for the Step Up Program and Connections to Success through the Association of Women Lawyers of Greater Kansas City. This program provides free legal assistance to women affected by domestic violence. I spent one day (eight hours) each quarter assisting the program.

While working in the prosecutor's office, I served as a liaison for the Platte County Prevention Coalition. In this role, I met with local high school students and administrators once a month to discuss issues affecting teenagers. Our goal was to minimize drug use among teenagers through open dialogue about consequences. I also volunteered for Platte County's Arrive Alive program, teaching high schoolers about the negative consequences of unsafe, distracted, and impaired driving.

On November 13, 2024, I wrote a letter to Senator Josh Hawley and Senator Eric Schmitt seeking consideration for Missouri's federal district vacancies. I interviewed with Senator Schmitt's office on November 27, 2024 in Kansas City, Missouri. On February 4, 2025, I interviewed with Senator Hawley's office at the federal courthouse in St. Louis, Missouri.

I met with a member of Senator Hawley's judicial advisory committee on April 4, 2025. On September 22, 2025, officials from the White House Counsel's Office contacted me to set up an interview. I interviewed with attorneys from the White House Counsel's Office and the Office of Legal Policy at the Department of Justice in Washington, D.C. on September 30, 2025. On October 24, 2025, I was notified by the White House

Counsel's Office that there would be an FBI background check for the possible nomination. On November 14, 2025, President Trump called to inform me that he would nominate me.
