AMENDMENT intended to be proposed by Mr. BLUMENTHAL Viz:

At the end of subtitle G of title III, add the following:
 SEC. 3720. POWERS OF IMMIGRATION OFFICERS AND EM PLOYEES AT SENSITIVE LOCATIONS.

4 Section 287 (8 U.S.C. 1357) is amended by adding5 at the end the following:

6 "(i)(1) In order to ensure access to sensitive loca7 tions, this subsection applies to enforcement actions by of8 ficers and agents of U.S. Immigration and Customs En9 forcement and officers and agents of U.S. Customs and
10 Border Protection.

"(2)(A) An enforcement action may not take place
 at, or be focused on, a sensitive location except as follows:
 "(i) Under exigent circumstances.

4 "(ii) If prior approval is obtained.

5 "(B) If an enforcement action is taking place pursu-6 ant to subparagraph (A) and the condition permitting the 7 enforcement action ceases, the enforcement action shall 8 cease.

9 "(3)(A) When proceeding with an enforcement action 10 at or near a sensitive location, officers and agents referred 11 to in paragraph (1) shall conduct themselves as discreetly 12 as possible, consistent with officer and public safety, and 13 make every effort to limit the time at or focused on the 14 sensitive location.

15 "(B) If, in the course of an enforcement action that is not initiated at or focused on a sensitive location, offi-16 17 cers or agents are led to or near a sensitive location, and no exigent circumstance or prior approval with respect 18 19 to the sensitive location exists, such officers or agents 20 shall conduct themselves in a discreet manner, maintain 21 surveillance, and immediately consult their supervisor be-22 fore taking any further enforcement action, in order to 23 determine whether such action should be discontinued.

24 "(C) [This policy does]/[Subparagraphs (A) and (B)
25 do] not apply to the transportation of an individual appre-

hended at or near a land or sea border to a hospital or
 healthcare provider for the purpose of providing such indi vidual medical care.

4 "(4)(A) Each official specified in subparagraph (B) 5 shall ensure that the employees under the supervision of 6 such official receive annual training on compliance with 7 the requirements of this subsection in enforcement actions 8 at or focused on sensitive locations and enforcement ac-9 tions that lead officers or agents to or near a sensitive 10 location.

11 "(B) The officials specified in the subparagraph are12 the following:

13 "(i) The Chief Counsel of U.S. Immigration14 and Customs Enforcement.

15 "(ii) The Field Office Directors of U.S. Immi-16 gration and Customs Enforcement.

17 "(iii) Each Special Agent in Charge of U.S. Im-18 migration and Customs Enforcement.

19 "(iv) Each Chief Patrol Agent of U.S. Customs20 and Border Protection.

21 "(v) The Director of Field Operations of U.S.
22 Customs and Border Protection.

23 "(vi) The Director of Air and Marine Oper-24 ations of U.S. Customs and Border Protection.

3	"(5)(A) The Director of U.S. Immigration and Cus-
4	toms Enforcement and the Commissioner of U.S. Customs

6	priate committees of Congress each year a report on the
7	enforcement actions undertaken by U.S. Immigration and
8	Customs Enforcement and U.S. Customs and Border Pro-

20	(i) and (ii) occurred.

23	"(v) A description of the intended target of
24	each such enforcement action.

1	"(vi) The number of individuals, if any, ar-
2	rested or taken into custody through each such en-
3	forcement action.
4	"(vii) The number of collateral arrests, if any,
5	from each such enforcement action and the reasons
6	for each such arrest.
7	"(viii) A certification whether the location ad-
8	ministrator was contacted prior to, during, or after
9	each such enforcement action.
10	"(C) Each report under this paragraph shall be made
11	available to the public without the need to submit a re-
12	quest under section 552 of title 5, United States Code
13	(commonly referred to as the 'Freedom of Information
14	Act').
15	"(6) In this subsection:
16	"(A) The term 'appropriate committees of Con-
17	gress' means—
18	"(i) the Committee on Homeland Security
19	and Governmental Affairs and the Committee
20	on the Judiciary of the Senate; and
21	"(ii) the Committee on Homeland Security
22	and the Committee on the Judiciary of the
23	House of Representatives.
24	"(B) The term 'enforcement action' means an
25	arrest, interview, search, or surveillance for the pur-

1	poses of immigration enforcement, and includes an
2	enforcement action at or focused on a sensitive loca-
3	tion that are part of a joint case led by another law
4	enforcement agency.
5	"(C) The term 'exigent circumstances' means
6	the following a situation involving the following:
7	"(i) The imminent risk of death, violence,
8	or physical harm to any person, including a sit-
9	uation implicating terrorism or the national se-
10	curity of the United States in some other man-
11	ner.
12	"(ii) The immediate arrest or pursuit of a
13	dangerous felon, terrorist suspect, or other indi-
14	vidual presenting an imminent danger or public
15	safety risk.
16	"(iii) The imminent risk of destruction of
17	evidence that is material to an ongoing criminal
18	case.
19	"(D) The term 'prior approval' means the fol-
20	lowing:
21	"(i) In the case of officers and agents of
22	U.S. Immigration and Customs Enforcement,
23	prior written approval for a specific, targeted
24	operation from one of the following officials:

1	"(I) The Assistant Director of Oper-
2	ations, Homeland Security Investigations.
3	"(II) The Executive Associate Direc-
4	tor of Homeland Security Investigations.
5	"(III) The Assistant Director for
6	Field Operations, Enforcement and Re-
7	moval Operations.
8	"(IV) The Executive Associate Direc-
9	tor for Field Operations, Enforcement and
10	Removal Operations.
11	"(ii) In the case of officers and agents of
12	U.S. Customs and Border Protection, prior
13	written approval for a specific, targeted oper-
14	ation from one of the following officials:
15	"(I) A Chief Patrol Agent.
16	"(II) The Director of Field Oper-
17	ations.
18	"(III) The Director of Air and Marine
19	Operations
20	"(IV) The Internal Affairs Special
21	Agent in Charge.
22	"(E) The term 'sensitive location' includes the
23	following:
24	"(i) Hospitals and health clinics.

1	"(ii) Public and private schools (including
2	pre-schools, primary schools, secondary schools,
3	postsecondary schools (including colleges and
4	universities), and other institutions of learning
5	such as vocational or trade schools).
6	"(iii) Organizations assisting victims of
7	crime or abuse.
8	"(iv) Churches, synagogues, mosques, and
9	other places of worship, such as buildings
10	rented for the purpose of religious services.
11	"(v) Such other locations as the Secretary
12	of Homeland Security shall specify for purposes
13	of this subsection.".
