Dear Chairman Leahy and Ranking Member Grassley:

I have reviewed the questionnaire I submitted to the Senate Judiciary Committee on January 14, 2014, in connection with my nomination to the United States District Court for the Northern District of Georgia, and I would like to provide some additional information with respect to my service as a State Representative in the Georgia General Assembly.

I deeply respect the Senate's constitutional responsibility to provide advice and consent on judicial nominations. In several instances in my original questionnaire, I omitted detail that I did not believe was responsive, based on the public questionnaires of other judicial nominees who also had served as state legislators, and I would like to apologize for not including this information. In addition, most of the material I have provided here was not readily available, and, as explained in greater detail below, I have located and exhausted new resources to provide the Committee with as much information as possible.

In reviewing hard copies of the Charlton County Herald, I located the following Letter to the Editor, which I did not previously recall and which is only available in hard copy:

Q. 12(c)

In my original questionnaire, I provided a summary description of my testimony as a State Representative before House and Senate committees in order to explain legislation I had sponsored and urge committee approval. The Assistant Clerk of the Georgia House of Representatives has confirmed that no audio or videotapes were kept or archived during my tenure, from 2001 to 2004, and that House committee meetings were not broadcast over the internet until the 2006 Legislative Session.

As a State Representative, I also had the occasion to speak on the floor of the Georgia House of Representatives, and to the best of my knowledge, the list of 13 speeches below includes all of my speeches. The daily proceedings of the Georgia House of Representatives are taped by Georgia Public Broadcasting (GPB) and searchable records extend only back to the 2009 Legislative Session. GPB does have archives of the Legislative Sessions from 2002 to 2008, but they are located in a new storage location and unavailable online. Furthermore, GPB only has DVD recordings extending back to 2005, and any recordings prior to that time are located on archived servers in a “legacy format” that must be specially decoded. Nevertheless, over the course of the last several weeks, GPB has been extraordinarily helpful in accessing available archives, locating as many of these video files as possible, and converting them to a useable format. As a result, I am able to provide a video recording for eight of my floor speeches.

April 1, 2004: I authored House Bill 1192, prohibiting the use of the Georgia Bureau of Investigation’s nomenclature without permission. After the bill passed the Senate, I spoke on the floor of the House in support of my motion to adopt the Senate Amendments or Substitute to the Bill. My comments were made extemporaneously. I have no notes, transcript or recording. Because the records are not searchable electronically, GPB searched its archived files by date, and video coverage for April 1, 2004 could not be located. GPB informed me that the this file may have been lost due to a hard drive crash, may not have been converted, or may have been inadvertently deleted.

March 12, 2004: I authored House Bill 1335, requiring an opinion or memorandum of decision from the superior court sentence review panel. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes, transcript or recording. Because the records are not searchable electronically, GPB searched its archived files by date, and video coverage for March 12, 2004 could not be located. GPB informed me that the this file may have been lost due to a hard drive crash, may not have been converted, or may have been inadvertently deleted.

February 26, 2004: I spoke on the floor of the House of Representatives in favor of Senate Resolution 595 calling for a proposed constitutional amendment prohibiting same-sex marriages in Georgia. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 2, file: hv022604.m4v at 2:10:26 - 2:14:04).

February 10, 2004: I authored House Bill 1192 regarding the use of the Georgia Bureau of Investigation’s nomenclature without permission. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: hv021004.m4v at 1:33:07 - 1:35:59).

April 25, 2003: After the House of Representatives passed House Bills 462 (the Child Protection Act of 2003) and 463 (a bill strengthening the State Sexual Offender Registry), which I authored, I spoke on the floor of the House in support of my motion to adopt the

Senate Amendments or Substitute to the Bills. My comments were made extemporaneously. I have no notes, transcript or recording. GPB was able to provide me with three videos of the daily proceedings from April 25, 2003, but in reviewing these videos, I have been unable to find any record of my speech.

March 27, 2003: I authored House Bill 462, the Child Protection Act of 2003. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: hv032703.m4v at 2:48:53 - 2:54:48).

March 24, 2003: I authored House Bill 90, a bill providing for the submission of state bar applicants' fingerprints for a national background check. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: hv032403.m4v at 1:59:45 - 2:02:14).

March 6, 2003: I authored House Bill 463, a bill strengthening the State Sexual Offender Registry. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: hv030603 at 59:05 - 1:05:44).

April 3, 2002: As Chair of the Elections Subcommittee of the House Governmental Affairs Committee, I was asked by the Secretary of State to carry Senate Bill 414 in the House of Representatives following its passage in the Senate. This bill provided for the use of direct-recording electronic voting in Georgia. I spoke on the floor of the House in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: hv040302 at 39:43 - 1:17:33).

March 26, 2002: I authored House Bill 1338, a bill clarifying property forfeiture provisions in cocaine possession cases. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes, transcript or recording. GPB was able to provide me with a partial video of the daily proceedings from March 26, 2002, but in reviewing this video, I have been unable to find any record of my speech.

March 26, 2002: I authored House Bill 1556, a bill providing for criminal background checks for bail bondsmen. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes, transcript or recording. (see: Video Attachments CD 1, file: hv032602.m4v at 2:30:29 - 2:32:07).

March 25, 2002: I authored House Bill 1369, a bill providing for a limited license for retail vendors of communications equipment. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes but video coverage is supplied. (see: Video Attachments CD 1, file: Hv032502.m4v at 1:22:29 - 1:25:42).

March 7, 2001: I authored House Bill 681, a bill expanding the membership of the Georgia Technology Authority Advisory Council of the Georgia Courts Automation Commission. I spoke on the floor of the House of Representatives in introducing the measure and urging favorable consideration from my colleagues. My comments were made extemporaneously. I have no notes, transcript or recording. Because the records are not searchable electronically, GPB searched its archived files by date, and video coverage for March 7, 2001 could not be located. GPB informed me that the this file may have been lost due to a hard drive crash, may not have been converted, or may have been inadvertently deleted.

As a State Representative, I sponsored 28 House Bills and 12 House Resolutions. I also co-sponsored at least 52 House Bills and 28 House Resolutions. In my original questionnaire, I provided a summary description of my speeches and talks made from 2001 to 2004 while I was a member of the Legislature. When I served as a State Representative, I maintained my law office calendar on my laptop computer, which I discarded several years ago after it stopped working. To the extent that I may have had written calendars memorializing the dates of any speeches, I would have discarded them in 2012. When I became a judge in January 2005, the State Bar of Georgia directed me to maintain my law firm client and personal files for seven years, which I did, but I did not keep my records beyond that time. In completing my questionnaire, I made a good faith effort to search available records for media coverage of these speeches, but three of the local newspapers that covered my legislative district do not maintain electronic or searchable editions (even internally) for the time period in which I served as a State Representative. Their editions exist solely in bound volumes and on microfiche. A fourth local newspaper, the Waycross Journal-Herald/South Georgia Journal, does not maintain electronic editions searchable by the public for the time period in which I served as a State Representative. These editions are only available in bound volumes and on microfiche.

Therefore, in order to provide more information about my speeches and talks, I have performed a rigorous physical review of hard copies of newspaper coverage during that time. I obtained bound volumes of 515 editions of the Blackshear Times, the Charlton County Herald, and the Pierce County Press, and I spent five days reviewing approximately 8,050 pages. I also hired a journalist at the Waycross Journal-Herald/South Georgia Journal to review approximately 1,200 editions of that newspaper, covering approximately 20,000 pages. Through this research, I have identified the following 48 speeches and talks.

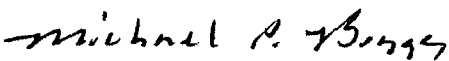
