Dear Chairman Grassley and Ranking Member Durbin,

We, the signatories below, are all former U.S. Department of Justice officials who write in support of the confirmation of Emil J. Bove to be a judge on the U.S. Court of Appeals for the Third Circuit.

As former DOJ officials, we recognize the importance of public service, and confirmation as a federal judge would mark a continuation of Mr. Bove's career-long commitment to public service. He began his career by clerking for two highly respected jurists in New York and later served nearly a decade as an Assistant U.S. Attorney in the Southern District of New York. Most recently, he departed his position as a partner in a successful law firm to return to DOJ as the Principal Associate Deputy Attorney General.

From our time litigating on behalf of DOJ, we also recognize that the judiciary depends on judges who are willing to rule without fear in the most important and controversial of cases. Mr. Bove has never shied away from taking on the hardest matters. As an Assistant U.S. Attorney, he rose through the ranks to become the Co-Chief of the Terrorism and International Narcotics Unit, where he was part of the team that prosecuted the "Chelsea Bomber," for which Mr. Bove received the DOJ Award for Superior Performance by a Litigative Team. He also prosecuted members of Hezbollah, Russia's foreign intelligence service, and international gangs.

Given his excellent credentials, Mr. Bove could have chosen a quiet career path at that point. Instead, he agreed to take on several of the highest-profile cases in the Nation's history, representing President Trump in criminal prosecutions in Florida, New York, and the District of Columbia, even though this inevitably resulted in increased public scrutiny of Mr. Bove himself. Then, in the finest tradition of DOJ, Mr. Bove again chose public service in 2025 by agreeing to serve as Principal Associate Deputy Attorney General, where he has been willing—as always—to take on the hardest cases, hear from all interested parties, and come to reasoned and just decisions, all of which are necessary traits for successful judicial service, as well.

Mr. Bove would make an eminently qualified and excellent addition to the U.S. Court of Appeals for the Third Circuit. We respectfully urge the Senate Judiciary Committee and the full Senate to move expeditiously to process and confirm his nomination.
