## Re: Nomination of David Bragdon to the United States District Court for the Middle District of North Carolina

Dear Chairman Grassley and Ranking Member Durbin:

We are former law clerks to the Honorable Clarence Thomas, and we write solely in our personal capacities to express our strong support for the nomination of David Bragdon, who has been nominated to serve as a federal judge on the United States District Court for the Middle District of North Carolina.

But as impressive as David's outstanding resume and his record of public service have been, they do not tell the full story of David. Having had the privilege of knowing David, we have witnessed firsthand David's formidable intellect, tireless work ethic, and unwavering dedication to the rule of law. David is the epitome of thoughtfulness and humility in his approach to others and in his consideration of complex legal issues. He approaches legal arguments with care, rigor, and precision—qualities that will serve the people of North Carolina and the federal judiciary with great distinction.
