Over the next several years, I gained experienced in a variety of fields, including securities, financial services, government claims, agribusiness, commercial, and some employment matters.

During the fall of 2004, Kutak Rock offered my services on a full time basis to the Douglas County, Nebraska Attorney's Office for a three month time period due to a shortage of attorneys in the Douglas County Domestic Violence Prosecution Unit. While at the Douglas County Attorney's office, I prosecuted dozens of domestic violence charges, gaining both jury and bench trial experience. During my service with the Douglas County Attorney's office in the fall of 2004, I continued to be an employee of Kutak Rock, although I was a sworn Douglas County and Omaha City prosecutor.

In 2005, my work began to focus more on the legal issues of a single food and meat packing client, Tyson Foods, Inc., where I took primary briefing responsibility for large, complex briefing projects on cases with tens of millions of dollars at stake. At that time, I began to focus my practice on

agribusiness law and agribusiness disputes. I also gained experience with class action lawsuits, including performing substantial primary briefing responsibility for class certification briefs and other legal issues within such cases.

In 2009, I began leading the Kutak Rock LLP national agribusiness litigation team. In that capacity, I represent local and national clients in general commercial litigation, and coordinate activities of those attorneys who practice in agricultural law. I also supervise other attorneys who work on cases I am handling as lead counsel. I represent some of the largest agribusinesses relating to disputes involving real estate, state and federal regulation, environmental concerns, food products, railroad and transportation issues and contract disputes, among other matters. I also represent a variety of small or medium agribusiness entities and individual farmers, ranchers or operators with regard to various disputes and advice relating to agriculture. I also have experience in the area of solid waste disposal and the environmental considerations relating to this industry. I also occasionally advise other attorneys on matters of legal ethics and professional responsibility and work on government relations matters in Nebraska at the state and local level. I have also handled several class action lawsuits as lead counsel, including class actions relating to the Fair Debt Collections Practices Act.

My practice is litigation-focused. However, I spend a considerable amount of my time assisting large agribusiness clients with various matters outside of litigation. I spend time managing my clients' legal needs, including assisting in a variety of ways with transactions managed by corporate firm attorneys.

I would estimate that 70 percent of my time is spent on active litigation or dispute work seeking to resolve disputes or work in anticipation of litigation. The remaining 30 percent of my work includes general services to clients assisting such clients in a variety of ways, including finding specialist attorneys to handle specific legal issues for such clients. I also provide assistance to clients in communications and legal services management on legal work including transactions and employment issues.

Of the time I spend in active litigation or anticipation of litigation, a majority of such time is spent litigating in, or in anticipation of litigation in, federal courts, mostly in Nebraska and Iowa, but also in various other jurisdictions around the country.
