RE: Michael B. Brennan, Nomination to the United States Court of Appeals for the Seventh Circuit

Dear Senators Johnson and Baldwin:

I am a long standing friend and judicial colleague of Michael Brennan, and believe that I am uniquely qualified to share with you some of my thoughts concerning his nomination to the Seventh Circuit Court of Appeals.

Judge Michael Brennan has the mind, heart and soul of a great jurist. He has consistently demonstrated an unwavering commitment to the fundamental constitutional principle of applying the rule of law "without respect to persons." That isn't just some abstract legal concept to Judge Brennan; rather it has been the shining lodestar of his entire legal career. What distinguishes Judge Brennan from others, who share that same commitment to the rule of law, is his humanity. He understands that real people, whether they are rich or poor, faith-filled or agnostic, well spoken or shy, look to the courts to help them solve their problems within the context of the rule of law.

His judicial service in Milwaukee County, the largest, busiest and most diverse in the great state of Wisconsin, included serving as the Presiding Judge in the Civil Division, where he handled both large and small claims calendars. Mike Brennan served with distinction on the civil bench and earned the respect of the Bar with his keen understanding of the legal issues in sophisticated and complex civil litigation. Equally important was his deft and pragmatic approach to problem solving with small claims litigants in matters ranging from evictions to consumer protection. He

not only had the respect of the Bar and self represented litigants, it is very note-worthy that the Court of Appeals consistently affirmed Judge Brennan's decisions.

Judge Brennan also served in the criminal division handling domestic violence cases, misdemeanors and felonies. Judge Brennan and I served together on the Homicide and Sexual Assault Docket in Milwaukee County. During that time, the third judge on our homicide team became very ill and had to take a medical leave of absence, leaving Mike and I to manage not only our own calendars, but that of our sick colleague. Mike never complained about the situation; instead he just rolled up his sleeves and did the work. He is a consummate team player with an incredible work ethic.

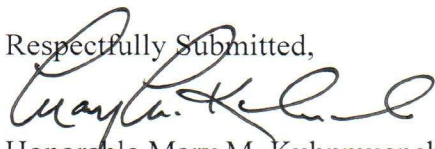
Most importantly to the litigants who appeared before him, Judge Brennan was a wonderfully kind and patient judge with a humble demeanor. He didn't use the bench to showboat or tell everyone how smart he was. I was amazed at his patience in dealing with any number of difficult people or cases before him.

Graduating with honors in philosophy and government from the University of Notre Dame, Judge Brennan studied law at Northwestern University Law School, where he served as the coordinating note and comment editor of the Northwestern University Law Review. A brilliant legal scholar, with more than 50 published articles on various legal topics including sentencing and federal jurisdiction, Mike is an outstanding writer and communicator. He is also a natural teacher, having developed and presented several judicial education programs to fellow judges. He is intellectually curious and thoughtful without being haughty. His incredible legal acumen was developed and honed through his broad and diverse experiences as a former state prosecutor, circuit court judge, mediator, and distinguished civil litigator.

Finally and significantly, Mike is not an ideologue, and he has never worn his politics on his sleeve. You could ask any number of lawyers who appeared before him, or his colleagues who worked along side of him, and they will confirm that Judge Mike Brennan never let his personal, religious or political views influence his legal decision in any case. He is brilliant, experienced, hard working and fair minded.

Rest assured that they don't come any better than Mike Brennan. He will be an outstanding Judge, and a wonderful addition to the Seventh Circuit Court of Appeals.
