Generally speaking, my law practice has involved litigation in federal district and appeals courts, primarily involving regulatory and constitutional issues. I have argued three cases in the United States Court of Appeals for the Eleventh Circuit and one case before the Alabama Court of Criminal Appeals. I have written briefs, both as an amicus and representing the state of Alabama, for the United States Supreme Court. I have also led multi-state efforts in district and appellate courts around the country on issues of import to the states. Finally, I have been involved in one capacity or another—from taking depositions to briefing to consulting to moot-courting—in many additional cases.

After graduating from law school in 2007, I spent a year as an associate with Gibson, Dunn & Crutcher in Washington, D.C. During this period, my practice was divided into three parts. First, I represented a United States Congressman in a public corruption investigation that was resolved favorably for the client. I also represented, pro bono, a class of plaintiffs harmed by a D.C. landlord. This was a complex litigation, with many defendants and plaintiffs and a lengthy paper trail, resulting in a dozen or more depositions I either took or second chaired. Finally, I represented international corporations facing investigations under the Foreign Corrupt Practices Act.

For two years from 2008 to 2010, I served as a law clerk to Judge L. Scott Coogler of the United States District Court for the Northern District of Alabama. In that capacity, I drafted bench memoranda, helped to prepare

In addition, I advised the Attorney General on matters of legal policy and drafted statements for the Alabama Attorney General.

I briefed and argued this case before the Eleventh Circuit on an expedited, emergency basis. Over a dissent by Judge Jordan, the panel of Judge Martin and Judge Wilson found that Madison was incompetent to be executed and refused to lift the stay.

- (2) *Alabama, et al. v. National Marine Fisheries Service, et al.*, No. CV 16-00593 (S.D. Ala. Nov. 29, 2016).

In this case, Alabama led an 18-state coalition challenging new regulations promulgated under the Endangered Species Act that significantly expanded the definition of “critical habitat” and “adverse modification” of habitat. The State of Alabama believed that these new regulations would have allowed the federal government to declare areas generally unsuitable for a species to nevertheless qualify as critical habitat, with all the regulations and limitations such a designation would entail. The lawsuit, filed in the Southern District of Alabama before Judge Grenade, followed on a number of amicus briefs we filed in federal appeals courts challenging similar perceived abuses of the Endangered Species Act.

I developed the strategy for challenging these regulations and drafted the complaint filed in federal district court. The case is still pending, though the change of administrations in Washington resulted in a stay that is still in place.

In this case, the Ninth Circuit found that California's procedural bar against claims raised for the first time in a habeas petition was inadequate to bar habeas review of those claims. This rule would have made it much more difficult for the states to enforce procedural bars on habeas review. In my capacity as deputy solicitor general, I represented Alabama and 23 states—including all of the states in the Ninth Circuit—as amicus curiae in support petitioner California. In a per curiam opinion, the Supreme Court summarily reversed the decision of the Ninth Circuit, citing our brief in the opinion.

- (4) *Brooker v. State of Alabama*, 192 So. 3d 1 (Ala. 2015), cert. denied, 136 S. Ct. 1659 (2016). Brief in opposition to certiorari available at 2016 WL 1056625.

Brooker involved a challenge to Alabama's Habitual Felony Offender Act. Brooker was arrested for growing marijuana plants on his property. Due to his previous convictions for drug trafficking and multiple counts of armed robbery, Brooker's marijuana charge resulted in a mandatory life-in-prison sentence. Because the case involved an elderly man receiving such a high sentence and because the triggering offense involved marijuana, the case received international attention, with the New York Times calling on the Supreme Court to invalidate the sentence.

I represented the state of Alabama, drafting the brief in opposition to Brooker's petition for certiorari. The brief argued that Brooker's history of violent crime and not the ultimate conviction for marijuana possession triggered the life sentence. The Supreme Court declined to take Brooker's case.

Peruta was an en banc case in the Ninth Circuit challenging San Diego's system of issuing concealed carry permits. A panel of the Ninth Circuit had struck down the law for violating the right of citizens to bear arms, protected by the Second Amendment of the Constitution. California bans open carry of firearms altogether, and San Diego only permits the concealed carry of firearms if the applicant can demonstrate some special need. Thus, the average citizen of California is banned from bearing arms.

I represented the state of Alabama and twenty other states, arguing that the San Diego law was inconsistent with the Supreme Court's rulings in *Heller* and *McDonald* and violated the Second Amendment of the Constitution. The en banc court, in a 7-4 ruling, reversed the panel's decision and upheld the ban (Judges W. Fletcher, Thomas, Pregerson, Graber, McKeown, Paez, and Owens in majority; Judges Callahan, Silverman, Bea, N. R. Smith, dissenting.)

- (6) *State v. McCarthy*, No. CV 215-79, 2015 WL 5092568 (S.D. Ga. Aug. 27, 2015), *appeal held in abeyance sub nom. Georgia ex. rel. Olens v. McCarthy*, 833 F.3d 1317 (11th Cir. 2016).

This litigation represented one of several challenges by groups of states to rules seeking to define the phrase “waters of the United States.” The states argued that the new definition was inappropriately overbroad, sweeping under federal jurisdiction minor rivers, streams, bodies of water, and even areas that may not contain water for years at a time. The states felt this new regulation was incompatible with the both the Clean Water Act and Supreme Court jurisprudence interpreting it.

I led Alabama’s efforts in this area, coordinating both with the states involved in the Georgia litigation as well as states in other district courts around the country. This included helping to prepare Georgia’s solicitor general for a jurisdictional argument before the Eleventh Circuit Court of Appeals. The states’ efforts resulted in a stay of the rule, and the Trump administration recently announced plans to rescind and replace it. The case was before Judge Wood in the district court and Judges E. Carnes, J. Pryor, and Reeves on appeal.

This case was a direct appeal of Largin's double homicide conviction in which he was found guilty of murdering his parents for drug money. The case presented a number of interesting evidentiary questions, including the admission of a confession and prior bad acts. Moreover, because of the brutality of the crime, the case had drawn considerable attention from the Alabama press.

Following the resignation of the lead attorney for the state, I was assigned the task of arguing the case before the Alabama Court of Criminal Appeals less than two weeks before the argument. The court unanimously upheld Largin's conviction.

Samra argued that he was under Duke's sway at the time of the murder, and claimed that his attorney inadequately represented him during trial.

Waldrop and his wife murdered Waldrop's grandparents during a robbery for drug money. Waldrop was convicted of the murder, and the jury recommended he receive life in prison. At the time, however, Alabama allowed the judge to override the jury's recommendation and impose a death sentence, which the judge did. On appeal, in addition to claiming that his attorney was ineffective at trial, Waldrop made the cutting-edge argument that Alabama's override system was unconstitutional in light of two Supreme Court cases: *Ring v. Arizona* and *Hurst v. Florida*.

I handled the appeal on behalf of the state, drafting the brief and arguing the case before Judges Marcus, Martin, and Jordan of the Eleventh Circuit Court of Appeals. As of this writing, the court has yet to decide the case.

Spokeo raised a key question in civil litigation: does a litigant who has suffered no actual harm nevertheless have standing to sue for and recover statutory damages? This question arises in the context of statutory schemes created by Congress to protect consumers from certain types of activity, standardizing damages where they are often difficult to quantify.

I represented Alabama and seven states as *amicus curiae* in support of *Spokeo* arguing that a consequence of no-harm standing would be to allow substantial, enterprise-killing class actions by thousands of individuals who have suffered no injury but nevertheless can collect millions of dollars in damages. The Supreme Court in a 6-2 ruling vacated and remanded the case to the lower court, reiterating the need for a plaintiff to show a concrete injury before standing can be established.
