Description:

In this case, seven individuals were charged with providing material support to a designated terrorist organization. The defendants collected money at Los Angeles International Airport, claiming that they were raising money for a charity when in fact it was sent to a terrorist organization. The money was deposited into bank accounts in Los Angeles maintained by defendants, and was wire-transferred through bank accounts in Europe and the Middle East. The terrorist organization also maintained paramilitary camps in Iraq, where some of the defendants had participated in the organization's activities and/or received paramilitary training.

The case involved multiple cooperating witnesses who were former members of the organization; 89 consensual Farsi-language recordings; over 500 videotapes depicting the organization's activities and operations; thousands of checks and credit card slips; records from hundreds of bank accounts located in the Belgium, Canada, England, France, Germany, Italy, Jordan, Luxembourg, Netherlands, Norway, Sweden, Turkey, the United Arab Emirates, and the United States; computers with encryption and Farsi-language software; and unwitting donor victims in the United States, Japan, and Great Britain. We worked closely with law enforcement in Australia, France, and Germany, gathering evidence and assisting those countries in their law enforcement actions.

The case was originally indicted in March 2001, the District Court dismissed that indictment and the government appealed. I was assigned to

the case following dismissal, to determine whether alternative charges could be presented. I presented the grand jury with fraud charges, and a superseding indictment was returned. The Ninth Circuit Court of Appeals reversed the dismissal of the original indictment, and the case returned to the district court for trial on both material support and fraud charges. The defendants filed sixteen pretrial motions seeking to dismiss the indictment through challenges to the constitutionality of the statutes under which they were charged, the manner in which the charges were alleged in the indictment, the timing of the indictment, and the facts that supported the indictment. The district court denied all sixteen motions.

Disposition:

On April 29, 2009, in the middle of jury selection, all defendants pled guilty.

As a supervisor in the United States Attorney's Office for the Central District of California, between 1999 and 2009, I oversaw many significant criminal matters, and frequently made filing decisions and/or investigative strategic decisions relative to the cases. In addition, I frequently worked with the Criminal Division and the National Security Division at the Department of Justice regarding coordination and approval for proceeding with the prosecution of these matters.

As the first Chief of the National Security Section for the Central District of California, I was actively engaged in overseeing the creation and development of the Section. I was responsible for creating the Section, recruiting attorneys to join the Section, developing the skills of the lawyers in the Section, working closely with the law enforcement agents assigned to national security, developing reporting requirements, and developing successful oversight tools to effectively manage this emerging area.

As part of this effort, I helped create the Export and Anti-Proliferation Global Law Enforcement (EAGLE) Task Force. <u>Domestic Violence</u>: Organized and supported the City's Domestic Abuse Response Program (DART), which partners victim advocates with LAPD officers to respond to domestic violence calls at the scene of the crime and provides crisis intervention. <u>Crisis Response Team</u>: Managed a 200-person volunteer team of residents who, at the request of the Los Angeles Police Department or Los Angeles Fire Department, provide crisis care and counseling to victims of crime, traffic accidents, or other traumatizing events.

While an Associate at Gibson, Dunn & Crutcher, I served as the Pro Bono Coordinator, where I worked on numerous bro bono cases and assigned pro bono projects to other attorneys. I worked primarily with: (1) Public Counsel; (2) the American Bar Association; and (3) the Central American Refugee Center ("CARECEN").

While an Assistant United States Attorney, the United States Attorney's Office approved providing pro bono services to families seeking to adopt children in uncontested proceedings. The cases were provided though Public Counsel's Children's Rights Project. I estimate (because I no longer have the records) that I assisted approximately 30 families in the adoption of their children. In 2001, I received a commendation for this work from Public Counsel.

I have been involved in various mentorship programs aimed at providing law students with a connection to people in the legal profession. The mentoring programs I have worked with are primarily through the Women Lawyers Association of Los Angeles, and the Harvard Law School Wasserstein Public Interest Fellowship Program. In addition, since 2000, I have annually funded a college scholarship program for high school seniors who have a demonstrated interest in public service. The scholarship fund is named after my father, who inspired me to enter public service. In addition, my husband and I fund a scholarship at Cornell University for government majors at the University.

For many years, I regularly volunteered at the Los Angeles Downtown Women's Center, a shelter in downtown Los Angeles.

I also have worked to preserve the history of women lawyers in Los Angeles by recording oral histories of women in the profession and by working on a committee to change the name of the downtown criminal courts building to the Clara Shortridge Foltz Criminal Justice Center, in honor of the first woman in California who was admitted to the California State Bar.
