Dear Chairman Grassley and Ranking Member Durbin:

On behalf of the International Association of Chiefs of Police (IACP), I am pleased to offer our endorsement of Robert Cekada as Director of the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF).

Deputy Director Cekada is a career law enforcement professional with more than 30 years of local and federal service. He began his career in local policing with the New York City Police Department and later with the City of Plantation Police Department in Florida. These early years in local policing shaped his understanding of the day-to-day realities facing officers and detectives and continue to inform his leadership approach today. His subsequent federal career has included leadership roles across major ATF field divisions and headquarters.
