The Fleur de Lis organization of the Archdiocese of St. Louis is governed by a Board consisting only of women (other than the Archbishop). Annually, the organization hosts the Fleur de Lis Ball, a debutant ball to raise funds for Cardinal Glennon Children's Hospital. The Board has various Committees, most of which are women-only. The Committee on which I serve includes men and provides security for the Ball.

When I became a member of the Missouri Athletic Club in 1991, the Club's athletic facilities were open only to men. During the time I served as a member of the Club's Athletic Committee, the Club's athletic facilities were opened to women.

Membership in the Veiled Prophets of St. Louis is limited to men. It is my understanding that the Veiled Prophets of St. Louis previously excluded members on the basis of race. These policies were changed in 1979, and have not been in place at any time during my affiliation.

It is also my understanding that the St. Louis Country Club either through formal policies or through the practical implementation of its policies previously excluded persons of certain races or religions from membership. These policies are no longer in place and have not been in place since at least 2003.

To the best of my knowledge, and other than as noted, none of the organizations listed above currently invidiously discriminates or formerly invidiously discriminated on the basis of race, sex, religion or national origin either through formal membership requirements or the practical implementations of membership policies.

I have represented many professionals in separating them from their medical, law, and accounting practices. These are often intensely emotional situations involving complex personal, business, and legal relationships. With but one exception, I have successfully negotiated resolutions without litigation.

From 1991 to 2003, I served as a volunteer lawyer for the St. Bridget's Parish Legal Outreach Clinic. I would go to the Church on Saturday mornings and assist clients at the clinic. In this role, I represented many indigent clients on a pro bono basis. I no longer have access to time records on these matters but estimate 30 – 50 hours per year, for a total of approximately 390 to 650 hours. From 1991 to 1996, I also served as a volunteer lawyer for Legal Services of Eastern Missouri. I no longer have access to time records on these matters but estimate 30 – 50 hours per year, for a total of approximately 180 to 300 hours. Currently, as the sole principal of my firm, I devote my own time to pro bono matters and I pay my attorneys and staff to handle pro bono matters.

In *Jalesia McQueen v. Justin Gadberry*, 507 S.W.3d 127 (Mo. App. 2016) (transfer denied), the case involved a mother seeking to gain custody of frozen embryos.
