I have been blessed throughout my career with having several positions and opportunities to protect and serve our great nation. However, I am most proud of being a husband and father. I have been married to Joy Cole for 32 years and we have four adult children together. My daughters are strong, independent young women who both earned scholarships to the University of Virginia-Wise and both of my sons are choosing to serve their country as members of the U.S. military.

I began my law enforcement career approximately 28 years ago as a police officer in the State of New York before moving to the Drug Enforcement Administration (DEA) in 1998, where I served for 21 years. While at DEA I worked in several domestic offices and multiple foreign countries including Colombia, Mexico and Afghanistan. I also served as the Chief of Staff and Executive Officer at the DEA/ Department of Justice

Special Operations Division, the DEA representative to the National Security Council, and the Chief of Staff and Executive Officer for the DEA Chief of Global Operations. I retired from federal service as the Acting Regional Director of Mexico, Canada, and Central America in 2019.

After retirement, I entered the private sector where I led the Financial Threat Matrix Division and the Government Solutions Division of Apeira Solutions, Inc. (Apeira), a Dallas, Texas based software and services company that provides secure transaction processing and regulatory compliance support to the financial services sector.

In 2023, Governor Youngkin asked me to continue my public service to our great country and to the Commonwealth of Virginia as the Secretary of Public Safety and Homeland Security. As the Secretary, I lead 11 state public safety agencies with more than 19,000 employees and a budget of approximately \$3.1 billion dollars. I provide daily leadership and governance to the critical mission of each agency to enhance the public safety of Virginia's citizens, visitors, and businesses. I also serve as the Homeland Security Advisor to Governor Youngkin and lead Virginia's unified homeland security efforts. This role is crucial to protecting Virginia's critical infrastructure and maintaining a secure and resilient Commonwealth.

As directed by Governor Youngkin, as the Secretary of Public Safety and Homeland Security for the Commonwealth, I focus on addressing the fentanyl crisis and violent crime affecting the commonwealth. The initiatives I led became the priority and a structure of a comprehensive action plan to reduce violent crime, the amount of illicit drugs, and drug overdose deaths in the Commonwealth. These initiatives include leading the implementation of Operation Bold Blue Line which addresses violent crime in Virginia's 13 most violent cities; implemented the Violent Crime Reduction Strategy which uses data driven policing to target the most violent criminals and regions within the Commonwealth; implemented Operation FREE which specifically focuses on reducing the prevalence of fentanyl and overdose deaths in Virginia; and started Operation Silence Shattered to address the heinous crime of human trafficking. From the beginning of my time in this role, it has been my focus to breakdown the silos of communication and information sharing and to build up the relationships between state law enforcement and federal partners, other states, prosecutors, and private industry to bring to bear all available resources in a focused, unified force to defeat those individuals and networks driving crime and harming our communities.

The combination of these initiatives led to significant reductions in violent crime including murder by 19%, rape by 9%, robbery by 11% and aggravated assault by 7%. Operation FREE and fentanyl awareness campaigns led to a 35% reduction in fentanyl related deaths, the second highest rate in the nation. I am extremely proud of the work I am doing in the Commonwealth of Virginia and prouder yet of the positive impact these programs are having towards making Virginia safer for her residents.
