In my capacity as a tenured Member of Congress and a lifelong advocate for civil rights and social justice in America, I write to express my unwavering support for the nomination of Debo P. Adegible to become the Assistant Attorney General of the Civil Rights Division of the Department of Justice. I encourage his swift and expeditious confirmation.

I first came to know Mr. Adegbile through his work at the NAACP Legal Defense and Educational Fund (LDF) when we were working to reauthorize sections of the Voting Rights Act before they expired in 2006. He was a trusted and committed advocate for reauthorization who worked closely with my staff, as well as other House and Senate staff, as a primary consultant on our legislative strategy throughout the bipartisan, bicameral reauthorization process. He was a key presenter at congressional briefings my office developed on the issue of voting rights and is an expert my staff consistently engages whenever I need to prepare legal briefs, develop published opinions on voting rights, or take any action which might impinge on the goals that the LDF or other civil rights groups are trying to accomplish.

Mr. Adegbile's broad legal experiences have made him an exemplary litigator and exceedingly qualified to lead the Civil Rights Division.
