Re: Nomination of John D. Russell to the United States District Court for the Northern District of Oklahoma

I write to offer my unqualified support for the nomination of John D. Russell as United States District Judge for the Northern District of Oklahoma.

Mr. Russell and I have been professionally and socially associated in various respects since the 1990s. Having closely observed Mr. Russell for almost three decades, I know him to be highly qualified for the position you consider here. For over fifteen years we practiced law in the same firm and worked closely together on contested and complex cases in Federal Court, before regulatory commissions and in private arbitration.
