I follow the Oregon Code of Judicial Conduct and recuse myself from any case where I have a conflict, as defined in the Code, or where there could be an appearance of partiality or impropriety. My court does not have an automated conflict process nor does our electronic filing system systematically track judicial conflicts that would allow me to identify the cases in which I have recused myself. When I joined the bench, I notified court staff of conflicts that I have due to my prior practice and my husband's employment with a law firm, and I review the cases that I am assigned for these conflicts. I also review the cases I am assigned for other personal conflicts or potential appearances of impropriety. From my recollection, I have recused myself four times due to a prior relationship with an attorney or litigant involved in the case. All four recusals were sua sponte.
