#### b. Describe:

The entirety of my legal career has been with the United States Attorney's Office in the District of New Mexico. In 2006, after graduating from law school, I clerked for Assistant United States Attorneys (AUSAs) in the Organized Crime Drug Enforcement Task Force (OCDETF) unit in the Albuquerque office. In 2008, I was hired as a contract High Intensity Drug Trafficking Area (HIDTA) Special Assistant United States Attorney (SAUSA) in the Las Cruces Branch Office. My hiring was structured as a detail from the Town of Mesilla to the United States Attorney's Office. I primarily prosecuted drug trafficking, immigration, and firearms offenses.

In 2009, I was hired by the District of New Mexico as a full time AUSA. My practice focused on complex drug trafficking and money laundering investigations, including numerous OCDETF and Title III wiretap investigations. However, I represented the United States in all types of criminal cases. I handled all aspects of my criminal cases from investigation to charging decisions, discovery, motions practice, plea negotiations, trials, sentencing litigation, and a few appeals.

In 2022, I was promoted to Supervisory AUSA in the Las Cruces Branch Office and have served in this capacity since. I am one of two criminal section supervisors and supervise nine AUSAs on average. The AUSAs I supervise prosecute a wide range of federal criminal offenses including immigration, firearms, drug trafficking, white collar, and violent crime

cases. Their work includes both cases charged by complaint and long-term complex investigations that are typically initiated by indictment. In addition to overseeing casework, I am responsible for administrative personnel matters for the AUSAs in my section. I serve on the Las Cruces Branch Office's hiring committee for AUSAs and partner with other management personnel to conduct regular internal training. From time to time, I interface with law enforcement partners, the Court, and defense counsel on a variety of issues that arise in the general federal criminal practice.

I have exclusively represented the United States. From 2008 to 2022, I specialized in drug trafficking and money laundering prosecutions, both cases and complex, long-term investigations.

Beginning in 2008 when I became a SAUSA, at least 75 percent of my practice has involved litigation, with the remainder focused on investigatory work. On average, I have appeared in court 2 to 3 times each week for the entirety of my career.

From 2016 to 2022, I represented the United States as co-lead counsel in this 44-count case charging 23 defendants with various drug trafficking, money laundering, and firearms offenses. The indictment resulted from a year-long investigation, including court authorized wiretap interceptions of various telephones for approximately six months. The entire investigation revealed a total of approximately 64 kilograms of methamphetamine, approximately 17 kilograms of cocaine, and approximately 30 kilograms of heroin being distributed in New Mexico between the areas of Doña Ana County, Bernalillo County, Valencia County, Otero County, and elsewhere within the United States. Twenty of the 23 defendants were arrested in April 2017, and all pled with negotiated plea agreements resulting in sentences ranging from probation to 200 months imprisonment. Three defendants remain fugitives. As co-lead counsel, I shared responsibility for compiling evidence, recommending charging decisions, making detention arguments, plea negotiations, and responding to sentencing motions. I have handled numerous post-sentencing motions.

From 2021 to 2022, I represented the United States in this civil forfeiture proceeding as assistant counsel. In the proceeding, a claimant challenged the United States Border Patrol's seizure of \$426,590 found in a tire in the bed of a rental truck during an inspection at a border checkpoint. After the completion of discovery, including eight depositions, and extensive negotiations, we reached a settlement. Ultimately, opposing counsel and I negotiated a settlement prior to mediation that resulted in the claimant forfeiting his rights to a total of \$276,590, and the government returned \$150,000. As associate counsel, I drafted interrogatories, responded to interrogatories, and helped manage discovery.

# 5. United States v. Romero, 2:13-CR-02723 (Brack, J.)

From 2013 to 2019, I represented the United States in this 10-count drug trafficking and firearms case charging three defendants. I was lead counsel and handled all stages of the case from investigation to sentencing. This case resulted from an investigation of a group of drug traffickers believed to be members or affiliates with the Barrio Azteca gang operating in southern New Mexico. The defendants sold cocaine and firearms to cooperating sources. All three defendants resolved their charges through negotiated guilty pleas and received sentences ranging from 3 years and 1 month to 11 years and 11 months in prison. 6. United States v. Leyva, 2:17-CR-00769 (Parker, Gonzales, JJ.)

From 2016 to 2018, I represented the United States in this case as sole counsel. On August 29, 2016, Leyva led federal and local law enforcement on a harrowing car chase through the neighborhood streets near downtown Las Cruces after he failed to yield to an attempted traffic stop. During the high-speed chase, at different times, the defendant crashed into law enforcement vehicles and drove directly towards one federal task force officer who was trying to escape the area on foot after the defendant crashed into his vehicle and disabled it. Leyva pleaded guilty to two counts of assaulting federal officers using a deadly weapon through a negotiated plea agreement and was subsequently sentenced to 82 months imprisonment. 7. United States v. Vasquez, et al., 2:13-CR-03367 (Brack, J.), United States v. Marquez, 898 F.3d 1036 (10th Cir. 2018) (Tymkovich, Moritz, and Eid, Circuit JJ.), 139 S. Ct.

654 (2018) (cert. denied).

From 2013 to 2018, I represented the United States in this 43-count drug trafficking and money laundering case brought against 18 defendants. This case involved a methamphetamine trafficking organization operating between Arizona and New Mexico. I joined the prosecution team as the wiretap investigation was concluding in the role of associate counsel and have participated in all aspects of the case since that time. Initially, 17 of the 18 charged defendants were arrested and resolved their charges through negotiated guilty pleas with sentences ranging from five days to five years. The final defendant (Marquez) remained a fugitive for approximately 12 months. By the time he was arrested, I had transitioned to lead counsel. Marquez proceeded to a three-day jury trial, at the conclusion of which he was convicted of six of the seven charges against him. Thereafter, the District Court sentenced him to 121 months of imprisonment. As lead counsel for the trial, I filed and responded to pretrial and post-trial motions, conducted voir dire, conducted direct examination for half of the trial witnesses, including expert testimony, argued jury instructions, and presented closing arguments.

Following the trial conviction, from 2016 to 2018, I represented the United States for Marquez's appeal on the issues of sufficiency of the evidence, the District Court's witness examination, and the admission of particular aspects of two federal agents' testimony. I briefed the response and argued the case to the Tenth Circuit. In the United States Attorney's Office, appeals are typically transferred to the Appellate Division and trial counsel are not regularly expected to handle their own appeals. However, AUSAs have the option to request permission to keep the appeal if the Appellate Chief approves proceeding in that fashion, which is what occurred in this case. I did not have co-counsel on the appeal. The conviction was affirmed.
