The Second Circuit sought the Antitrust Division's views as to whether investment banks were entitled to implied antitrust immunity in a suit alleging that the banks had conspired to inflate the aftermarket prices for certain securities because of the Security and Exchange Commission's regulation of the initial public offering process in which the alleged anticompetitive activity occurred. I worked on the Division's response to that request, which took the position that claims alleging that defendants engaged in "practices that are strictly prohibited under the securities laws and that the SEC has never permitted or proposed to permit[,] should not be dismissed on implied immunity grounds." After I left the Division, the case was heard by the Supreme Court, which held that the banks were entitled to implied antitrust immunity because all four elements of *Gordon v. New York Stock Exchange's* "plain repugnancy" test were met.

First, I am proud of my contributions to the bi-partisan 2003 PROTECT Act, which banned child pornography over the internet. The U.S. Supreme Court in *United States v. Williams*, upheld key parts of this legislation after several prior attempts were struck by the Court as a violation of the First Amendment. Second, I am proud of my work advising the Committee in the bi-partisan passage of the first major changes to the Hart-Scott-Rodino antitrust laws to update the merger filing thresholds for the first time since 1976, resulting in more efficient use of government and private sector resources, as well as a greater focus on the so-called second-request review process by requiring the antitrust enforcement agencies to create internal procedures to streamline the process. Finally, I am proud of the work I did in response to the 9/11 terrorist attacks in updating our criminal and intelligence capabilities in the bi-partisan passage of the USA Patriot Act of 2001.

At the Justice Department, in my prior service in 2003 to 2005, I am proud of the work I did in helping guide the U.S international efforts in establishing Intellectual Property working groups with Taiwan, Korea, and other foreign trading partners to ensure that the proper respect and attention is paid to intellectual property rights.

In my practice representing parties to mergers or parties that have concerns about particular pending mergers, in addition to legal counseling, I have registered to lobby, often taking a broad reading of the Lobbying Disclosure Act on the advice of outside counsel. My involvement in these mergers for which I registered as a lobbyist involved assisting the company in presenting the transaction or its interest in the transaction before members of the Senate Judiciary Committee or before the DOJ or FTC, as needed. I would also help

prepare the company representative in her testimony before the Senate or House Judiciary Committees. My compensation will depend on a number of factors, but generally is based on 50% of the adjusted revenues Pilgrim receives.

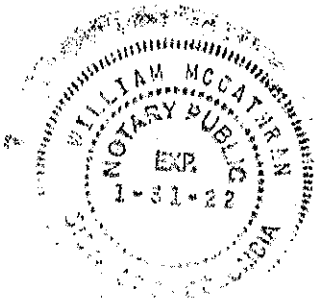
