Dear Chairman Graham and Ranking Member Feinstein:

Amy Coney Barrett will be an outstanding Supreme Court Justice. As her former law clerks, we know this from experience.* We have witnessed firsthand Judge Barrett's dedication to the law as a principled, independent judge. We have also come to know her as a warm, caring person whose intellect is matched only by her generosity and compassion. We unanimously support her nomination and have no doubt that she will continue to serve our country with great distinction if confirmed to our nation's highest court.

Judge Barrett's brilliance as a legal scholar is well known. We saw that brilliance in action every day. She demonstrated a singular ability not only to distill complex issues but also to spot wrinkles that everyone else had missed. In every case, she tirelessly worked to explain the law in a way that was clear, precise, and accessible to all.

Judge Barrett taught us that a good judge will not always like the results she reaches; a good judge goes wherever the law leads. And she instilled in us the value of debate and discussion as a useful compass on that quest. She welcomed disagreement, and she engaged every argument with respect and attention.

Judge Barrett approached differences with her colleagues in the same way, never giving their views short shrift and never taking disagreements personally. She instead approached each discussion with an open mind and collegial spirit, believing that the project of ensuring equal justice is a shared one, and it can only be accomplished by honest judges engaging together in good faith.

Judge Barrett's impact extends beyond the courtroom. Both professionally and personally, we all look to her as a mentor and role model. Her career gives us confidence that we need not choose between a successful professional life and a fulfilling personal life. She consistently demonstrated how best to balance the two, a skill that was
