Working with him during various periods throughout his career as an AUSA provided us with a complete perspective of him as an attorney, a jurist, and a man. With this knowledge, we enthusiastically convey our unequivocal support for the nomination of Kevin G. Ritz to the United States Court of Appeals for the Sixth Circuit.

As former colleagues, we vouch for Kevin's high legal acumen and sound judgment. Kevin possesses a unique affinity for the law that we all admire.
