i. the general character of your law practice and indicate by date when its character has changed over the years.

From the fall of 2003 to December of 2007, I served as a Deputy Prosecuting Attorney in Benton County. I handled a wide variety of cases as a Deputy Prosecuting Attorney, including misdemeanor DWI cases all the way up to murder cases. I tried several jury trials during this four-year period and appeared in Court frequently (usually at least three days per week).

In December of 2007, I began work as an Assistant United States Attorney in Fort Smith, Arkansas, in the Western District of Arkansas. I began my federal prosecution career by serving as the coordinator for the Project Safe Neighborhood (PSN) program in Western Arkansas. In this position, I prosecuted numerous illegal firearm possession cases, violent criminal cases, cases involving the use and possession of firearms in furtherance of drug trafficking crimes, and child exploitation cases. In 2011, I was awarded the EOUSA Director's Award for Superior Performance by a Litigative Team for my work in the United States v. Tony Alamo investigation and jury trial. Later in 2011, I became the lead task force attorney for the Organized Crime Drug Enforcement Task Forces (OCDETF) program in Western Arkansas. From 2011 to 2014, I prosecuted numerous cases involving multi-jurisdictional large scale drug trafficking organizations. I routinely reviewed and prepared wiretap applications and I indicted and prosecuted entire drug trafficking organizations, some of which included more than 40 total defendants convicted and sentenced to federal prison. It was during this time that I was awarded the EOUSA Director's Award for Outstanding Performance by a Criminal AUSA.

I am currently serving as the United States Attorney for Western Arkansas. I served as the Acting United States Attorney under the Vacancy Reform Act beginning on January 20, 2020. I was appointed by the Court to serve as the United States Attorney on November 17, 2021.

Prior to serving as the United States Attorney, I served as the First Assistant United States Attorney and supervised the Civil and Criminal Divisions in Western Arkansas. Prior to that, I was the Criminal Chief and Deputy Criminal Chief in Western Arkansas. During my time leading the office, we have made tremendous strides towards our ultimate goal of making Western Arkansas a safer and better place. As the United States Attorney, I began a response team for drug poisoning deaths that incorporated federal and state agents specifically trained to investigate death cases and the distribution of fentanyl. This team has worked very hard to make sure that every drug poisoning death in Western Arkansas is properly investigated and the drug dealers held accountable. Additionally, under my leadership our office has prosecuted over three times the national average number of child abuse and exploitation cases. During my time as the United States Attorney, my courtroom appearances decreased due to my focus on meeting with law enforcement officers to learn about criminal trends in Western Arkansas and spending time developing strategies to make our communities safer. I have also spent time developing and updating policies to include a new criminal division manual, a new discovery policy, and new intake processes.

As an Assistant United States Attorney, I prosecute criminal cases on behalf of the United States.

The entirety of my practice has been in litigation. As a Deputy Prosecuting Attorney in Benton County, I appeared in state court frequently for hearings, oral arguments, and jury trials. As an Assistant United States Attorney, I have similarly appeared in federal court frequently for hearings, oral arguments, and jury trials. From December 2007 to April of 2013, I appeared in court at least twice a week for hearings, oral arguments, and jury trials.  - 1. State of Arkansas v. Ramon Sanchez, Benton County Case Number 04CR-04-1166 (Benton County, Arkansas, 2005) (J. David Clinger) (Representation: 2004 – 2005).

This case involved the hit-and-run killing of a man in Rogers, Arkansas. The investigation conducted by the Benton County Sheriff's Office revealed that an illegal alien who unlawfully entered and remained in the United States drove a truck while intoxicated and ran over a competitive bicyclist training for an upcoming competition. The incident occurred during the early morning hours, and the driver fled the scene without stopping. The driver eventually fled back to Mexico (the driver was later extradited back to Benton County, Arkansas, where he received the maximum sentence for negligent homicide in a separate case). The investigation further showed that another individual, Ramon Sanchez, fraudulently used his own lawful resident status to purchase the truck and insurance for the truck used in the hit-and-run, thereby allowing the driver of the vehicle to own and drive a truck that he would otherwise be prohibited from operating as an illegal alien. As chief counsel on this case, I prepared all the investigative documents and the charging documents. I also served as the lead attorney for the trial team during the Ramon Sanchez jury trial. I charged Sanchez with Filing a False Police Report and Insurance Fraud stemming from his actions surrounding the DWI fatality accident that occurred in western Benton County. The jury returned a verdict of guilty on both counts and recommended a maximum sentence of five years in the Arkansas Department of Correction. Judge David Clinger sentenced Mr. Sanchez accordingly. The Department of Homeland Security deported Ramon Sanchez after he served his sentence in the Arkansas Department of Corrections.

3. State of Arkansas v. Darra Barritt, Benton County Case Number 04CR-05-477 (Benton County, Arkansas 2004 – 2005) (J. Tom Keith) (Representation: 2004 – 2005)

The defendant in this case was charged with one count of Battery in the First Degree for shaking her two-month-old child, causing severe and permanent injuries. I was the chief counsel for this case, and I tried this case before a jury in Benton County, Arkansas. The case centered around the severe injuries to the child and how they were caused. I presented expert witnesses from the Arkansas Children's Hospital and cross-examined an expert witness provided by the defense. The jury convicted Mrs. Barritt and recommended a sentence of fifteen years in the Arkansas Department of Correction. Judge Tom Keith sentenced the defendant to twelve years in the Arkansas Department of Correction. 5. United States v. Torrance Bunch, et al., No. 2:10-CR-20024, Western District of Arkansas, Fort Smith Division (2010) (J. Robert Dawson) (Representation: 2010 – Present).

This case involved a drug trafficking organization operating in Fort Smith, Arkansas. Two of the leaders of the organization, Torrance Bunch and Fernando Sanchez-Garcia, were involved in the distribution of large quantities of methamphetamine in the Fort Smith, Arkansas, area. During Torrance Bunch's jury trial, one of the cooperating coconspirators, who was also charged in this case, testified to the jury that Torrance Bunch and Fernando Sanchez-Garcia operated a drug trafficking group that was the only organization that was capable of supplying large quantities of high-quality methamphetamine to drug dealers in Fort Smith, Arkansas. Torrance Bunch was sentenced to life in prison under the habitual offender provision in the federal drug trafficking statutes.

The investigation did not stop with Bunch and Garcia's arrest. The investigative team continued to work on this case until Bunch's source of supply for methamphetamine (Orlando Lira-Ibarra) was located, arrested, and prosecuted in the Western District of Arkansas. In all, we were able to prosecute a total of 27 individuals for their involvement in drug trafficking in Western Arkansas. As the chief counsel for this case, I was responsible for preparing all of the investigative documents, including search warrants and other applications for surveillance techniques. I was also responsible for preparing all the indictments, pretrial motions, sentencing arguments, and appeal briefs. I represented the United States at every court hearing and was lead counsel for the trial team during the Torrance Bunch and Fernando Sanchez-Garcia jury trial. The Court sentenced Bunch to life in prison and Sanchez-Garcia to 324 months in prison.

6. United States v. Jose Machado, et al. (Operation Pantera Negra), No. 5:12-CR-50008, Western District of Arkansas, Fayetteville Division (2011 – 2012) (J. Jimm Hendren) (Representation: 2010 – Present).

This case targeted a drug trafficking organization operating in Springdale, Arkansas. The investigation began with an individual named Wilver Rosales and eventually uncovered a

large organization that was affiliated with the La Familia drug cartel in Mexico. The organization used members in Texas and Mexico to smuggle methamphetamine into the United States and eventually into Western Arkansas. As the sole counsel for this case, I was responsible for preparing all the search warrants, applications for surveillance techniques, indictments, and sentencing memorandums. I also represented the United States in every court proceeding, including contested sentencing hearings and one jury trial. My work on this case resulted in over 30 convictions for drug trafficking, several indictments against known cartel members, the seizure of hundreds of pounds of methamphetamine, and the seizure of numerous firearms, including several automatic weapons. This organization utilized numerous stash houses in Arkansas and Texas. As an example of the organization's distribution of large quantities of methamphetamine, in one stash house located in Dallas, Texas, the DEA seized over 100 pounds of methamphetamine and a machine gun.

7. United States v. Arturo Vaca-Raya, et al. (Operation West End Gambler), No. 13-CR-50002, Western District of Arkansas, Fayetteville Division (2012 – 2013) (J. Jimm Hendren) (Representation: 2012 – Present)

This investigation began in October of 2012 when the DEA received information about an organization that was involved in distributing large quantities of methamphetamine in Northwest Arkansas. Arturo Vaca-Raya, who resided in Springdale, was identified as the leader of this organization. As a result of the investigation, law enforcement agencies were able to identify 12 associates of Vaca-Raya who were also involved in the distribution of methamphetamine. Through the investigation, law enforcement agencies learned that Vaca-Raya was involved in smuggling large quantities of methamphetamine into Northwest Arkansas and distributing the methamphetamine to other drug dealers in Arkansas and Oklahoma. On December 2, 2012, the DEA learned that Vaca-Raya was expecting a large shipment of methamphetamine and placed his residence under surveillance. During the surveillance, the agents observed a co-conspirator from Texas named Maria Molina bring Vaca-Raya what appeared to be a large quantity of methamphetamine. Vaca-Raya was arrested later that day. The next day, on December 3, 2012, the DEA executed a search warrant on his residence. During the search, the agents recovered approximately 6.9 kilograms of methamphetamine, digital scales, a

firearm, and ammunition. Vaca-Raya eventually entered a plea of guilty to the indictment and the Court imposed a sentence of 40 years in prison based on the large quantities of methamphetamine his organization distributed and Vaca-Raya's lengthy criminal history including violence and firearm convictions. I was the sole counsel in this case. I prepared all of the Title III Applications for Wire and Electronic Interceptions, I submitted the case to the Grand Jury for indictment, prepared all plea agreements, and made all of the arguments to the Court during contested sentencing hearings. Vaca-Raya had been one of the most prolific methamphetamine distributors in Northwest Arkansas for many years prior to this case. In addition to seizing a large amount of methamphetamine, we were also able to forfeit several hundred thousand dollars in cash and property that Vaca-Raya used to facilitate his distribution of methamphetamine.

8. United States v. Miguel Paramo, et al. (Operation Great Scott), No. 2:12-CR-20043, Western District of Arkansas, Fort Smith Division (2012 – 2013) (J. P.K. Holmes) (Representation: 2012 – Present)

This case targeted a drug trafficking organization operating in Waldron, Arkansas. The organization took advantage of the reduced law enforcement presence in small, rural communities like Waldron to organize the smuggling and distribution of methamphetamine to larger communities, such as Fort Smith and Fayetteville. The organization also used minors to transport and distribute methamphetamine as another way of concealing their drug trafficking operations. Various law enforcement techniques resulted in the identification of numerous members of the organization and the location of stash houses in both Arkansas and Texas. Over forty controlled purchases of methamphetamine were conducted with members of the organization, as well as several controlled purchases of marijuana. As a result of the investigation, 19 individuals were arrested. In addition, 28 firearms, 12 pounds of methamphetamine, \$49,800, over 100 pounds of marijuana, and 2 bullet-proof vests were seized from members of the organization. As the chief counsel for this case, I was responsible for the preparation of all of the investigative documents, including numerous search warrants and other applications for surveillance. I was also responsible for preparing the indictment for all 19 of the members charged in the case. I represented the United States in every court proceeding and successfully won convictions on all 19 of the defendants in this case. In 2014, I was recognized with the EOUSA's Director's Award for Superior Performance by a Criminal AUSA for this case and other drug trafficking investigations and cases I worked on.

9. United States v. Gerardo Gamboa, et al. (Operation Shawcrank Redemption), No. 2:13-CR-20037, Western District of Arkansas, Fort Smith Division (2013) (J. P.K. Holmes) (Representation: 2013 – Present)

This case targeted a significant drug trafficking operation within the Fort Smith Division of the Western District of Arkansas. Gerardo Gamboa was directly communicating with a member of the Drug Trafficking Organization (DTO) in Mexico and coordinating substantial shipments of methamphetamine destined for Fort Smith, Arkansas. Following a two-year investigation, we successfully indicted and convicted 41 members of the DTO, including the individual operating in Mexico. This case held immense significance as it marked the largest DTO prosecuted in the Fort Smith Division in several years. As the chief counsel for this case, I was solely responsible for all aspects of the investigation and prosecution of every member of this organization. My duties included preparing all investigative documents, Search Warrants, indictments, plea agreements, motions, and sentencing arguments. I represented the United States in every court proceeding, successfully presenting arguments before the Court in each case.

10. United States v. Paul Petersen, No. 5:19-CR-50079, Western District of Arkansas, Fayetteville Division (2020) (J. Timothy L. Brooks) (Representation: 2015 – Present).

This case stands as the first human trafficking case involving a group of individuals who specifically targeted the Marshallese people. Also notably, it was the first such case to be prosecuted within the United States under the theory advanced by the indictment I prepared and defended in the District Court and on Appeal to the Eighth Circuit Court of Appeals. The case involved a group of defendants, including Paul Petersen, a licensed attorney who practiced law in Arizona, Utah, and Arkansas. Beginning in 2014, Petersen devised a fraudulent scheme to defraud and obtain money and property from unsuspecting adoptive parents and others. He paid pregnant Marshallese women substantial amounts of United States currency, compelling them to travel to the Western District of Arkansas and subsequently place their infants for adoption in the same district. Petersen procured airline tickets for them and orchestrated their concealment of their true travel intentions from the authorities in the Republic of the Marshall Islands and the United States. In furtherance of this scheme, Petersen manipulated adoption case files, presenting documents that contained materially false and fraudulent statements. He subsequently filed these court documents in the Circuit Clerk's Offices of Washington and Polk counties and further distributed case documents via the United States mail to government offices in Little Rock, Arkansas. Petersen concealed his involvement in the payments and conducted wire transactions to transfer over one million dollars into a bank account. He eventually pleaded guilty to the indictment. I requested that the Court impose a sentence of 10 years in prison, considering the severe criminal conduct in this case. The Court, after a contested sentencing hearing, determined that a sentence of 74 months in prison was appropriate. As chief counsel in this case, I handled every aspect of the investigation and the prosecution. I developed the legal theory that enabled me to prosecute Petersen and his co-conspirators. I also traveled to Marshall Islands and spent a week there interviewing witnesses, gathering evidence, and preparing the case for presentation to the Grand Jury.

This has given me a unique perspective of the criminal issues facing our communities in Western Arkansas. I have also been able to guide our office to several important milestones, including leading our office to prosecute child exploitation cases at over three times the national average. I have also been able to lead our office to achieve significant progress in reducing drug poisoning deaths caused by the distribution of fentanyl. I began a program we refer to as our Overdose Response Team, made up of officers and agents from various agencies who take the lead in our district in investigating and prosecuting drug poisoning cases.
