All seven defendants were convicted of RICO conspiracy. Four pleaded guilty before trial. Sontez Wells was sentenced to 144 months. Andre Chattam was sentenced to 132 months. Corey Toney and Kevin Pearson were each sentenced to 90 months. The remaining three defendants pleaded guilty approximately seven weeks into their jury trial. Capsule summary:

I led the prosecution for the United States in a HSI, Detroit Police Department, and Dearborn Police Department investigation into a violent drug and sex trafficking operation that controlled the Victory Inn hotel in southwest Detroit. Agent rescued 14 sex trafficking victims during the raid. We also brought in federal forfeiture attorneys and the City of Detroit legal department to shut down the hotel after the raid. All nine defendants were convicted. Seven pleaded guilty before trial to various drug and sex trafficking crimes. Shervie Avery was sentenced to 228 months. Terry Pruitt was sentenced to 188 months. Michael Randol was sentenced to 180 months. Charles Ford was sentenced to 144 months. And the two hotel clerks, Jack Yako and Kemal Gabrail, were sentenced to probation. Darrick Bell was convicted at trial of various drug crimes and sentenced to 336 months. Harold Nero pleaded after the jury could not reach a verdict on all of his charges and was sentenced to 115 months.

Deshawn Langston was sentenced to 240 months. Tyree Williams was sentenced to 210 months. Carlos Davis was sentenced to 180 months. Korey Sanders was convicted of RICO conspiracy and a drug and firearm crime and sentenced to 72 months. Jerray Key was convicted of RICO conspiracy and a gun charge and sentenced to 72 months.
