In that capacity, I held assignments as defense counsel, operational law attorney, and legal assistance attorney. In 1998, I served as labor lawyer for the U.S. Navy's Office of General Counsel. In 2004, I was ordered to active duty. At that time, I served again as an operational law attorney. In 2007, I served as an attorney/advisor.

As a reservist serving as a judge advocate I have held several positions. In 1997, I served as a staff attorney. From 1998 to 2003, I was an appellate counsel. From 2003 to 2009, I served as a staff attorney.

Since 1998, I have been employed by the U.S. Department of Justice as an Assistant United States Attorney. I was a criminal prosecutor in the District of Nevada until 2000. I then accepted a position as an Assistant United States Attorney for the Middle District of Louisiana in the office's Criminal Division. I remained in the Criminal Division until 2010, when I was promoted to First Assistant United States Attorney.

- *Nation of Iraq v. Ali Hassan Majid (Chemical Ali) et al.*

I served as principal advisor to Iraqi prosecutors assigned to the Anfal trial, which trial consisted of numerous international law violations. These violations resulted in the death of thousands of civilians. All six members of the former regime were convicted at trial. Notably, Ali Hassan Majid was sentenced to death as a result of the guilty verdict on war crimes, crimes against humanity, and genocide.

This investigation involved the large-scale draining of the marshes in southern Iraq which resulted in the death and displacement of tens of thousands of Iraqis. I submitted a draft of the referral (indictment) to be used in later proceedings.

The Louisiana State Commissioner of Elections pled guilty to tax charges. The Commissioner had accepted over \$900,000 in kickbacks during his term and was convicted for not reporting the kickbacks on his

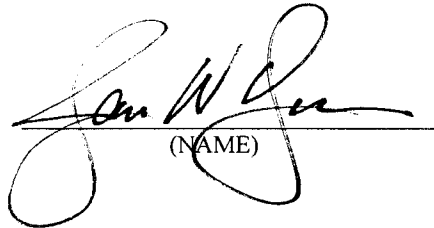
