Circuit Judge, Oakland County/State of Michigan, 2015 – Present. I was appointed by then-Michigan Governor Rick Snyder to this position in 2015 and, following an election, was elected in 2016. The Oakland County Circuit Court has jurisdiction over felony criminal cases and civil cases in which the amount in controversy exceeds \$25,000. I have served from the time of my appointment to the present (2015 – Present) in both the civil and criminal divisions.

All the opinions I issue are unpublished. The opinions are electronically filed with the case.

As a state trial court judge presiding over a civil and criminal docket, I hear and rule on a large volume of matters. My total number of active cases averages between 450 to 500 cases at any given time. I also hear and rule on matters post-judgment, post-settlement, and post-sentencing. On average, I hear and rule on four summary disposition motions every week; opinions are usually written and filed soon after. I sometimes will issue opinions on other civil matters, as well as on criminal matters. All opinions are electronically filed in the case the opinion pertains to (with counsel receiving those opinions electronically as the attorneys of record). Opinions are sent via United States mail to those individuals who are not listed on the electronic filing system for that case (for example, a defendant in prison who files an in pro per matter).

1. *People of the State of Michigan v. Bennie L. Layton*, Oakland County Circuit Court Case No. 1996-143720-FC

Mr. Layton was convicted of first-degree murder after a jury trial in 1996, when he was 17 years old. He was sentenced to mandatory life in prison. After the United States Supreme Court’s decisions in *Miller v. Alabama*, 567 U.S. 460 (2012) and *Montgomery v Louisiana*, 136 S.Ct. 718, 577 U.S. ____ (2016), Mr. Layton, as a “juvenile lifer,” was eligible for resentencing. I did not preside over Mr. Layton’s trial in 1996; I took over his case when I took the bench in 2015. On December 18, 2017, I resentenced Mr. Layton to 35 to 60 years with the Michigan Department of Corrections. Prior to resentencing, I reviewed everything associated with the case, including but not limited to: the entirety of the trial transcripts, the probation department’s recommendation, the parties’ sentencing memoranda, the presentence investigation report, the Michigan Department of Corrections central file, and Mr. Layton’s recent psychological

evaluation. The resentencing was appealed to the Michigan Court of Appeals, which affirmed the sentence. Mr. Layton has filed an application with the Michigan Supreme Court.

2. Novi Hospitality LLC v. Central Ceiling & Partition, Inc. and Gaman Group, Inc., Oakland County Circuit Court Case No. 2013-133660-CK

Novi Hospitality filed a breach of contract lawsuit related to the alleged improper construction of a hotel, specifically improper installation of drywall that caused unacceptable noise levels in the guest rooms of the hotel. The victim in the case testified that he was walking on Baldwin Avenue in the City of Pontiac, when he encountered a woman with whom he had previously exchanged sexual favors. They went to the victim's home where the victim paid the woman for another sexual encounter. The woman then left and went to the store. When she returned to the victim's home, the woman asked the victim if he wanted to get high. The victim agreed and the woman called a drug dealer. Cases Reversed:

Cichewicz v. Salesin, Michigan Court of Appeals No. 330301 (Oakland County Circuit Court Case No. 2011-120900-NH). Unpublished opinion supplied. In this wrongful-conception case, plaintiff appealed by leave granted on my order granting defendants' motion in limine precluding testimony or evidence regarding her claim for emotional distress damages. These arose from her knowledge that her child would be born with Down Syndrome. The Court of Appeals issued an opinion in a prior appeal finding that although plaintiff could not seek damages for raising the child, she was entitled to recover traditional medical-malpractice damages related to the alleged wrongful conception. *Cichewicz v. Salesin*, 306 Mich App 14, 33; 854 NW2d 901 (2014). Plaintiff argued that the damages she sought fell within the prior ruling, and the Court of Appeals agreed. The Court of Appeals held that plaintiff's claim for emotional distress arising from her knowledge that her child would be born with Down Syndrome fell within traditional medical malpractice damages. The case was reversed and remanded.

Novi Hospitality v. Central Ceiling, Michigan Court of Appeals No. 333086 (Oakland County Circuit Court Case No. 2013-133660-CK). Unpublished opinion supplied. In this breach of contract action involving the construction of a Holiday Inn Express Hotel and Suites in Novi, Michigan, plaintiff, Novi Hospitality, LLC, appealed as of right a judgment of no cause of action, which I entered following a nine-day jury trial. The jury returned a verdict finding that defendants, Central Ceiling & Partition, Inc. and Gaman Group, Inc., did not breach their respective construction contracts with Novi Hospitality. The Court of Appeals affirmed my order denying Novi Hospitality's motion for judgment notwithstanding the verdict, or, in the alternative, for a new trial, and affirmed the jury's verdict. The Court of Appeals also affirmed my order regarding case evaluation sanctions on the issues of attorney fees awardable to LeFevre, non-expert litigation costs, and expert costs. The Court of Appeals reversed, however, my order regarding case evaluation sanctions on the issue of attorney fees awardable to Mellon and Kowalski and remanded for entry of an order awarding the bifurcated rates charged by Mellon Pries and awarding attorney fees for the work performed by attorneys Heid and Solman.

Bass v. Peters, Michigan Court of Appeals No. 332217 (Oakland County Circuit Court Case No. 2015-150655-NM). Unpublished opinion supplied. Plaintiff appealed my dismissal of her case when I granted the defendant's motion for summary disposition on grounds of res judicata. The Court of Appeals held that the purpose of res judicata is to relieve the parties of the cost of multiple lawsuits, conserve judicial resources, and prevent inconsistent decisions thereby encouraging reliance on adjudication. The Court of Appeals found that none of the purposes underlying res judicata applied in the case. The case was reversed and remanded.

Nielsen v. Safeguard, Michigan Court of Appeals No. 333244 (Oakland County

Circuit Court Case No. 2015-149178-NZ). Unpublished opinion supplied. Defendant, Safeguard Properties, works with mortgage companies nationwide to secure properties that have been vacated following a mortgagor's default. In this case, Safeguard's agents entered a home that was occupied but secured it anyway, resulting in inconvenience and expense to the homeowner. I granted the defendant's motion for summary disposition. Plaintiff appealed the dismissal of his trespass and conversion counts, as well as his challenges based on the federal Fair Debt Collection Practices Act, 15 USC 1692 *et seq.* (FDCPA), the Michigan Regulation of Collection Practices Act, MCL 445.251 *et seq.* (MRCPA), and the Michigan Occupational Code, MCL 339.901 *et seq.* (MOC) through the granting of defendant's motion for summary disposition. The Court of Appeals held that I properly dismissed the claims under the FDCPA, MRCPA, and MOC as Safeguard is not a debt collector. However, the Court of Appeals held that I erred in dismissing the trespass and conversion claims because the evidence supported that Safeguard and its contractor acted in concert pursuant to a common design (agency). Further, the Court of Appeals held that I did not abuse my discretion in denying plaintiff's motion to amend its complaint. The opinion affirmed my decision in part, vacated in part, and remanded for further proceedings.

Comerica Bank v. Kelman, Michigan Court of Appeals No. 336637 (Oakland County Circuit Court No. 2012-124821-CK). Unpublished opinion supplied. Defendant appealed as of right my order denying his objection to the writ of garnishment issued to garnishee-defendant, Birmingham Bloomfield Credit Union ("BBCU"). Plaintiff, Comerica Bank, issued a writ of garnishment to BBCU after Kelman defaulted on a home equity loan. Kelman objected to the writ of garnishment, arguing that the account funds included disability payments that were exempt from garnishment pursuant to MCL 600.6023(1)(f) and that the garnishment exceeded the statutory maximum under the federal Consumer Credit Protection Act ("CCPA"), 15 USC 1671 *et seq.* The Court of Appeals held that to the extent that the disability payments were the source of the account funds, the disability payments deposited into Kelman's BBCU account were exempt under MCL 600.6023(1)(f). Accordingly, the exemption applies even after the disability payment is deposited into an account. The Court of Appeals found that I did not make factual findings as to whether the BBCU account contained exempt funds, including what amount of the BBCU account reflected disability payments. Therefore, the case was remanded for me to determine what amount of the BBCU account balance, if any, was subject to garnishment. The Court of Appeals vacated my order denying Kelman's objection to the writ of garnishment issued to BBCU and remanded for further proceedings. A partial concurrence/dissent in the case agreed with the majority to the extent that the majority concluded that any disability payments deposited into Kelman's BBCU account were exempt under MCL 600.6023(1)(f). However, the concurring/dissenting judge wrote separately to point out that review of the record did not yield any documentary evidence supporting Kelman's contention that his disability payments were deposited into his BBCU account. The judge dissented, finding the remand unnecessary.

Toteff v. Hemming, Michigan Court of Appeals No. 337182 (Oakland County Circuit Court No. 2015-147155-NM). Unpublished opinion supplied. Defendants, Joseph H. Hemming and Law Offices of Joseph H. Hemming, appealed as of right a judgment for plaintiff, Thomas Toteff, following a jury trial in this legal malpractice action. Hemming argued that I erred by excluding court-ordered psychological evaluations, a personal protection order (PPO), and evidence that Toteff failed to file tax returns. The Court of Appeals held that I abused my discretion by excluding the PPO and the psychological reports on the basis of hearsay. The Court of Appeals held that the PPO and psychological reports were not being offered to prove the truth of the allegations that Toteff abused his ex-wife but rather to establish that Hemming had a reasonable basis for advising Toteff to settle the divorce case given that the abuse allegations would have been damaging to him at trial. A limiting instruction could have been provided to ensure that the jury in this case only considered the evidence for the purpose of determining whether Hemming's advice to Toteff was reasonable. The case was reversed, retried again before a jury and the plaintiff was awarded a larger judgment than after the first trial.

Schafer and Weiner PLLC v. Dreyfuss, Michigan Court of Appeals No. 343371 (Oakland County Circuit Court Case No. 2015-145121-CK). Unpublished opinion supplied. Plaintiff appealed from my order granting summary disposition in favor of garnishee defendant, Oakridge Manor Nursing & Rehabilitation Center pursuant to MCR 2.116(C)(10). The Court of Appeals held that I had addressed the wrong question. I addressed the question of whether there was legally adequate consideration to prevent the contract from failing for a lack of consideration. But the Court of Appeals held that I should have addressed the question of whether there was a genuine issue of material fact regarding whether there was "reasonably equivalent value" given and whether plaintiff could establish a right to a remedy under Uniform Fraudulent Transfer Act (UFTA), MCL 566.31 *et seq.* The Court of Appeals reversed and remanded for further proceedings.

Van Fleteren Jr v. Shugar, Michigan Court of Appeal No. 341458 (Oakland County Circuit Court Case No. 2017-159547-CK). Unpublished opinion supplied. Plaintiff appealed as of right my order granting defendants, Thomas J. Shugar and Kelsey A. Shugar, summary disposition. Additionally, plaintiff argued that I erred after granting defendants summary disposition by failing to take evidence to determine whether plaintiff was entitled to compensation for any improvements that he made to the real property under MCR 3.411(F). The Court of Appeal held that I committed error when I failed to follow the procedure provided in MCR 3.411(F) and hold a hearing to determine whether plaintiff had a right to recover any value corresponding to the improvements that he made to the property. The Court of Appeals affirmed my opinion and order granting defendants summary disposition but reversed to the extent that my order denied plaintiff the opportunity to claim the value of improvements. The matter was

remanded for a hearing in accordance with MCR 3.411(F). This case settled prior to the scheduled hearing date.

Life Skills Village, PLLC, and Life Skills Residential, LLC v. Nationwide Mutual Fire Insurance Company, Michigan Court of Appeals No. 345237 (Oakland County Circuit Court Case No. 2017-160986-NF). Unpublished opinion supplied. Plaintiff Life Skills Residential, LLC, (LSR) appealed my granting of defendant Nationwide Mutual Fire Insurance Company's (Nationwide) summary disposition ruling on the grounds that plaintiff LSR was operating as an unlicensed adult foster care facility. LSR had also filed a summary disposition motion as the nonmoving party entitled to judgment. At issue was whether under the statutory definition of adult foster care, LSR provided "personal care" and "room and board" to the underlying claimant. The Court of Appeals reversed my ruling granting summary disposition in favor of Nationwide holding that LSR was not required to be licensed as a foster care facility but affirmed my ruling to deny LSR summary disposition. The opinion affirmed my ruling in part, reversed my ruling in part, and remanded for further proceeding.

To my knowledge, I have not had any judgments affirmed with significant criticism of my substantive or procedural rulings.

All the opinions I issue are unpublished. The opinions are electronically filed with the case.

As a state trial court judge presiding over a civil and criminal docket, I hear and rule on a large volume of matters. My total number of active cases averages between 450 to 500 cases at any given time. I also hear and rule on matters post judgement, post settlement, and post sentencing. On average, I hear and rule on four summary disposition motions every week; opinions are usually written and filed soon after. I sometimes will issue opinions on other civil matters, as well as on criminal matters. All opinions are electronically filed in the case the opinion pertains to (with counsel receiving those opinions electronically as the attorneys of record). Opinions are sent via United States mail to those individuals who are not listed on the electronic filing system for that case (for example, a defendant in prison who files an in pro per matter).

Guy Barron v. Lori Barron, Oakland County Circuit Court No. 19-175255-PD. I noticed this case on my list of upcoming summary disposition motions and recused myself sua sponte, on the record, the next day on August 7, 2019. The case involves a lawsuit related to alleged marital property by Guy and Nora Barron against their daughter-in-law, the defendant, who is in the middle of a divorce case with their son, Judge Marc Barron. Judge Barron is a former colleague of mine from the Oakland County Prosecutor's Office. I personally know all the parties and have socialized with all of them. To avoid the appearance of impropriety, I recused myself.

People of the State of Michigan v. Melvin Jarbo, Oakland County Circuit Court Case No. 2018-268400-FH. At the arraignment, when the defendant first appeared before me, I recused myself sua sponte. The case involved drug charges and although I did not know or recognize the defendant, there was some distant familial relationship, according to the defendant.

People of the State of Michigan v. Kevin Jay Jarbo, Oakland County Circuit Court Case No. 2018-268419-FH. At the arraignment, when the defendant first appeared before me, I recused myself sua sponte. The case involved drug charges and although I did not know or recognize the defendant, there was some distant familial relationship, according to the defendant.

Keith Jay Vanwagner v. Yousif G. Jarbo and Ghassan N. Jarbo, Oakland County Circuit Court Case No. 2019-174639-NI. This civil case was filed sometime in 2019 but first came to my attention on February 19, 2020 when the attorneys appeared before me on a motion. Although I did not believe I knew the defendants, there was a possibility of some familial relationship. To prevent even an appearance of impropriety, I recused myself sua sponte.

Winning Strategies v. Kathleen Ryan and Kathleen Ryan For Probate Judge, Oakland County Circuit Court Case No. 2020-179162-CZ. This is a civil case filed against one of the judges in my courthouse. Although I felt that I could preside over the case fairly and impartially, to prevent even an appearance of impropriety, I recused myself sua sponte.

I have declined recusal in the following case:

Bank of the West v. Patrick Smorra, Anita Smorra, the Smorra 2004 Revocable Trust, Oakland County Circuit Court No. 2018-169078-CZ. I did not realize until after the parties argued a summary disposition motion in front of me on October 23, 2019 that I had met one of the attorneys at my judicial investiture (he was a guest of one of my brothers and had done some legal work for him). That attorney (Miroslav Vlcko) called my office the afternoon after the motion was heard, asked to speak with me on a personal matter, and when I returned the call, he told me of meeting me previously at my judicial investiture. That evening I inquired of my brother who the attorney was. My brother informed me that he brought Mr. Vlcko to my judicial investiture and Mr. Vlcko was doing some legal work for him at the time. My brother also informed me that he was involved in a pending lawsuit with Mr. Vlcko regarding legal fees. Immediately the next day October 24, 2019, I revealed the conversation to all the parties on the record, I informed all parties of the very brief meeting and my inability to recall meeting him until he told me; I also informed them of the very brief telephone conversation the day before, and revealed that there was a pending lawsuit between Mr. Vlcko and my brother. Mr. Vlcko withdrew from the case the morning I held a status conference on the record to inform everyone. Mr. Vlcko had co-counsel on the case who maintained representation. The other side moved to recuse me. I declined the recusal on October 25, 2019. I did not feel the brief meeting at my judicial investiture was grounds for recusal; I also stated on the record that there were attorneys from the moving party's firm at my judicial investiture and one of those attorneys was the master of ceremonies. I also did not feel that the pending lawsuit between my brother and Mr. Vlcko (that I did not

know about until that time) was a basis to recuse myself, especially considering Mr. Vlcko's withdrawal from the case. I did not feel any of this would prevent me from being fair and impartial to both sides. The case settled weeks later.

I started in that office with an assignment in the Warrants Division, reviewing and authorizing complaints; I was then assigned to the District Court Division, prosecuting misdemeanor cases and holding preliminary examinations on felony matters in various district courts in the county; I was then assigned to the Parole Appeal Section, where I appeared at parole hearings and appealed the decision of the parole board, where appropriate; I then held various assignments in the Circuit Court Division – in the General Circuit Court Division handling general felony matters through trial and sentencing; in the Child Sexual Assault Section handling specialized child sexual assault cases through trial and sentencing; in the Major Crimes Unit handling murder and high profile cases through trial and sentencing.

2. *People of the State of Michigan v. James Edward Terry*, Oakland County Circuit Court Case No. 2003-189994-FC

Mr. Terry had previously served a prison sentence for sexually assaulting his sister-in-law. After his return home from prison, he soon began to sexually assault his three minor daughters. A teacher asked one of the daughters about a burn on her arm, and the child indicated that her father had done it; all three daughters were forensically interviewed and revealed both physical and sexual abuse. The mother did not believe her daughters and

indicated to Child Protective Services that her daughters had disclosed to her what their father was doing but that he had denied such actions and she believed him. The case was tried before a jury and all three daughters had to testify against their father, while he sat across from them at the defense table. The youngest witness I ever put on the stand was Mr. Terry's youngest daughter (who I believe was four years old at the time). The jury convicted Mr. Terry of four counts of First Degree Criminal Sexual Conduct. Mrs. Terry's rights to her children were also terminated.

Mr. Boulding, who was confined to a wheelchair, was charged with sexually assaulting his minor granddaughter. During the investigation leading to trial, the minor's mother (Mr. Boulding's daughter) revealed to me that I should obtain a DNA sample of her minor son. That DNA test revealed that Mr. Boulding was that minor son's father (in other words, Mr. Boulding had also fathered his own grandson). According to Mr. Boulding's adult daughters, all had been repeatedly sexually assaulted by their father and he had continued with the granddaughter, the victim in this case. Mr. Boulding was convicted after a jury trial of three counts of First Degree Criminal Sexual Conduct and acquitted of one similar count.

4. *People of the State of Michigan v. Kevin Ross Munro*, Oakland County Circuit Court Case No. 2007-214455-FH

Mr. Munro owned some type of construction company. He was driving a work truck one day and encountered some traffic on a two-lane road. Further ahead was a work crew working on the road; traffic was allowed in one lane; a person stood with a stop sign in

each direction directing some traffic to stop while the opposite lane of traffic proceeded. Mr. Munro grew impatient, drove in the opposite (oncoming traffic) lane, and when the victim, holding up his stop sign, tried to stop Mr. Munro, Mr. Munro hit the victim with his truck and fled the scene. Police tracked Mr. Munro's truck back to his company. When the police arrived, Mr. Munro had coerced his employee in admitting that he/the employee was driving the truck that hit the victim. The employee was charged. As the case against the employee proceeded to trial, the employee's lawyer implored me to investigate further, the lawyer indicated that someone else was driving the vehicle, but that his client would not aid in that investigation or speak with investigators. Mr. Munro made it very difficult for investigators to speak with his employees, including the employee that who originally charged (Mr. Munro provided the employee with a place to live, and was his source of income). Eventually as we kept pressing on with the investigation, more evidence was developed that led us to believe that the employee was not driving the truck that hit the victim and that Mr. Munro was the driver. Charges against the employee were dismissed and I charged Mr. Munro. The case proceeded to trial. Some employees did not appear for trial and evaded law enforcement; law enforcement was able to find one employee, who reluctantly testified against Mr. Munro. Mr. Munro was found guilty of Failure to Stop at the Scene of an Accident Causing Serious Injury and Felonious Assault; the jury found Mr. Munro not guilty of Inducements or Promises to Witnesses.

The jury convicted Mr. Kelsey of Homicide in the First Degree (premeditated and an alternative theory of felony murder). Mr. Kelsey was sentenced to life in prison without the possibility of parole.
