portfolio of issues impacting Executive agencies under the supervision and control of the Governor. In this capacity, I oversaw active litigation pursued by the Executive agencies within my portfolio, as well as litigation by and against the Governor and the Governor's office.

In 2019, I began serving as General Counsel to a United States Senator, providing constitutional analysis, legal counsel, ethics guidance, and advice across a broad spectrum of policy areas.

April 2017 – September 2017

The State Attorney for Florida's Ninth Judicial Circuit (Aramis Ayala) sued the Florida Governor, challenging his authority to issue executive reassignments of capital criminal cases arising in the Ninth Circuit to other State Attorneys in adjacent circuits. The Governor's executive reassignments became necessary after Ms. Ayala adopted a blanket policy for her office declining to enforce Florida's capital punishment law in any case, irrespective of the aggravating circumstances of the charged capital offense. My work largely consisted of drafting responsive pleadings on behalf of the Florida Governor and preparing the Governor's General Counsel for oral argument before the Florida Supreme Court.

After oral arguments, the Florida Supreme Court denied Ayala's petition for a writ of quo warranto, holding the Governor was acting squarely within his constitutional and statutory authority to "take care that the laws be faithfully executed" and to discharge that duty through assignments of state attorneys. The Court held Ayala's blanket refusal to pursue the death penalty in any eligible case, irrespective of the particular aggravating circumstances presented, was not a valid exercise

of prosecutorial discretion, and provided the Governor with "good and sufficient reason" to reassign such cases to ensure Florida's laws were faithfully executed.

2. Florida v. Georgia

Case No.: No. 142, Orig.
The Supreme Court of the United States
2013 – 2018

This case was an Original Action filed directly with the Supreme Court of the United States in the most recent iteration of long-running "water wars" between the states through which the Apalachicola-Chattahoochee-Flint river system flows. Florida contended upstream consumption by Georgia along the Chattahoochee and Flint rivers had resulted in sustained, diminished flows of water into the Apalachicola River, which was vital to the health of the marine ecosystem of the Apalachicola Bay, including the prized Apalachicola oyster fishery. Diminished water flows into the Apalachicola Bay had materially altered its salinity, causing a near-total collapse of the oyster fishery industry on which generations of Apalachicola oysterman had relied. Although I was not counsel of record in this case, I represented the interests of the Florida Governor in supporting and overseeing outside counsels' pursuit, development, filing, and argument of the case.

After trial proceedings before two separate Special Masters appointed by the Court, and two oral arguments before the Supreme Court of the United States, Florida's claims were ultimately denied.

This case, brought by a class of convicted felons seeking the restoration of civil rights, challenged the discretionary exercise of the executive clemency power by the Florida Governor and Florida Cabinet, sitting as the Board of Executive Clemency. I was not counsel of record in the litigation, but as the Governor's clemency advisor and his Chief Deputy General Counsel, I was directly involved in preparing our legal counsel to defend the actions of the Florida Board of Executive Clemency as consistent with the historical exercise of the executive clemency power, as recognized and respected by the Supreme Court of the United States.

The district court ruled in favor of the plaintiffs, but that ruling was stayed by the 11th Circuit Court of Appeals on a finding the plaintiffs had failed to allege, much less demonstrate, that Florida's clemency scheme had a discriminatory purpose or effect. Ultimately, the case was dismissed as moot following a voter referendum on restoration of civil

rights for felons that modified the state constitution.

4. State of Florida v. David Warren Fiessinger, Jr.

Case No.: 2010-CT-037421ASB

Palm Beach County Court, 15th Judicial Circuit of Florida

The Honorable August Bonavita Date: January 2012 – February 2012

This case was my first jury trial on a charge of Driving Under the Influence, involving impairment caused by both alcohol and a controlled substance, which was the defendant's second DUI within a 5-year period. At trial, defense counsel pursued a novel attempt to introduce and certify an expert witness to provide testimony against the Standardized Field Sobriety Tasks employed by law enforcement during DUI investigations. Although accompanied by co-counsel, I led all aspects of this criminal prosecution, including a last-minute deposition of the proposed expert witness who had not been previously disclosed by defense counsel. Based on that deposition, I was able to disqualify the expert witness's proposed testimony and strike him from the witness list.

Following the trial, the jury returned a guilty verdict against the defendant. The defendant was sentenced to be incarcerated in the county jail for a brief period, followed by a term of probation, with statutorily defined conditions applicable to DUI in Florida.

5. State of Florida v. Daniel David Aguilar

This case was my first criminal jury trial involving an elderly victim witness who had been the target of a road rage incident that resulted in the defendant repeatedly punching the victim while their vehicles were stopped at a traffic light. Although the attack did not result in serious injury, the victim was understandably hesitant to face his attacker in court, which required multiple pretrial meetings to prepare the victim to deliver his testimony. I served as sole counsel.

Following the trial, the jury returned a guilty verdict against the defendant. The defendant was sentenced to be incarcerated in the county jail for a brief period of time, followed by a term of probation.

6. <u>State of Florida v. Wayne G. Doucet</u> & <u>State of Florida v. Bryan E.</u> Chapman

Date: July 2012 – September 2012

In this case the co-defendants were represented by separate attorneys but opted to proceed to trial together, creating a complex case presentation at trial. The co-defendants were each charged with two counts of battery for an incident in which they mutually attacked the victim with hands, fists, and feet, and later retrieved a pellet rifle from their nearby house, which they used to shoot the victim in the head. After the attack, the victim had moved out of the state, but agreed to return to testify at trial. During a lunch break in the trial, the co-defendants contacted the victim to offer him financial compensation in exchange for not returning to the courtroom to testify, in hopes that his failure to appear would lead to the criminal charges being dropped. The victim notified my office of the attempted witness tampering, which was promptly brought to the attention of the trial judge, and permitted to be used as impeachment evidence on cross-examination. I handled all aspects of this criminal prosecution, with co-counsel acting in a support role.

Following the trial, the jury returned guilty verdicts against both co-

defendants. Both defendants were sentenced to be incarcerated in the county jail for 120 days, followed by a period of probation.

The defendant was charged with Driving Under the Influence, and the video evidence of the officer's interaction showed the defendant becoming increasingly belligerent and combative toward the officer during the Standardized Field Sobriety Tasks. When the officer attempted to make the arrest, the defendant became physically aggressive and actively resisted the officer's attempts to place him in custody, requiring the officer to deploy a taser to subdue the defendant. Defense counsel deceptively used the video evidence of the physical struggle to detain the defendant in his opening statement, asserting the arresting officer had used unlawful force, in an attempt to taint the jury against the arresting officer. This required substantial rehabilitation of the officer's credibility on the witness stand, as well as the introduction and exhibition of the full video to demonstrate the proper context of the arrest for the jury. I served as sole counsel in the prosecution of this

case.

Following the trial, and after seeing the entire context of the officer's interaction with the defendant, the jury returned a swift guilty verdict. The defendant was sentenced to a term of probation with statutorily defined conditions applicable to DUI in Florida.
