2. *Thaler v. Haynes*, 559 U.S. 43 (2010).

3. *Medellin v. Texas*, 554 U.S. 759 (2008).

I was lead counsel for the State of Texas during the stay of execution proceedings in this capital case. The U.S. Supreme Court had previously affirmed the dismissal of Medellin's petition for writ of habeas corpus, concluding that an adverse judgment of the International Court of Justice against the State of Texas was not directly enforceable federal law. *Medellin v. Texas*, 552 U.S. 491 (2008). In a per curiam decision, the Court [Roberts, Scalia, Kennedy, Thomas, Alito] denied Medellin a stay of execution, noting that neither the President of the United States nor the Governor of Texas had represented to the Court that any congressional or state legislative action with respect to Medellin's case was likely. Justices Stevens, Souter, Ginsburg, and Breyer filed dissenting opinions.

4. *McDonald v. City of Chicago*, 561 U.S. 742 (2010), and *National Rifle Ass'n of America, Inc. v. City of Chicago*, 561 U.S. 1041 (2010).

In *McDonald*, the U.S. Supreme Court considered whether the Second Amendment right to keep and bear arms applies to the States by virtue of Fourteenth Amendment. I served as lead counsel for amici curiae Texas, Ohio, Arkansas, Georgia, Alabama, Alaska, Arizona, Colorado, Florida, Idaho, Indiana, Kansas, Kentucky, Louisiana, Maine, Michigan, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Mexico, North Carolina, North Dakota, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Tennessee, Utah, Virginia, Washington, West Virginia, Wisconsin, and Wyoming, arguing that the Second Amendment protects a fundamental right that applies against the States through the Due Process Clause of the Fourteenth Amendment. Justice Alito's opinion cited Texas's amicus brief three times.

This dispute over the use of affirmative action in undergraduate admissions at the University of Texas at Austin made its way to the U.S. Supreme Court twice before that Court eventually ruled in favor of the University by a vote of 4-3, with Justices Kennedy, Ginsburg, Breyer and Sotomayor in the majority and Chief Justice Roberts and Justices Thomas and Alito in dissent. As the Solicitor General of Texas, I served as lead counsel for the University of Texas before both the federal district court in Austin [Sparks] and the Fifth Circuit [King, Higginbotham, and Garza] on its first hearing by that court. Although I was no longer lead counsel for the University after I left the Solicitor General's office, the University retained me as a consultant on the case going forward. 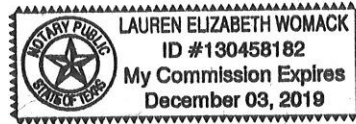
