Following extensive pre-trial motions and preparation, the case went to trial. Following a two-week jury trial before Judge Philip Simon, the jury returned not guilty verdicts for Mr. Ciaccio

2. *Koehlinger v. Lottery Commission of Ind.*, No. 49D07-0701-CT-730 (Ind. Marion Super. Ct., Civil Div.); 933 N.E.2d 534 (Ind. Ct. App. 2010).

This was a class action against the State Lottery Commission of Indiana d/b/a the Hoosier Lottery alleging multiple claims, including fraud, deceptive sales practices, breach of contract, and negligence, and seeking recovery of \$20,000,000 in damages. I served as lead counsel for the Hoosier Lottery in this matter. Following substantial discovery and contested motions, each party filed a motion for summary judgment. I presented oral argument on the Lottery's motion for summary judgment. The court (Judge Gerald Zore) granted full summary judgment to the Hoosier Lottery and denied the plaintiff's motion for summary judgment. Plaintiff appealed the court's ruling, resulting in briefing and argument before the Indiana Court of Appeals. 3. *United States v. Bryant*, No. 1:04-cr-013 (S.D. Ind.); 420 F.3d 652 (7th Cir. 2005).

This case involved a prosecution of federal firearms related offenses and was resolved by a plea agreement at the district court level. I served as sole counsel for the United States in this matter. The contested sentencing hearing was unique in that this was one of the first sentencing hearings to be conducted in the Southern District of Indiana after the issuance of groundbreaking decisions, *Blakely v. Washington* and *United States v. Booker*, finding the United States Sentencing Guidelines unconstitutional. At the sentencing hearing before Judge Sarah Evans Barker, I presented argument regarding the position of the United States on these issues. On appeal, the defendant contended that the district court had erroneously deprived him of his constitutional right to a jury trial when it made factual findings on contested issues, and that the methodology the district court used to fashion his sentence violated his due process rights in light of *Blakely* and *Booker*. I wrote the briefs for the appeal and presented oral argument on these issues before the Seventh Circuit. The district court's decision was affirmed in an opinion by Judge Kanne, joined by Judges Wood and Sykes.

4. *United States v. Burts*, No. 1:03-cr-0089 (S.D. Ind.); 108 F. App'x 389 (7th Cir. 2004).

This was a federal criminal case involving the prosecution of a defendant for illegal possession of a gun. I served as sole counsel for the United States in this matter. Because the defendant had three prior convictions involving violent crimes, he qualified for enhanced sentencing as an Armed Career Criminal. The case culminated with a jury trial before Judge John D. Tinder. While the fact pattern was not complicated – the police pulled over a vehicle with three people in it and found a loaded handgun on the floor – it was a difficult case to make because of the circumstantial nature of the admissible evidence. The jury found the defendant guilty and the court sentenced him to over 20 years in prison. I briefed and argued the appeal before the Seventh Circuit, which affirmed the conviction and sentence in a *per curiam* decision joined by Judges Cudahy, Coffey, and Rovner.

5. *United States v. White*, No. 1:02-cr-00165 (S.D. Ind.); 368 F.3d 911 (7th Cir. 2004), *cert. granted sub nom. White v. United States*, 543 U.S. 1105 (2005), *on remand*, 213 F. App'x 488 (7th Cir. 2007).

This was a federal criminal case where the defendant was charged with federal firearms violations. I served as sole counsel for the United States in this matter. The case was challenging from an evidentiary perspective in that the government's admissible evidence of the defendant's guilt was entirely circumstantial, requiring the jury to draw multiple inferences in order to convict. The case became more challenging when multiple defense witnesses testified to facts that, if true, would have established the defendant's innocence. During the trial before Judge John D. Tinder, we located recordings of telephone conversations the defendant had with the witnesses from jail wherein the defendant instructed the witnesses how to testify. When confronted with these recordings, the witnesses recanted their prior testimony. The jury convicted Mr. White and the court increased his sentence for having attempted to obstruct justice by instructing the witnesses how to testify. The defendant appealed multiple issues relating to the trial and sentence imposed. I prepared the appellate brief and presented oral argument to the Seventh Circuit, which affirmed the verdict and sentence in an opinion by Judge Kanne, joined by Judges Posner and Easterbrook. The Supreme Court later granted, vacated, and remanded the case in light of *Booker*, and, upon remand, the Seventh Circuit affirmed in a *per curiam* decision joined by Judges Easterbrook, Posner, and Kanne.

6. *United States v. Bryson, et al.*, No. 1:02-cr-093 (S.D. Ind.); 94 F. App'x 389 (7th Cir. 2004).

This was a federal criminal case where multiple defendants were charged in a 34-count indictment with various criminal offenses, including mail and wire fraud, conspiracy, and money laundering, as part of a mortgage fraud scheme. I served as co-counsel for the United States with a more senior Assistant U.S. Attorney, sharing the pre-trial and trial responsibilities. Seven defendants entered into plea agreements before the indictment was returned against seven other individuals. Two individuals, Deb Bryson and Melvin Girton, proceeded to trial. Following a week-long jury trial before Judge Larry McKinney, both defendants were convicted on all counts on February 20, 2003. 7. *United States v. Swanson*, No. 1:01-cr-0083 (S.D. Ind.); 394 F.3d 520 (7th Cir. 2005) (first appeal); 483 F.3d 509 (7th Cir. 2007) (second appeal).

This was a federal criminal case where the defendant was charged with multiple counts of wire fraud, money laundering, interstate transportation of converted funds, and tax evasion. I served as associate counsel for the United States with a more senior

Assistant United States Attorney. The charges stemmed from a complex scheme of financial manipulations the defendant orchestrated through various roles, including as CEO of Countrymark Cooperative. The case culminated with a four-week jury trial before Judge Sarah Evans Barker, where the defendant was found guilty on October 10, 2002. This case presented complex sentencing issues, such as the method of calculating the appropriate amount of loss, restitution, and forfeiture, and the novel application of United States Supreme Court decisions that fundamentally altered certain aspects of sentencing in federal criminal cases. 10. *In re Manukian Alliev, Armen, Emma, Samir & Cara*, Nos. A 77-659-244, 245, 246, and 247 (U.S. Dep't of Justice, Executive Office for Immigration Review Aug. 14, 2001).

This case involved the Manukian Alliev family (father, mother, daughter and son), refugees from Armenia who were seeking political asylum in the United States. As sole counsel, I represented all four family members on a *pro bono* basis in a consolidated case before the Immigration Court. Armen, the father, is an ethnic Azerbaijani while Emma, the mother, is Armenian. Armen had been persecuted in Armenia because of his ethnicity; Emma was persecuted because she was married to an ethnic Azerbaijani; and Samir and Cara were persecuted because as children of an Azerbaijani-Armenia couple, they are of mixed ethnicity. The case culminated with a bench trial before immigration judge James R. Fujimoto. The court found in favor of the Manukian Alliev family, granting their petitions for asylum and giving them the ability to remain together and stay in the United States.

For example, I represented an individual appealing a life sentence for drug-related offenses.

I have dedicated a very substantial amount of volunteer time to serving on the Board of Providence Cristo Rey High School since 2007. I was a founding board member involved with starting and opening the school. The mission of Providence Cristo Rey is to transform lives by providing college preparatory education and corporate work experience to students of limited economic means. Almost all of the students who graduate from Providence Cristo Rey are first-generation college students, and many of the students are first-generation high school graduates.

As appointed counsel at the United States District Court for the Southern District of Indiana under the Criminal Justice Act, I have represented indigent individuals charged with federal criminal offenses. For example, I represented an individual in a federal criminal case where over a dozen defendants were charged with conspiracy to distribute methamphetamine. My client was 27 years old, six months pregnant, and a single mother to a young child.

As a volunteer attorney with the Midwest Immigration and Human Rights Center, I represented refugees seeking political asylum in the United States in proceedings before the United States Department of Justice, Executive Office for Immigration Review. I served as sole counsel in two bench trials before administrative law judges, prevailing in each trial and obtaining orders granting asylum for my clients. In one case, my client, Mr. Moyo, was a refugee from Angola seeking political asylum in the

United States. In another case, my clients were four members of a family who were refugees from Armenia seeking political asylum in the United States.

Further, as a volunteer attorney with Pro Bono Advocates, I represented indigent victims of domestic violence in obtaining orders of protection. Separately, I represented an indigent individual in seeking enforcement of alimony order.
