I write to supplement my Senate Judiciary Questionnaire submitted to the Committee on February 27, 2019.


In my initial submission to the Committee, I provided several articles from my college newspaper, *The Daily Northwestern*, that were in my personal possession. I also performed a reasonably diligent search for additional articles. While issues of *The Daily Northwestern* published after 1980 are publically available online, I graduated from Northwestern University in 1979, and articles from my tenure at Northwestern University did not appear in the initial electronic searches.

Since my initial submission, it has come to my attention that articles published before 1980 are digitally available behind a paywall. I have obtained access to the paywall protected database and am supplementing my Questionnaire response with additional articles that were searched and found in that database as published in *The Daily Northwestern* during 1976 – 1979 that appear to be responsive or reasonably might be construed to be. I have listed and included copies of the aforementioned materials in the attached Exhibits.
