As a member of the Perry County Bar Association, I am obligated to serve periodically as an arbitrator on an arbitration panel comprised of other members of our local bar association to arbitrate civil cases in which the claim is no more

than \$35,000. I have served on approximately four arbitration panels in ten years, but I have no notes, files, or records of the cases or dispositions.

From 2003 to 2005, I worked as an associate at a large New York law firm, Chadbourne & Parke LLP (now Norton Rose Fulbright). I worked on civil suits in New York state court and federal court. I completed numerous research memoranda for partners, and was third chair in a products liability lawsuit in New York county court.

From 2005 to 2009, I was a trial attorney with the U.S. Department of Justice Tax Division in Washington, D.C. I represented the United States in complex tax refund litigation matters. I practiced exclusively in the field of federal taxation, and I was assigned to litigate cases in the U.S. Court of Federal Claims in Washington, D.C. I was on the trial teams for three complex tax shelter cases, each of which was a multiple-week trial. I also gained considerable experience with civil discovery, including taking depositions of various individuals across the country, preparing written discovery, and document review, as well as working with expert witnesses.

From 2009 to present, I have been a partner in Philpott Wilson LLP, a general practice in Duncannon, Pennsylvania. I have been practicing in federal court in the Middle District of Pennsylvania and the Third Circuit Court of Appeals as a criminal defense attorney. I was appointed to the Criminal Justice Act panel of defense attorneys for the Middle District in 2009, and I have been re-appointed twice. I have represented individuals accused of federal offenses in numerous cases, and have appeared before all of the active and senior judges in the Harrisburg office of the Middle District. I have taken two cases to jury trial, with favorable outcomes for my clients. I have also handled numerous plea and sentencing hearings, as well as habeas matters and appeals.

I have also been practicing in the state court in the Courts of Common Pleas in multiple jurisdictions, as well as the Pennsylvania Superior Court and Supreme Court. I have represented individual and small business clients in civil suits, criminal cases, family law matters, and appeals involving court appearances ranging from jury trials to hearings, conferences, and arguments on a routine basis. This tax refund case presented the issue of whether the investments of \$450,000 which generated over \$40 million in tax losses possessed economic substance. Following a lengthy bench trial, the court concluded that the United States was correct in asserting that the spread transactions lacked economic substance. As a result, the plaintiff's refund claim was denied, and the United States prevailed. This case established an important precedent for the IRS in order to dismantle a particular category of tax shelter referred to as "Son of BOSS." My role in this case included taking depositions, reviewing discovery materials, preparing fact and expert witnesses for trial, and conducting several trial examinations, as well as assisting the other trial counsel with trial examinations. 2. *Wells Fargo & Co. v. United States*, 91 Fed. Cl. 35 (2010).

I represented the United States in this matter from 2008 to 2009. The Honorable Thomas C. Wheeler presided in the United States Court of Federal Claims. This tax refund suit addressed a tax shelter referred to as a "SILO" (short for "sale in/lease out") that was designed to generate depreciation, interest and transaction deductions for the bank to use to offset taxable income for tax purposes. Following a 20-day bench trial, the court determined that the transactions at issue lacked economic substance, and therefore denied Wells Fargo over \$100 million in claimed deductions. My role in this case as the second chair consisted of conducting depositions, preparing written discovery, reviewing voluminous discovery materials, developing expert witnesses, and conducting numerous trial examinations of fact and expert witnesses. 3. *K2 Trading Ventures v. United States*, 101 Fed.Cl. 365 (2011).

I represented the United States in this matter from 2007 to 2009. The Honorable Mary Ellen Coster Williams presided in the United States Court of Federal Claims. This tax refund suit involved the same “Son of BOSS” tax shelter that was at issue in *Jade Trading*, but with the alleged difference that the spread transactions had some profit potential, thus demonstrating that the transactions had economic substance. The court affirmed the position of the United States that the spread transactions lacked economic substance and the tax effects generated were entirely fictional. 4. *Commonwealth v. Mark Clegg*, 27 A.3d 1266 (Pa. 2011).

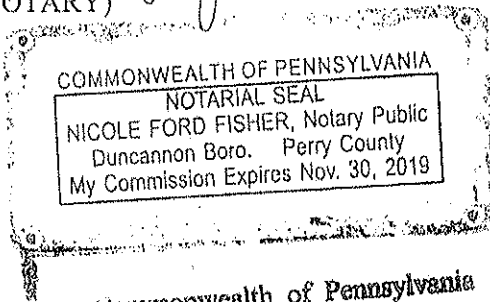
