My practice has focused on civil litigation, including complex commercial and general civil litigation, insurance insolvency litigation, insurance company liquidations, directors and officers' fiduciary duty litigation, and auditor and actuary professional negligence litigation. My representation of business entities and executives grew over the years to involve corporate governance issues, commercial transactions, business entity formation and business succession planning. In the last ten years or so, I have also served as outside general counsel for a number of businesses.

Over the years, my practice has moved toward complex commercial litigation and transactions, usually with substantial dollar amounts at risk.
