
Questions 12(c) and 26(a): On August 1, 2018, I testified before the Senate Judiciary Committee concerning my nomination and, on or about August 13, 2018, responded to related questions for the record.

Question 17(10): *New York ex rel. Campagna v. Post Integrations, Inc.*, No. 100516/14 (N.Y. Supr. Ct., New York Cty.) (Justice James D'Auguste). On June 28, 2018, the Appellate Division, First Department, affirmed the trial court's denial of Defendants' motion to dismiss. *See* 81 N.Y.S.3d 14 (2018).

Question 20: The current approximate annual pension benefit figure is now \$31,054. Upon withdrawal from my firm, I would be entitled to return of approximately \$43,703 of capital and approximately \$82,834 on account of accounts receivable.

I am also forwarding an updated net worth statement. When my nomination is formally submitted to the Senate and I file my Financial Disclosure Report, I will supplement this letter with a copy of that Report.
